集團簡介

集團母公司金山科技工業有限公司於1964年成立，並自1984年在香港上市。金山科技現時擁有GP工業有限公司86.18%* 股權，作為其主要投資工具。GP工業在新加坡上市。

金山科技工業有限公司致力研發創新電池技術及企業對企業 (B2B) 電池業務，而GP工業則主力發展其消費類電池及音響業務。集團之主要產品類別如 **GP 超霸電池**、**Recyko 綠再充電池**、**KEF 高級揚聲器** 和 **Celestion 專業揚聲器**，已成為業內著名品牌。

GP能源科技有限公司是集團旗下以可持續發展為營運核心的附屬公司，致力研發可持續創新及革新充電電池技術，提供更完善的能源存儲解決方案。

金山科技集團之生產設施、產品研發及銷售辦事處遍佈全球十多個國家。集團於2025-2026年之營業額為70億港元，總資產逾81億港元，於世界各地共聘員工約6,400人。

The parent company, Gold Peak Technology Group Limited, was established in 1964 and has been listed on the Stock Exchange of Hong Kong since 1984. Gold Peak holds a majority stake at 86.18%* in the Singapore-listed GP Industries Limited as its major industrial investment vehicle.

Gold Peak Technology Group Limited focuses on R&D of new battery technology and B2B battery business, whilst GP Industries develops its consumer batteries, and electronics and acoustics businesses in consumer products. The Group has built renowned brand names for its major product categories, including **GP** batteries, **Recyko** rechargeable batteries, **KEF** premium acoustic products and **Celestion** professional speakers.

GP Energy Tech Limited, formed to charter sustainability as the core of business, is the Group's major subsidiary committed to delivering sustainable innovations as well as rechargeable battery advancement for enhanced energy storage solutions.

The Group has a strong and extensive manufacturing, R&D and distribution network spanning over 10 countries. 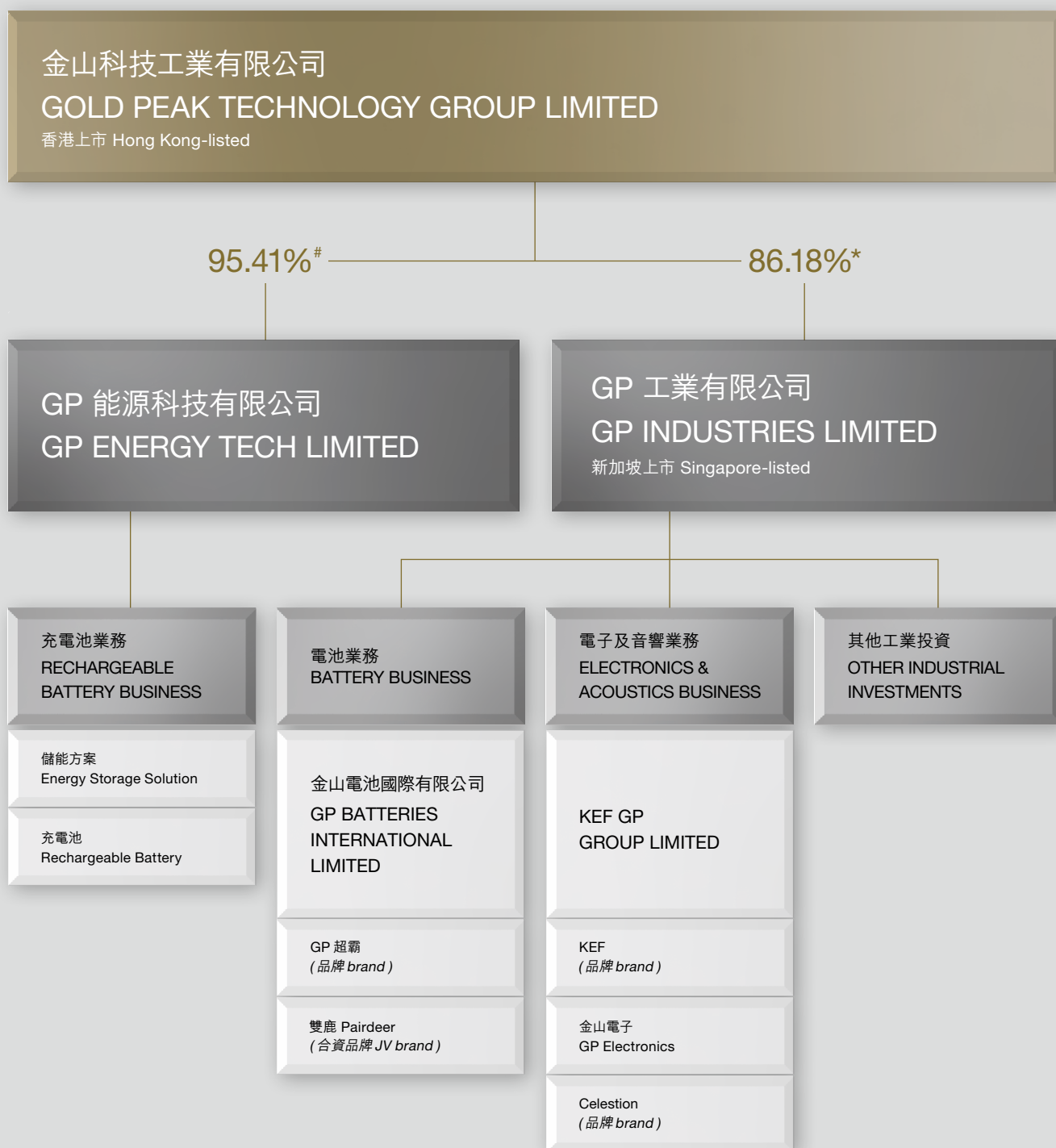

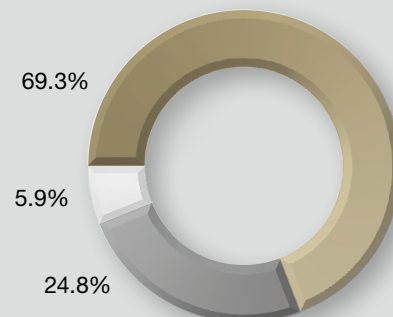

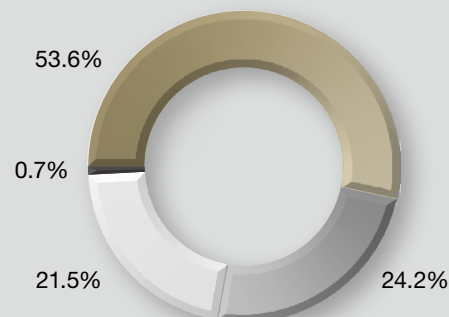
各地區之營業額分佈

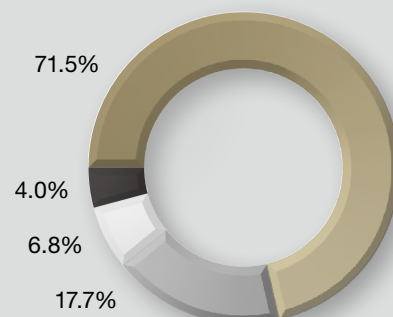
各地區之總資產分佈

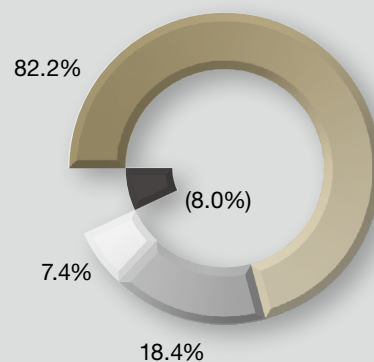

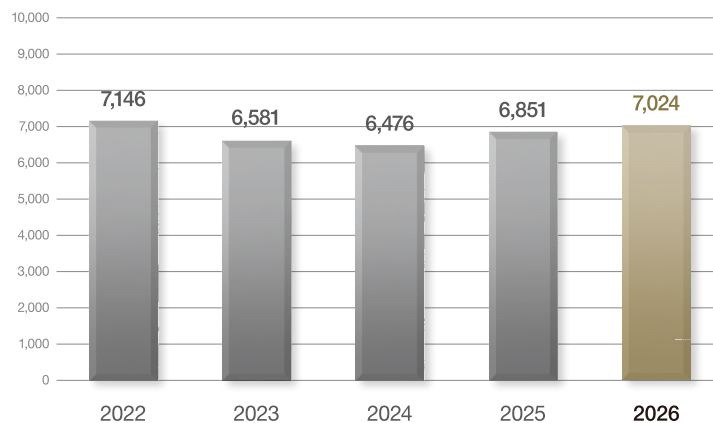

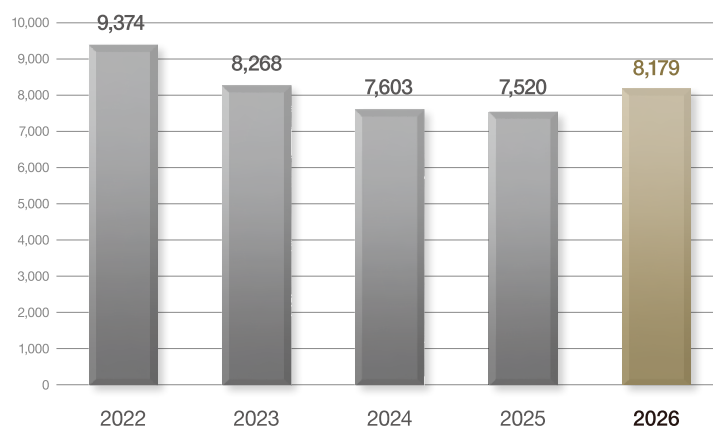

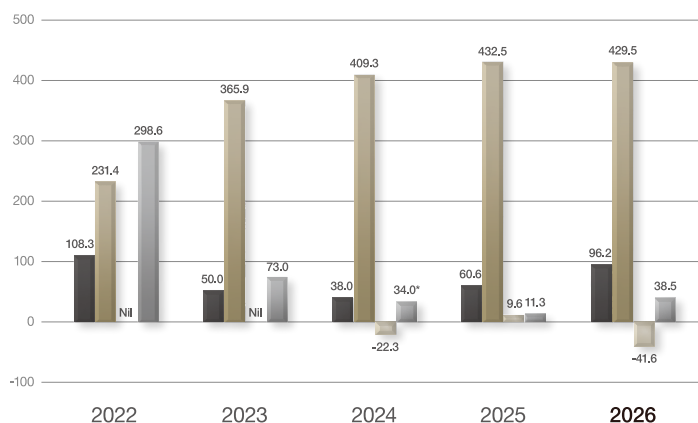

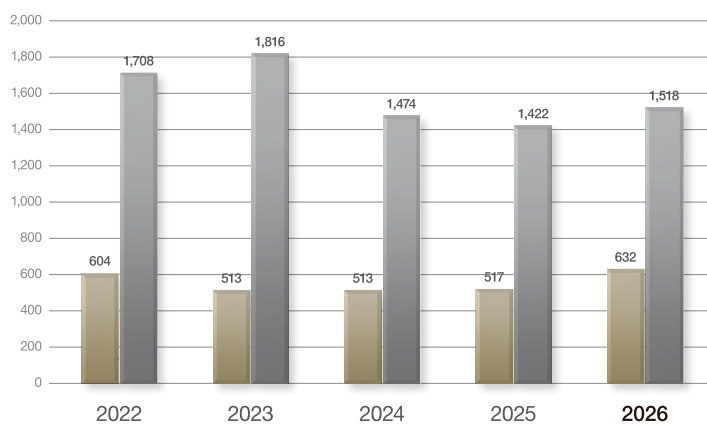

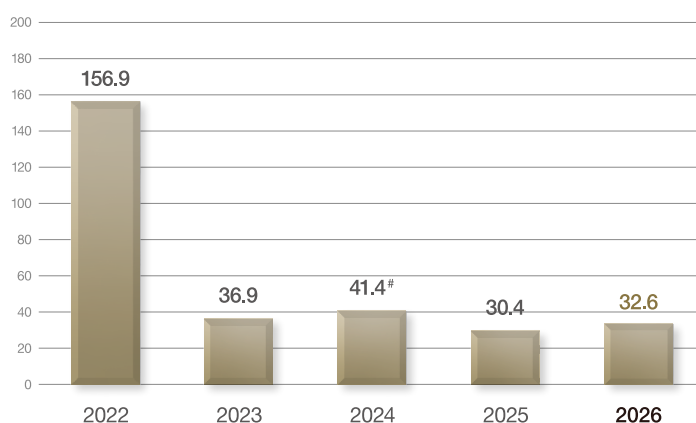

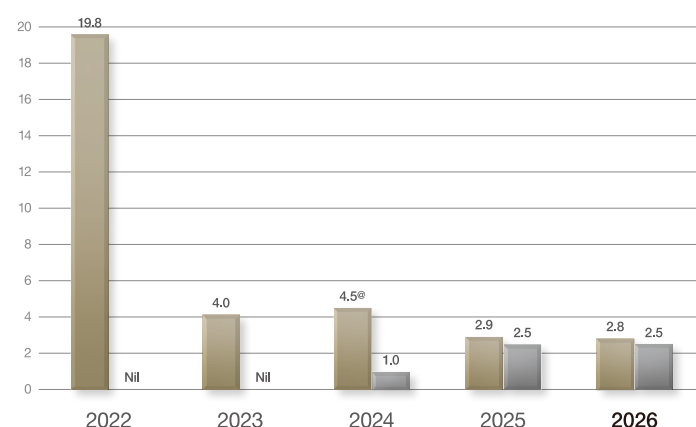

截至2026年3月31日止財政年度（「2026年度」）內，持續的地緣政治緊張局勢、貿易政策變化及通脹壓力，為企業及消費者帶來多重挑戰。在此背景下，金山科技依然錄得穩健業績，股東應佔溢利增長7.3%至3,260萬港元，表現充分反映本集團長期致力推動生產業務地域多元化及發展高端品牌之策略成效，相關基礎持續在全球複雜多變的環境中提供具防禦性的競爭優勢。

業績摘要

於2026年度，集團錄得營業額70.239億港元，較截至2025年3月31日止財政年度（「2025年度」）增加1.726億港元。毛利率微跌至28.5%，反映美國關稅及市場價格競爭加劇所帶來之影響。支持股東應佔溢利改善的因素包括所佔聯營公司業績顯著上升，由2025年度之7,670萬港元增至1.147億港元，主要因為主力致力數據中心散熱系統市場的聯營公司智富科技有限公司（「智富科技」）表現強勁。同時，財務成本減少16.1%，反映借貸利率回落及審慎的資產負債管理，進一步鞏固集團之盈利表現。

作為集團最大業務分部，電池業務於2026年度錄得營業額48.661億港元，與上年度大致持平，在重大關稅衝擊及貿易政策不確定性下，該業務充分展現集團多元化生產佈局之韌性。電子及音響業務錄得強勁增長，營業額上升10.2%至17.408億港元，主要受惠於KEF成功推出多款新產品及拓展分銷渠道，以及專業音響製造業務營業額增長15.1%。儘管額外美國關稅及物流成本上升對毛利率構成壓力，惟透過更嚴謹管理廣告及推廣支出，及持續推行行政成本優化措施，分部盈利能力得以支持。本年度每股基本盈利為2.8港仙。

董事局建議派發末期股息每股0.7港仙。連同每股1.8港仙的中期股息，全年股息為每股2.5港仙（去年度：每股2.5港仙），本年度派息率為90.9%（去年度：86.2%）。

Resilient Performance despite the Volatile Market Environment

The financial year ended 31 March 2026 ("FY2026") was shaped by persistent geopolitical tensions, evolving trade policies, and inflationary pressures that tested businesses and consumers alike. Against this backdrop, Gold Peak delivered resilient results, with profit attributable to equity holders growing 7.3% to HK\$32.6 million. This performance reflects the Group's long-standing commitment to geographic manufacturing diversification and premium brand development – foundations that continue to provide defensive competitive advantage in a complex global environment.

Results Summary

The Group recorded revenue of HK\$7,023.9 million in FY2026, an increase of HK\$172.6 million compared to the financial year ended 31 March 2025 ("FY2025"). Gross profit margin declined modestly to 28.5%, reflecting the impact of U.S. tariffs and heightened pricing competition. Supporting the improvement in attributable profit was a substantial increase in the share of results of associates – rising from HK\$76.7 million in FY2025 to HK\$114.7 million, driven primarily by the strong performance of Wisefull Technology Limited ("Wisefull"), our associate company specializing in the data center cooling market, together with a 16.1% reduction in finance costs reflecting lower borrowing rates, demonstrating disciplined balance sheet management.

The Battery Business, the Group's largest segment, maintained revenue broadly in line with the prior year at HK\$4,866.1 million, demonstrating the resilience of the Group's diversified manufacturing base amid significant tariff disruption and trade policy uncertainty. The Electronics and Acoustics Business delivered strong growth of 10.2% to HK\$1,740.8 million, driven by KEF's successful new product launches and distribution channel expansion, and a 15.1% revenue increase in the professional audio manufacturing business. Despite margin pressure from additional U.S. tariffs and increased logistics costs, segment profitability was supported by greater discipline in managing advertising and promotion expenses and continued administrative cost reduction. Basic earnings per share for FY2026 were 2.8 Hong Kong cents.

The Directors have proposed a final dividend of 0.7 HK cent per share which, together with the interim dividend of 1.8 HK cents per share, brings the full-year dividend to 2.5 HK cents per share (FY2025: 2.5 HK cents per share), representing a payout ratio of 90.9% for FY2026 (FY2025: 86.2%).

靈活部署 推進多元增長

全球貿易情況持續演變，進一步突顯集團長期推行地域多元化策略的價值。本年度出現了一項重要結構性轉變 – 中國逐步下調電池產品出口增值稅退稅率，該退稅率已於2024年12月由13%下調至9%，於2026年4月進一步降至6%，於2027年1月更將全面撤消 – 此措施令中國電池出口商之工廠成本增加約13%，並從根本上重塑全球電池行業之競爭環境。

集團在越南及馬來西亞共七個地區設有生產設施，具備充足條件應對此項結構性成本轉變。位於越南胡志明市之鹼性電池廠目前正以每年10億枚之滿產能營運，直接供應美國市場，有效避免與中國原產出口相關之高關稅負擔。

本集團預期，中國增值稅政策調整與持續之美國關稅不確定性，將於未來數年推進行業整合。資本實力雄厚且具備多元地域佈局之製造商，將更有能力在結構性變化中把握機遇，擴大市場份額；相對而言，資源較為有限之競爭對手在適應相關轉變時將面臨更大挑戰。我們相信，金山科技於行業中處於佔優之列，應對此輪結構性轉變。

電池業務於2026年度錄得營業額48.661億港元，與2025年度相若，惟各地域表現有異。南北美洲銷售下跌18.1%，主要受關稅相關不確定性、零售渠道削減庫存，及消費者審慎支出所影響；歐洲市場整體保持穩定；亞洲則錄得5.6%增長，充分體現集團多元收入基礎之韌性。

該分部於特種電池及物聯網應用領域明顯具備實力。隨著智能家居設備、GPS追蹤器、醫療設備及工業物聯網系統日益普及，對集團鈕型鋰電池及特種電池產品的需求持續強勁。此等產品毛利較高，與集團聚焦高增值產品之策略一致。

為對應消費者不斷轉變之行為模式，集團正擴展充電電池產品之直銷電子商貿業務，藉此接觸尋求高性價比替代一次性電池之消費者，同時優化供應鏈及改善利潤。集團之產品組合包括由著重性價比之碳性電池，以至高端鹼性電池及特種電池產品，全面覆蓋不同價格層面及分銷渠道，滿足多元化消費者需求。

電子及音響業務表現強勁，2026年度營業額17.408億港元，按年增長10.2%。增長主要受惠於KEF持續推進其主動型無線音響系統增長策略，以及Celestion成功拓展新市場分部。

Driving Agile, Diversified Growth

The evolving global trade landscape continues to reinforce the value of our long-established geographic diversification strategy. A significant structural shift emerged in FY2026 with the progressive rollback of China's value-added tax ("VAT") export rebate for battery products. Reduced from 13% to 9% in December 2024 and further to 6% in April 2026, the rebate is scheduled for full elimination by January 2027 – greatly increasing factory costs for China-based battery exporters by approximately 13% and fundamentally reshaping the competitive dynamics of the global battery industry.

With 7 regional manufacturing facilities outside China – spanning Vietnam and Malaysia – we are well-positioned to navigate this structural cost shift. Our Alkaline battery plant in Ho Chi Minh City, Vietnam is operating at its full annual capacity of one billion units, serving the U.S. market directly and avoiding the high tariff associated with China-origin exports.

We anticipate that the combination of China's VAT policy changes and persistent U.S. tariff uncertainty will drive industry consolidation over the coming years. Well-capitalised manufacturers with diversified geographic footprints are better placed to gain market share as less well-resourced competitors face greater difficulty adapting to these structural changes – and we believe Gold Peak is among the better-positioned in the industry to cope with this shift.

The Battery Business recorded revenue of HK\$4,866.1 million in FY2026, broadly in line with FY2025, with divergent performance across geographies. The Americas declined by 18.1%, reflecting tariff-related uncertainty, retail inventory destocking, and cautious consumer spending. European markets remained broadly stable, while Asia delivered growth of 5.6%, demonstrating the resilience of our diversified revenue base.

The segment demonstrated considerable strength in specialty and IoT applications. The proliferation of smart home devices, GPS trackers, medical devices, and industrial IoT systems continues to drive robust demand for our Lithium coin cell and specialty batteries – a higher-margin category that aligns with our strategic emphasis on value-added products.

In response to evolving consumer behaviour, we are expanding our direct-to-consumer e-commerce presence for rechargeable battery solutions, enabling us to reach consumers seeking high-value alternatives to disposable batteries while streamlining the supply chain and improving margins. Our product portfolio – spanning value-driven Carbon Zinc through premium Alkaline and specialty batteries – positions us to serve diverse consumer needs across all price points and distribution channels.

The Electronics and Acoustics Business delivered strong performance, with revenue growing by 10.2% to HK\$1,740.8 million in FY2026, driven by the continued success of KEF's active wireless music system growth strategy and Celestion's expansion into new market segments.

主席報告書 (續)

KEF透過持續擴展主動式無線音響系統產品組合、推行整合營銷及渠道卓越策略，以及落實「Listen and Believe」零售策略，帶動業務持續增長。KEF積極拓展以KEF Music Gallery/Studio形式設立之體驗中心網絡，包括位於倫敦之旗艦店、東京青山、香港，以及北京與成都高端零售地段，大大提升品牌知名度並加強與顧客的契合。該等專門設計之聆聽體驗空間，有效提升核心高端及重視體驗之目標客群之購買意向及品牌忠誠度，鞏固KEF之市場定位。

「Sound by KEF」合作計劃繼續拓展KEF之市場版圖，並提升品牌於相關高增長領域之定位與形象。集團與路特斯科技(Lotus Technology)之合作，已將KEF之音響工程技術應用於其旗艦車系，包括Emira、Eletre、Theory 1及Emeya等型號；與海爾智家之合作亦進一步深化，涵蓋Casarte超高端電視系列，使KEF成功進軍高端智能家居顯示屏市場；與華為之合作則透過HUAWEI HiPlay無線音響平台，拓展集團於華語市場之覆蓋範圍。此外，與總部在倫敦的消費科技品牌Nothing建立全新合作關係，將KEF之音響專業技術應用於Headphone (1)，進一步拓展品牌於便攜式消費音響市場之佈局。

於2026年度，Celestion於英國萊士域治(Ipswich)廠房的全新自動化生產線投產，專門生產Ten Squared (TSQ)系列大型專業揚聲器單元。當中TSQ2460 24吋揚聲器單元憑藉卓越性能，迅速獲得全球大型巡演製作之工程師及系統整合商採用，進一步鞏固Celestion逾百年音響工程專業之市場地位。Hometainer作為Celestion首個推出消費市場之音響產品標誌著一項重要策略里程碑，其將品牌專業音響技術傳承應用於專為迅速增長之亞洲高端家庭娛樂及派對市場而設之系統，為集團在傳統專業及現場演出應用以外開拓新的收入來源。

KEF continues to grow through the ever expanding active wireless music systems offering, its integrated marketing and channel excellence strategy, plus our 'Listen and believe' retail strategy. Our expanding network Experience Centers in the form of KEF Music Galleries/Studios – including flagship locations in London; Aoyama, Tokyo; Hong Kong; and premium retail destinations in Beijing and Chengdu – has strengthened brand visibility and deepened consumer engagement. These purpose-designed listening environments drive purchase intent and brand loyalty among the affluent, experience-oriented consumers at the heart of KEF's audience.

“Sound by KEF” partnerships have expanded our market reach and enhanced brand perception across adjacent high-growth categories. Our collaboration with Lotus Technology embeds KEF's acoustic engineering across the brand's flagship vehicle line-up, including the Emira, Eletre, Theory 1, and Emeya. Our expanded partnership with Haier Smart Home now encompasses the Casarte ultra-premium television range, positioning KEF in the premium smart home display market. A collaboration with Huawei extends our reach across Chinese-speaking markets through the HUAWEI HiPlay wireless audio platform, while a new partnership with Nothing – the London-based consumer technology company – brings KEF's acoustic expertise to the Headphone (1), further extending the brand's presence into portable consumer audio.

Celestion commissioned a new automated production line at its Ipswich, U.K. facility during FY2026, dedicated to the Ten Squared (TSQ) range of large-format professional speaker drivers. The TSQ2460 24-inch driver has achieved rapid adoption among engineers and systems integrators serving major global touring productions, building on Celestion's century of acoustic engineering expertise. The launch of the Hometainer marks an important strategic milestone – Celestion's first consumer audio product applies the brand's professional acoustic heritage to a system designed principally for the rapidly growing Asian market for premium home entertainment and partying, establishing new revenue streams beyond traditional professional and live performance applications.

創新賦能 推動持續增長

2026年度，集團開展了一項重要的新里程－GP能源科技有限公司（「GP能源科技」）首座鎳鋅電池生產設施於2026年1月在中國東莞正式投產。此項發展為我們多年來持續推動之重要項目，亦是我們深信將為集團未來增長開啟嶄新篇章之重要舉措。

鎳鋅電池技術有效解決傳統鋰離子電池的一項重要且日益劇化之限制－防火。鎳鋅電池相對鋰離子電池具備本質上不易燃之特性，並免卻熱失控風險。隨著全球人工智能基礎設施對更高密度及更高功率之數據中心環境需求持續上升，此等安全優勢更為重要。鎳鋅電池之功率密度比傳統電池化學高達三倍，可回收率逾90%，且不含需特別處理之有害物質，能同時滿足數據中心營運商及重要基礎設施客戶對性能、安全及環境表現日益提高之要求。我們相信，此等綜合優勢在市場上具明顯差異化定位，並有助金山科技掌握全球其中一項增長最快之基礎設施領域所帶來之龐大需求機遇。

GP能源科技於截至2027年3月31日止財政年度（「2027年度」）之始已制定清晰的營運路線圖，在重要即時供電應用領域推進其鎳鋅電池技術商業規模化。隨著東莞廠房於2026年1月順利投產，集團預期將於2026年6月中全面大量投產，並於2027年度第二季交付首批商業訂單。馬來西亞廠房亦按計劃於2027年3月前投產。此等安排將進一步拓展集團的生產版圖，以滿足數據中心及重要基礎設施日益增長的需求。

在此必須指出，支持此項計劃之投資規模相當重大，研發開支及生產設施投產相關成本導致充電電池分部於2026年度錄得虧損，而上年度則錄得輕微盈利。集團認為，此乃構建具長遠價值之技術平台所必須且具增值效益之投資，該平台具潛力成為推動集團未來盈利及增長之重要新動力。隨著東莞生產設施正式投產，且商業化擴產藍圖已清晰確立，集團期待在GP科技由投資階段邁向收入貢獻及利潤率增長之過程中，持續匯報其最新進展。

集團應佔聯營公司業績由2025年度之7,670萬港元大幅上升至本年度之1.147億港元。集團聯營公司智富科技有限公司（「智富科技」）專注為人工智能及數據中心硬件提供高精密度熱能管理方案，其於年內持續為集團帶來顯著貢獻。相關增長主要受惠於全球人工智能運算基礎設施迅速擴展，帶動對先進圖形處理器（Graphics Processing Unit）散熱系統之需求持續上升。展望未來，智富科技具備良好基礎，充份掌握全球高性能運算基礎設施持續建設所帶來之增長機遇。

Innovation Driving Future Growth

FY2026 marked a defining milestone for Gold Peak with the opening of the first Nickel Zinc (“NiZn”) battery manufacturing facility of GP Energy Tech Limited (“GP Energy Tech”) in Dongguan, China in January 2026. This is a development we have been driving for a number of years, and one that we are confident will define a new chapter in the Group’s development.

NiZn battery chemistry addresses a critical and growing limitation of conventional Lithium-ion technology: fire safety. Unlike Lithium-ion alternatives, NiZn is intrinsically non-flammable and eliminates the risk of thermal runaway – a safety advantage of increasing importance as the world’s AI infrastructure demands ever-denser, higher-powered data center environments. With up to three times the power density of conventional battery chemistries, greater than 90% recyclability, and no hazardous materials requiring special disposal, NiZn delivers the performance, safety, and environmental profile that data center operators and critical infrastructure clients increasingly require. We believe this combination of attributes is genuinely differentiated in the market, and positions Gold Peak to capture meaningful demand in one of the fastest-growing infrastructure segments in the world.

GP Energy Tech enters the financial year ending 31 March 2027 (“FY2027”) with a clear operational roadmap for the commercial scale-up of its NiZn battery technology, for critical immediate power applications. Following the successful commissioning of the Dongguan facility in January 2026, the Group commenced full mass production in mid-June 2026, with initial commercial order deliveries anticipated in the second quarter of FY2027. The Malaysian facility remains on track to come online by March 2027, which will further diversify the Group’s manufacturing footprint to serve growing demand from data centers and critical infrastructure.

It is important to acknowledge that the investment underpinning this programme has been substantial. R&D expenditure and facility commissioning costs contributed to the Rechargeable Battery segment recording a loss in FY2026 after a small profit in the prior year. We view this as the necessary and value-accretive cost of building a technology platform with the potential to become a significant new driver of profit and growth for the Group. With the Dongguan facility now open and the commercial scale-up roadmap clearly defined, we look forward to reporting on GP Energy Tech’s progress as it moves from investment phase to revenue generation and margin expansion.

The Group’s share of results of associates increased substantially from HK\$76.7 million in FY2025 to HK\$114.7 million in FY2026. Wisefull, our associate company providing high-precision thermal management solutions for AI and data center hardware, continued to make a meaningful contribution to the Group, which was driven by growing demand for advanced GPU cooling systems as AI computing infrastructure expanded rapidly worldwide. Wisefull remains well-positioned to benefit from the continued global build-out of high-performance computing infrastructure.

財務穩健 引領可持續發展

集團對環境可持續發展之承諾一直是創造長遠價值策略之重要部份。年內，集團正式訂立量化目標，承諾於2050年前實現範圍一及範圍二淨零碳排放，並以2024年度為基準，設定於2030年或以前減排20%、於2040年或以前減排60%之階段性目標。於2025年度，集團整體碳排放量已錄得4.1%之減幅，充分展現朝上述具挑戰性目標邁進之實質進展。

集團於可持續發展方面之卓越營運表現再獲肯定，其中四間電池生產設施取得UL頒發「廢棄物零填埋 (Zero Waste to Landfill)」鉑金級認證，為全面廢物管理及循環經濟實踐之最高認證級別。此等成就充分體現本集團在維持世界級生產效率之同時，透過系統化管理持續降低對環境影響之堅定承諾。

為支持本集團之可持續發展舉措及日常營運需要，集團成功完成一項為期三年之綠色及可持續發展掛鉤銀團貸款，金額為6.75億港元，由十家主要銀行參與；以及另一項為期三年之可持續發展掛鉤銀團貸款，金額為5.04億港元，由五家銀行參與。此等融資安排充分反映貸款銀行對本集團業務模式、財務紀律及環境承諾之高度信心。可持續發展掛鉤結構將財務成本與預先訂立之環境、社會及管治 (ESG) 績效目標掛鉤，進一步將可持續發展理念融入集團之財務架構。

集團持續透過策略性整合營運至高效、多層式自動化設施，優化資產組合及提升營運效益。年內，集團繼續推進出售中國及馬來西亞非核心閒置工廠物業之計劃，惟物業市場環境仍然充滿挑戰，對交易進度構成一定影響。在完成出售前，相關物業持續帶來租金收入。本集團將繼續審慎管理資本配置，致力將資金重新投放於回報更高之核心業務活動。

集團之負債比率(定義為其銀行借款淨額除以權益總額的比率)於2026年3月31日為99.0%(2025年3月31日：98.4%)。年內完成之新貸款融資安排有效優化集團之債務到期結構，並為投放於重點增長領域提供所需之財務靈活性，同時維持股東回報。

Financial Stability and Sustainability Leadership

The Group's commitment to environmental sustainability remains integral to our long-term value creation strategy. The Group formalised quantitative targets to achieve net zero Scope 1 and Scope 2 carbon emissions by 2050, supported by interim reduction milestones of 20% by 2030 and 60% by 2040, measured against our FY2024 baseline. In FY2025, we achieved a 4.1% reduction in overall carbon emissions, demonstrating tangible progress toward these ambitious goals.

Our operational excellence in sustainability was further recognised as 4 of our battery manufacturing facilities achieved UL's Zero Waste to Landfill Platinum validation – the highest certification level for comprehensive waste management and circular economy practices. These achievements reflect our systematic approach to minimizing environmental impact while maintaining world-class manufacturing efficiency.

To support our sustainability initiatives and ongoing business operations, the Group completed a substantial 3-year syndicated green and sustainability-linked loan facility of HK\$675 million with 10 major banks and a 3-year syndicated sustainability-linked loan facility of HK\$504 million with 5 banks. These facilities demonstrate strong lender confidence in our business model, financial discipline, and environmental commitments. The sustainability-linked structure aligns our financing costs with the achievement of predetermined ESG performance targets, further embedding sustainability into our financial framework.

We continue to optimize our asset base through strategic consolidation of operations into efficient, multi-level automated facilities. Our ongoing program to divest non-core unused industrial properties in China and Malaysia progressed during FY2026, though challenging property market conditions continue to influence transaction timelines. These properties generate rental income until disposal completion, and we remain committed to redeploying capital into higher-return core business activities.

The Group's gearing ratio, defined as the Group's net bank borrowings expressed as a percentage of total equity, was 99.0% as at 31 March 2026 (FY2025: 98.4%). The new loan facilities completed during the year enhance our maturity profile and provide the financial flexibility needed to invest in growth priorities while maintaining shareholder returns.

展望

儘管全球宏觀經濟環境仍然充滿挑戰，本集團憑藉清晰之策略方向及穩健之營運實力，對未來發展保持審慎而具信心。

集團分散之生產版圖，使我們在全球貿易及成本結構出現結構性轉變、競爭環境重塑之環境下處於有利位置。中國出口增值稅退稅政策調整、持續之關稅不確定性，以及通脹壓力，預期將加快行業整合，從而為實力雄厚且具備地域靈活性之製造商創造擴大市場份額之機遇。

於電池業務方面，物聯網設備、智能家居系統、工業自動化及醫療設備等長期增長趨勢，持續為集團之特種電池及充電電池產品組合帶來強勢之長遠發展機遇。集團不斷擴展之直銷能力，以及全面的產品系列，使我們能有效覆蓋不同消費群及價格階層，進一步鞏固市場定位。

踏入2027年度，GP能源科技為集團之重點策略性發展。隨著東莞生產設施正式投入運作並於2027年度第一季度展開量產，預期將於年內開始交付首批商業訂單。位於馬來西亞之生產設施亦將於2027年度第四季度投產，進一步提升產能。本人期待於未來匯報GP能源科技錄得初步收入及持續取得之進展，隨著其逐步發展為本集團具實質貢獻之增長引擎，並長遠發揮轉型性影響。

電子及音響業務持續累積增長動能。KEF透過深化零售合作夥伴關係、擴展全球體驗中心網絡，以及推進「Sound by KEF」策略性合作，為高端音響市場之持續增長奠定穩固基礎。該市場受智能家居普及化和對無線連接高保真音響需求上升等增長動力支持，與集團之產品策略高度契合。Celestion憑藉Hometainer進軍專業消費者(prosumer)市場，加上其專業TSQ揚聲器單元迅速獲市場採用，在既有專業及現場演出業務基礎上開拓具意義之新增收入來源。

智富科技繼續捉緊由人工智能帶動的增長機會：隨著全球運算基礎設施持續擴張，特別是在人工智能與數據中心應用領域，智富科技的高精密度熱管理方案穩佔優勢，可望充分掌握圖形處理器半導體散熱市場之穩定增長的需求。

集團將持續投入資源於技術與產品研發、品牌發展、提升營運效率以及可持續發展等核心領域。鑒於本公司已承諾於2050年前達成淨零碳排放目標，並訂定2030年或以前減碳20%及2040年或以前減碳60%之階段性目標，我們正積極將金山科技打造成為兼具長期價值創造能力與短期波動承受韌性之企業，以持續為股東創造穩健且永續的回報。

Looking Ahead

While global macroeconomic conditions remain challenging, we approach the future with cautious confidence, grounded in strategic clarity and operational strength.

Our diversified manufacturing footprint positions us advantageously as structural shifts in global trade and cost structures reshape competitive dynamics. The combination of China's VAT export rebate policy changes, persistent tariff uncertainty, and inflationary pressures will likely accelerate industry consolidation, thereby creating market share opportunities for well-established manufacturers with geographic flexibility.

In the Battery Business, the secular growth trends in IoT devices, smart home systems, industrial automation, and medical devices continue to present compelling long-term opportunities for our specialty and rechargeable product portfolios. Our expanding direct-to-consumer capabilities and comprehensive product range position us effectively across multiple consumer segments and price points.

GP Energy Tech is a key strategic priority as we enter FY2027. With the Dongguan facility operational and mass production commencing in the first quarter of FY2027, we expect to begin delivering against our first commercial orders within the year. The Malaysian facility will further expand our capacity as it comes online in the fourth quarter of FY2027. I look forward to reporting initial revenues and continued progress as GP Energy Tech evolves into a meaningful growth driver for the Group that becomes transformative in the long run.

Our Electronics and Acoustics Business continues to build momentum. KEF's strengthened retail partnerships, expanding global network of Experience Centers, and strategic "Sound by KEF" collaborations provide a solid foundation for sustained growth in the premium audio market – a segment supported by growth drivers including smart home adoption and rising demand for wirelessly connected, high-fidelity audio, which aligns closely with our product strategy. Celestion's entry into the prosumer market with the Hometainer, combined with rapid adoption of its professional TSQ speaker drivers, opens meaningful new revenue streams alongside its established professional and live performance business.

Wisefull continues to provide meaningful exposure to AI-driven growth. As global computing infrastructure expands, particularly in AI and data center applications, Wisefull's high-precision thermal management solutions are well-positioned to capture sustained demand from the Graphics Processing Unit semiconductor cooling market.

We will continue to direct investment towards technology and product development, brand building, operational efficiency, and sustainability. Having committed to achieving net zero carbon emissions by 2050 – with interim reduction targets of 20% by 2030 and 60% by 2040 – we are building a business capable of delivering long-term value to shareholders while remaining resilient in the face of near-term volatility.

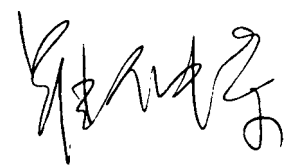

本年度業績摘要

- 營業額為70.239億港元，增加2.5%
- 毛利率下跌90個基點至28.5%
- 扣除財務成本及應佔聯營公司業績前溢利較去年度下跌7.6%至3.321億港元
- 應佔聯營公司溢利貢獻大幅上升，由去年度7,670萬港元上升至本年度1.147億港元
- 本公司擁有人應佔溢利上升7.3%至3,260萬港元
- 每股基本盈利為2.8港仙(去年度：2.9港仙)
- 負債比率輕微上升至99.0%(去年度：98.4%)
- 董事局建議派發末期股息每股0.7港仙
- 全年普通股股息為每股2.5港仙，派息率為90.9%

業務表現摘要

- 電池業務：營業額為48.661億港元(同比增長0.6%)，毛利率由25.0%下跌至24.5%
- 充電電池業務：營業額為4.17億港元(同比下跌3.5%)，毛利率下跌至12.9%
- 電子及音響業務：營業額為17.408億港元(同比增長10.2%)，毛利率下跌250基點至42.5%

業績回顧

截至2026年3月31日止年度(「本年度」)，金山科技集團的營業額為70.239億港元，較截至2025年3月31日止財政年度(「去年度」)上升1.726億港元。儘管全球電池市場競爭激烈，且受美國關稅影響導致對南北美洲的銷售減少，本年度電池業務營業額仍然微升0.6%。充電電池業務受客戶優化倉存及客戶組合變動影響，營業額於年內下跌3.5%。另一方面，電子及音響業務營業額則增長10.2%，主要受惠於新產品受市場歡迎，以及成功擴展與主要市場領先零售商合作的銷售渠道；按地域市場計算，此業務於南北美洲、歐洲及亞洲的銷售均錄得增長。

- Electronics and Acoustics Business: HK\$1,740.8 million revenue (+10.2% YoY), margin declined by 250 basis points to 42.5%

Review of Results

For financial year ended 31 March 2026 ("FY2026"), the Group generated a revenue of HK\$7,023.9 million, increased by HK\$172.6 million when compared to the last financial year ended 31 March 2025 ("FY2025"). Revenue from Battery Business slightly increased by 0.6% during FY2026. This was achieved despite intense competition in the global battery market and lower sales to the Americas, resulting from the United States ("U.S.") tariff impact. Revenue from Rechargeable Battery ("Rechargeable") Business decreased by 3.5% during FY2026 due to customer inventory optimisation and change in customer mix. Revenue from Electronics and Acoustics ("E&A") Business increased by 10.2%, driven by the successful launch of new products and sales channel expansion with leading retailers in key markets, resulting in increases in sales to Americas, Europe and Asia markets.

由於美國對入口產品加徵關稅，以及其他市場的價格競爭加劇，毛利率由去年度的29.4%下跌至本年度的28.5%。

分銷支出較上年度減少840萬港元(或1.0%)至8.532億港元，主要由於在業務環境不穩的情況下有效管理廣告及促銷支出。行政支出較上年度增加4,880萬港元(或5.7%)至9.047億港元，主要因為充電電池業務之研發費用較高，此等支出已部分被持續推行之成本減控措施(包括優化組織架構、提升營運效率以及嚴控支出)取得之成果所抵銷。

其他營運項目

本年度其他營運收入為1.394億港元，主要包括：

- 政府補助4,600萬港元(上年度：4,560萬港元)；
- 重新計量先前持有聯營公司常州鋰霸電池有限公司(「常州鋰霸」)的股權所產生的一次性公平值收益3,840萬港元(上年度：無)；
- 投資物業公平值收益1,080萬港元(上年度：公平值虧損30萬港元)；
- 電池分部附屬公司撤銷註冊產生收益480萬港元(上年度：1,160萬港元)；以及
- 利息收入870萬港元(上年度：930萬港元)。

本年度其他營運支出為4,100萬港元，主要包括：就金山科技集團內部重組作出的1,320萬港元(上年度：2,500萬港元)之撥備；註銷物業、廠房及設備850萬港元(上年度：2,210萬港元)；以及匯兌虧損1,220萬港元(上年度：匯兌收益1,920萬港元)。

本年度，金山科技集團扣除財務成本及應佔聯營公司業績前的溢利較上年度下跌7.6%至3.321億港元，主要因毛利減少及行政支出增加，而分銷支出減少連同其他收入及其他收益淨額增加已抵銷部分影響。

金山科技集團所佔聯營公司業績由上年度7,670萬港元大幅增加至本年度1.147億港元，主要因智富科技有限公司(「智富科技」)的表現改善。智富科技業務針對快速發展的圖形處理器(Graphics Processing Unit)半導體市場，為人工智能(AI)及數據中心硬件提供高精密度散熱解決方案。

Gross profit margin declined from 29.4% in FY2025 to 28.5% in FY2026 due to the impact of U.S. tariffs on products sold to the U.S. market and the increase in pricing competition in other markets.

Distribution costs decreased by HK\$8.4 million, or 1.0%, to HK\$853.2 million when compared to FY2025, mainly due to effective management of advertising and promotion expenses amid an uncertain business environment. Administrative expenses increased by HK\$48.8 million or 5.7% to HK\$904.7 million when compared to FY2025, mainly due to higher research and development (“R&D”) expenses for Rechargeable Business, partially offset by cost savings from ongoing initiatives to optimise organisational structure, enhance operational efficiency, and tighten expense control measures.

Other Operating Items

Other operating income for FY2026 amounted to HK\$139.4 million, mainly comprising:

- Government grants of HK\$46.0 million (FY2025: HK\$45.6 million),
- A one-off fair value gain on remeasurement of previously held equity interest in an associate, Changzhou Lithium Batteries Ltd. (“CZLB”), of HK\$38.4 million (FY2025: Nil),
- Fair value gain on investment properties of HK\$10.8 million (FY2025: fair value loss of HK\$0.3 million),
- Gain from de-registration of subsidiaries of the Battery segment of HK\$4.8 million (FY2025: HK\$11.6 million), and
- Interest income of HK\$8.7 million (FY2025: HK\$9.3 million).

Other operating expenses in FY2026 were HK\$41.0 million, mainly including a provision for the Group’s internal restructuring of HK\$13.2 million (FY2025: HK\$25.0 million), property, plant and equipment written-off of HK\$8.5 million (FY2025: HK\$22.1 million) and exchange loss of HK\$12.2 million (FY2025: exchange gain of HK\$19.2 million).

The Group’s profit before finance costs and share of results of associates for FY2026 declined by 7.6% to HK\$332.1 million when compared to FY2025, primarily attributable to reduced gross profit and higher administrative expenses, partially offset by reduced distribution costs and higher net other income and gains.

The Group’s share of results of associates increased substantially from HK\$76.7 million in FY2025 to HK\$114.7 million in FY2026, mainly due to the improved performance of Wisefull Technology Limited (“Wisefull”), which provides high-precision cooling solutions for AI and data center hardware, serving the rapidly expanding Graphics Processing Unit semiconductor markets.

金山科技集團受惠於借貸利率下調，財務成本下跌16.1%至1.882億港元。

股東回報

本年度本公司擁有人應佔溢利上升7.3%至3,260萬港元。根據902,689,636股(上年度：915,226,359股)的加權平均股數，並扣除永久債券的應計分配後，本公司本年度的每股基本盈利為2.8港仙。

董事局建議派發末期股息每股0.7港仙，連同每股1.8港仙的中期股息，全年股息為每股2.5港仙(上年度：每股2.5港仙)，本年度派息率為90.9%(上年度：86.2%)。

電池業務

業績概述

電池業務 – 電池業務營業額為48.661億港元，較上年度微升0.6%。按地域計算，南北美洲銷售下跌18.1%、歐洲保持平穩，亞洲的銷售則上升5.6%。來自南北美洲客戶的收入下跌，主要受全球貿易不穩及美國關稅發展所影響。

毛利率由去年度25.0%下跌至本年度24.5%，主要因為將產能由中國調配至東南亞以更有效地滿足美國市場需求，而在當地設立新生產線、員工培訓及物流所產生的額外成本所致。此外，中國政府調低電池相關產品出口增值稅退稅的新政策亦引致毛利率下跌。

本年度，金山科技集團錄得一項主要與中國閒置廠房及空地相關的1,080萬港元投資物業公平值收益，及一項因重新計量先前持有常州鋰霸股權所產生的一次性公平值收益3,840萬港元。去年同期因註銷一間位於馬來西亞的不活動電池附屬公司錄得一次性收益1,160萬港元。

本年度，電池業務盈利貢獻大致維持平穩，由去年度4.325億港元微跌至本年度4.295億港元，因為股本權益及投資物業所產生的一次性公平值收益大致抵銷了因毛利下跌及行政支出增加造成的影響。

The Group's finance costs declined by 16.1%, reaching HK\$188.2 million, attributable to a reduction in borrowing interest rates.

Shareholder Returns

Profit attributable to equity holders of the Company for FY2026 increased by 7.3% to HK\$32.6 million. Based on the weighted average of 902,689,636 (FY2025: 915,226,359) shares in issue and deducting the accrued distribution for perpetual bonds, basic earnings per share for FY2026 was 2.8 HK cents.

The Directors have proposed a final dividend of 0.7 HK cent per share which, together with the interim dividend of 1.8 HK cents per share, will bring the full-year dividend to 2.5 HK cents per share (FY2025: 2.5 HK cents per share), representing a payout ratio of 90.9% for FY2026 (FY2025: 86.2%).

Battery Business

Performance Overview

Battery Business – The revenue of the Battery Business for FY2026 was HK\$4,866.1 million, slightly increased by 0.6% when compared to FY2025. In geographical terms, sales to Americas decreased by 18.1%, Europe remained stable, while sales to Asia increased by 5.6%. The decline in revenue from customers in the Americas was primarily attributable to uncertainties in global trade and developments in U.S. tariffs during FY2026.

Gross profit margin declined from 25.0% in FY2025 to 24.5% in FY2026. The decrease was primarily due to the additional costs associated with the reallocation of production capacity from China to Southeast Asia, including new production line setup, staff training and higher logistics expenses, to better serve the U.S. market. A new China government policy to reduce Value Added Tax ("VAT") rebate for battery related product export also contributed to the gross profit margin decline.

During FY2026, the Group recorded a fair value gain on investment properties of HK\$10.8 million, primarily relating to the unused factory buildings and vacant land in China and a one-off fair value gain on remeasurement of previously held equity interest in CZLB of HK\$38.4 million, compared to a one-off gain of HK\$11.6 million from de-registration of a dormant Malaysia battery subsidiary in FY2025.

Segment profit of the Battery Business remained broadly stable, decreasing slightly from HK\$432.5 million in FY2025 to HK\$429.5 million in FY2026, as the impact of lower gross profit and higher administrative expenses was largely offset by one-off fair value gains on equity interest and investment properties.

充電池業務 – 充電池業務營業額為4.17億港元，較去年度下跌3.5%，主要因為受客戶優化倉存及客戶組合變動影響。按地域計算，亞洲銷售上升24.9%，歐洲維持平穩，而南北美洲則下跌55.6%。

毛利率由去年17.2%下跌至12.9%，主要由於客戶組合轉向毛利率相對較低的自有品牌(private label)客戶。

充電池業務分部業績由上年度960萬港元溢利轉為本年度4,160萬港元虧損；主要因為毛利下跌以及鎳鋅電池業務之研發費用增加。

GP能源科技

GP能源科技有限公司(「GP能源科技」)位於中國東莞的首間鎳鋅電池生產設施已於2026年1月正式啟用，此工廠與集團創新中心毗鄰，並鄰近主要物流基礎設施，地理位置優越，能有效滿足針對數據中心及重要人工智能基建對非易燃、可持續備用電力方案日益增長的需求。

市場狀況與競爭環境

本年度，集團的電池業務組合面對兩種迥異的市場趨勢。一方面，物聯網(IoT)及智能家居設備日趨普及，帶動市場對鈕型電池及特種電池的需求；另一方面，持續的通脹壓力及地緣政治不確定性，導致零售商與消費者由高端品牌轉向自有品牌的鹼性電池，進一步加劇傳統零售渠道間的競爭。

進一步而言，中國持續回撤增值稅(VAT)出口退稅政策，對行業構成重大結構性挑戰。該退稅稅率由2024年12月的13%下調至9%，並於2026年4月進一步降至6%；而該退稅安排更預計於2027年1月全面取消。此舉實質上將使以中國為基地的出口商之工廠成本增加約13%。董事預期行業需12至18個月的調整期，並將加速資源不足的競爭者間之合併。

集團早年率先擴大中國以外生產版圖的投資已令其穩佔重大優勢。由於集團面對直接受中國出口政策及全球關稅不確定因素的影響相對較少，令集團具備良好條件以應對短期市場波動，並預期隨著行業整合重塑競爭格局而受益。基於上述考量，集團將資源投向利潤率較高的特種電池業務分部，同時拓展針對充電池及快充解決方案的直銷電子商貿，以精簡供應鏈及降低交易成本。

Rechargeable Business – The revenue of the Rechargeable Business for FY2026 was HK\$417.0 million, a decrease of 3.5% when compared to FY2025. The decrease in sales was mainly due to customer inventory optimisation and change in customer mix. In geographical terms, sales to Asia increased by 24.9%, Europe remained stable, and the Americas decreased by 55.6%.

Gross profit margin declined from 17.2% in FY2025 to 12.9% in FY2026, mainly due to a shift in customer mix toward private label customers with relatively lower margins.

Segment results of the Rechargeable Business changed from a HK\$9.6 million profit in FY2025 to a HK\$41.6 million loss in FY2026, mainly due to a lower gross profit and the increase in R&D expenses for the Nickel-Zinc (“NiZn”) battery business.

GP Energy Tech

In January 2026, GP Energy Tech Limited (“GP Energy Tech”) officially opened its first NiZn battery manufacturing facility in Dongguan, China. Located adjacent to the Group’s Innovation Center and key logistics infrastructure, the facility is well-positioned to serve growing demand for non-flammable, sustainable power backup solutions, particularly for data centers and critical AI infrastructure.

Market Conditions and Competitive Landscape

The Group’s battery portfolio faced two diverging market trends in FY2026. Growing adoption of connected IoT and smart home devices is driving robust demand for coin cell and specialty batteries, while persistent inflation and geopolitical uncertainty have led retailers and consumers to trade down from premium to private label Alkaline brands, intensifying competition across traditional retail channels.

Compounding this, China’s ongoing rollback of its VAT export rebate presents a significant structural challenge for the industry. Reduced from 13% to 9% in December 2024 and further to 6% in April 2026, the rebate is scheduled for full elimination by January 2027, greatly increasing factory costs for China-based exporters by approximately 13%. The Directors anticipate a 12-to-18-month industry adjustment period and accelerated consolidation among less well-resourced competitors.

The Group’s early investment in manufacturing capacity outside China has proven to be a material competitive advantage. With comparatively limited direct exposure to Chinese export policy and global tariff uncertainty, the Group is well-positioned to navigate near-term disruption and expects to benefit as consolidation reorders the competitive landscape. Accordingly, the Group is directing resources toward higher-margin specialty segments while expanding direct-to-consumer e-commerce for rechargeable and fast-charging solutions to streamline the supply chain and reduce transaction costs.

南北美洲

南北美洲電池業務於2026年度營業額下跌18.1%，主要原因在於美國關稅政策波動及通脹壓力，導致大型零售商的主流市場消費放緩。集團「China Plus One(中國加一)」生產策略發揮了重要的競爭性對沖作用。集團位於越南胡志明市的鹼性電池工廠目前已達全年滿產營運，可以直接供應美國市場，有效避免來自中國原產地關稅所帶來的懲罰性成本。儘管高階品牌客戶的市場狀況仍然充滿挑戰，但由於主要自有品牌客戶的需求殷切——其高度重視集團的產能規模與技術可靠性——已抵銷了部份的收入下滑。

歐洲

年內，歐洲電池銷售維持穩定。持續上漲的生活成本壓抑消費意願，消費者轉移選取價格較低的替代品，導致品牌消費及工業兩大板塊均出現兩位數下滑。預期中國回撤增值稅(VAT)退稅政策將進一步加劇競爭壓力，令以中國為基地的出口商成本增加，並加速產業層面的更廣泛調整。面對上述情況，集團正在重組其歐洲組織架構，以更直接對接終端市場，同時發揮完整產品組合的優勢——由價值為導向的碳鋅至高端鹼性電池兼備——服務對價格越來越謹慎的消費者。

亞洲

年內，亞洲仍是集團最具韌性的電池市場，電池銷售額上升5.6%。地區內快速都市化，對用於追蹤及感測應用裝置的特種鈕型電池需求強勁。由於集團在越南當地已設置生產基地及建立區域合作夥伴，令越南逐步成為重要增長市場。為進一步強化中國以外的市場能力，集團正規劃於河內寧平(Ninh Binh)設立新的鈕型鋰電池營運據點。此外，集團亦正將馬來西亞柔佛州境內三座位於不同地點的工廠進一步整合至位於士乃(Senai)的廠區，以提升整體營運效率。在亞洲發展成熟的市場內，消費電池自有品牌的競爭持續加劇，並取代高端品牌；對此，集團正強化其「物超所值」的定位，並拓展直銷電子商貿，此模式特別適用於應對小型特種電池與充電電池產品的銷售需求。

Americas

Americas battery revenue decreased by 18.1% in FY2026, driven primarily by U.S. tariff volatility and inflationary pressures that slowed mass-market consumption through big-box retailers. The Group's "China Plus One" manufacturing strategy provided a critical competitive hedge. The Group's Ho Chi Minh City Alkaline facility in Vietnam, currently operating at full annual capacity, is serving the U.S. market directly and avoiding the cost penalties of China-origin tariffs. While conditions for premium brands remain challenging, strong demand from major private label customers who value the Group's manufacturing scale and technical reliability has partially offset the decline in revenue.

Europe

Battery sales in Europe remained stable in FY2026. The ongoing cost-of-living crisis dampened consumer spending, with double-digit declines in branded consumer and industrial segments as buyers shifted to lower-priced alternatives. The China VAT rebate rollback is expected to compound competitive pressures further, increasing costs for China-based exporters and accelerating broader industry adjustment. In response, the Group is restructuring its European organisation to engage more directly with end markets, while leveraging its full portfolio – from value-driven Carbon Zinc to premium Alkaline – to serve increasingly price-sensitive consumers.

Asia

Asia remained the Group's most resilient battery market, with sales growing 5.6% in FY2026. Rapid urbanisation across the region continues to fuel demand for specialty coin cells in tracking and sensing applications. Vietnam has emerged as a key growth market supported by the Group's localised manufacturing and regional partnerships. A new Lithium coin cell operation in Ninh Binh, Hanoi is under planning as part of our strategy to strengthen our position in serving customers outside of China. The Group is also consolidating its 3 factories, located in different locations in Johor, Malaysia, to Senai for better operation efficiency. In established Asian markets, private label competition for consumer batteries is intensifying, often displacing premium brands. The Group is responding by reinforcing its value-for-money positioning and expanding its direct-to-consumer e-commerce presence, which is particularly well-suited to the small form factor of specialty and rechargeable battery products.

電子及音響業務

業績概述

電子及音響業務本年度營業額為17.408億港元，較去年度上升10.2%。

本年度，KEF的銷售增長10.0%，成功推出的新產品和拓展分銷渠道帶動亞洲和歐洲銷售分別增長12.2%及15.1%。Celestion專業揚聲器驅動器業務營業額維持平穩，因應關稅影響，金山科技將部份生產由中國轉移至英國工廠，此等轉移仍在進行中。專業音響製造業務來自外部客戶的營業額上升15.1%，主要來自泰國工廠的新增訂單。銷售上升由南北美洲與亞洲的增長帶動，增幅分別為14.8%與30.6%。

此業務之毛利率下跌至42.5%，比去年同期下跌250個基點，主要受美國對進口品牌音響產品關稅影響，此等產品約佔KEF銷售的45%；同時，新開發的全球零售鏈的銷售毛利亦較低。此外，中國和泰國工廠的物流成本較高亦影響毛利率，但此成本預期隨供應鏈穩定而下調。儘管毛利受壓，透過有效管控廣告與促銷支出，以及透過重組與提升營運效率令行政開支持續減少，盈利仍錄得增長。

市場狀況與競爭環境

全球揚聲器市場持續展現強勁增長潛力，主要受智能家居技術普及和消費者對高保真音響體驗的需求上升所帶動。以KEF投入營運的高端無線音響细分市场而言，預估將由2026年的146億美元增長至2035年的408億美元，增長率明顯高於整體市場，反映消費支出在結構上持續轉向無線、具連網功能且在音色表現上更為精準細緻的音響產品；此快速增長亦受到多項因素支持，包括高解析度串流與空間音頻(spatial audio)逐漸成為主流、新興市場可支配收入增加，以及消費者對家居與私家車車箱之間的音響無縫接連的期望不斷提高。KEF聚焦連網型高端音響策略，並以LS60 Wireless等產品線為代表，使品牌得以在此產業演進中穩據核心位置。

Electronics and Acoustics Business

Performance Overview

The revenue of the E&A Business for FY2026 was HK\$1,740.8 million, an increase of 10.2% when compared to FY2025.

KEF's sales increased by 10.0% in FY2026, driven by successful new product launches and distribution channel expansion. These initiatives contributed to a sales increase of 12.2% in Asia and 15.1% in Europe. Revenue from the Celestion professional speaker driver business remained stable in FY2026, as the transfer of certain production from China to United Kingdom ("U.K.") factory, undertaken to mitigate tariff impact, is still in progress. The professional audio manufacturing business reported a 15.1% increase in revenue from external customers, primarily attributable to additional production orders for the Thailand factory. The sales increase was driven by 14.8% and 30.6% increases to the Americas and Asia, respectively.

Gross profit margin of the E&A Business for FY2026 declined to 42.5%, representing a decline of 250 basis points when compared with FY2025. The decline was primarily attributable to U.S. tariffs on branded acoustics products imported to the US market, which account for approximately 45% of KEF's sales, and lower margins from selling to new global retail chains. Higher logistic costs to support production in China and Thailand also contributed; however, these costs are expected to gradually decrease as supply chains stabilise. Despite the margin pressure, profitability growth was supported by enhanced financial discipline in managing advertising and promotion expenses, together with the continued reduction of administrative expenses through restructuring initiatives and operational efficiency improvements.

Market Conditions and Competitive Landscape

The global loudspeaker market continues to demonstrate strong growth potential, driven by the convergence of smart home technology adoption and growing consumer demand for high-fidelity audio experiences. The premium wireless audio segment, in which KEF operates, is projected to expand from US\$14.6 billion in 2026 to US\$40.8 billion by 2035, a materially higher rate of growth than the broader market, reflecting a structural shift in consumer spending toward wireless, connected, and acoustically sophisticated hardware. This acceleration is supported by the mainstreaming of high-resolution streaming and spatial audio formats, rising disposable incomes in emerging markets, and the growing expectation of seamless audio integration across home and automotive environments. KEF's focus on connected premium acoustics, exemplified by product lines such as LS60 Wireless, positions the brand at the center of this evolution.

KEF

亞太地區的需求正展現強勁增長力，預期2026年約佔全球家庭音響設備市場的35%。KEF的體驗中心網絡亦反映此策略重點：除既有的香港、倫敦與東京據點外，並在北京與成都開設專屬的KEF Music Galleries/Studio。此等經精心規劃的陳列室除提供具策展規劃的聆聽環境外，亦是KEF「Listen and believe」零售策略之核心。

除展示產品功能外，各場地亦可舉行貴賓式合作夥伴活動及聆聽體驗，旨在擴大品牌影響力、加強與顧客的契合，進一步提升目標顧客群之品牌忠誠度，這些具生活品味、追求高品質體驗及購買力充裕的顧客正是KEF要網羅的主要對象。

年內，北美洲受通脹壓力及關稅不確定性影響，家居開支預算受壓，令大型零售渠道之主流消費明顯放緩。集團因應此情況，調整KEF的分銷策略，轉向專業高端零售夥伴，減低依賴以銷量為主導的大型零售商；此重整策略成功保護品牌價值，並令毛利得以維持。在音響產品市場，高端音響消費者的價格敏感度相較中端客群為低，此結構性差異使KEF得以免受競爭對手因營運較低價產品所面對之嚴峻營商環境的衝擊。隨著市場演變，高端消費對音響的期望亦越來越高：產品除須具備出色音質表現外，亦須配有無線連線功能、以用者為中心的設計，並呈現卓越的設計美學。

集團的「Sound by KEF」合作計劃，透過將KEF的技術嵌入周邊快速增長高端產品，進一步提升品牌價值。其合作產品類別及模式包括：

- **路特斯科技(Lotus Technology)**：將KEF的音響技術用於Lotus旗艦車款的音響系統：包括Emira、Eletre、Theory 1及Emeya。
- **海爾智家(Haier Smart Home)**：KEF的音響調校技術已在「Sound by KEF」品牌標籤下用於海爾旗下卡薩帝(Casarte)超高端電視產品線。此合作將專業等級的多聲道音響系統直接嵌入高端平面電視產品中，從而將KEF的銷售延伸至家用電子產品零售渠道。
- **華為**：KEF與HUAWEI HiPlay無線音響系統的合作將KEF的音響技術帶進華為智能連網家居，進一步擴大品牌在中國主要消費類科技平台上的接觸面。
- **Nothing**：Nothing是一間以倫敦為基地的消費類科技公司，主要以設計前衛的智能電話而聞名，KEF以「Sound by KEF」為音響技術合作基礎，共同推出Headphone (1)耳機。

KEF

The Asia-Pacific region is emerging as the most dynamic driver of demand, expected to account for approximately 35% of the global home audio equipment market in 2026. The Group's network of Experience Centers reflects this strategic priority, with dedicated KEF Music Galleries/Studios in Beijing, Chengdu complementing established venues in Hong Kong, London and Tokyo. These purpose-designed showrooms serve as curated listening environments and are central to KEF's "Listen and believe" retail strategy.

Beyond product demonstrations, the venues host invitation-only partnership events and listening events, designed to expand brand reach, drive consumer engagement and deepen brand loyalty among the affluent, lifestyle-oriented consumers who represent KEF's expanded target audience.

In North America, consumer spending through mass-market retail channels slowed considerably in FY2026 as inflationary pressures and tariff uncertainty weighed on household discretionary budgets. The Group responded by rebalancing KEF's distribution toward specialist premium retail partners and reducing its exposure to volume-dependent big-box retail. This deliberate repositioning protected brand equity and margin discipline. Premium audio consumers exhibit materially lower price sensitivity than mid-market counterparts, a structural characteristic that insulated KEF from the more severe trading conditions faced by competitors operating in lower price tiers. Consumer demand in the premium segment is increasingly defined by expectations for audio hardware that combines sophisticated acoustic performance, wireless connectivity, user-centered features, and design excellence.

The Group's "Sound by KEF" partnership programme capitalises on its growing brand equity by embedding KEF's technology into premium products across adjacent high-growth categories:

- **Lotus Technology**: KEF's acoustic engineering underpins the audio systems across Lotus's flagship vehicle line-up, including the Emira, Eletre, Theory 1, and Emeya.
- **Haier Smart Home**: Under the "Sound by KEF" label, KEF's acoustic tuning is integrated into Haier's Casarte ultra-premium television range. The partnership embeds professional-grade multi-channel audio directly into premium flat-panel displays, extending KEF's distribution into the home electronics retail channel.
- **Huawei**: A collaboration with HUAWEI HiPlay wireless audio architecture brings KEF's acoustic technology to Huawei's connected home ecosystem, extending the brand's reach across China's dominant consumer technology platform.
- **Nothing**: KEF partnered with Nothing, the London-based consumer technology company known primarily for its design-forward smartphones, to create Headphone (1), featuring "Sound by KEF" acoustic collaboration.

KEF透過上述合作夥伴關係，總體成功將其市場版圖拓展至高端電動車、智能家居顯示屏及便攜式消費類音響等領域。該等細分市場正處於高速增長階段，而音質表現亦日益被視為主要差異化因素及核心競爭優勢。

Celestion

專業音響分部方面，Celestion繼續掌握全球現場娛樂市場的結構性增長機遇。隨著體育場館及大型音樂節巡演規模不斷發展，市場對Celestion高輸出、大型揚聲器單元的需求於全球保持穩定增長。

Celestion在2026年度內的一項重要里程碑為於英國萊士域治(Ipswich)廠房正式啟用全新自動化生產線，專門用於生產Ten Squared (TSQ)系列之大型揚聲器單元，涵蓋18吋至24吋產品。是次投資之旗艦產品TSQ2460已迅速獲得全球主要巡演製作項目之工程師及系統整合商廣泛採用。此外，Celestion於英國、泰國及中國之生產設施繼續靈活運作，致力高效服務全球市場，同時審慎應對不斷演變之貿易政策所帶來的影響。

Celestion首次憑藉其累積逾百年之音響工程專業及品牌傳承，正式拓展消費市場領域。於2025年12月推出之「Hometainer」為一套多功能娛樂系統，將Celestion專業級音響組件應用於精緻家居化設計之中，兼顧卓越音效表現與室內美學。Hometainer有效填補市場上介乎功率不足之消費級設備與商業規模專業系統之間的空隙。該系統主要針對迅速增長之亞洲高端家用卡拉OK市場而設。透過拓展「專業級消費者」(Prosumer)音響市場，Celestion得以在現場演出場館及專業錄音室應用以外，進一步多元化開拓其銷售來源。

其他工業投資

此業務包括集團於美隆工業股份有限公司、惠山工業有限公司及智富科技之投資。此業務的盈利由去年度1,130萬港元增加至3,850萬港元，主要由於所佔智富科技業績改善。

資本資源與流動性

本年度，集團成功與十家銀行完成一項為期三年的可持續發展掛鈎銀團貸款，金額為6.75億港元；及與五家銀行完成一項為期三年的可持續發展掛鈎銀團貸款，金額為5.04億港元。此等貸款加強了集團貸款組合的到期結構，並提升集團整體流動資金狀況。於2026年3月31日，集團的流動資產淨值為2,370萬港元，而於2025年3月31日則錄得流動負債淨額1.594億港元。

Together, these collaborations extend KEF's market presence into premium electric vehicles, smart home displays, and portable consumer audio: segments experiencing rapid growth where audio quality is increasingly regarded as a primary differentiator.

Celestion

In the professional audio segment, Celestion continues to capitalise on structural growth in global live entertainment. Structural expansion in stadium and festival touring is driving sustained demand for the Celestion high-output, large-format speaker drivers worldwide.

A significant development in FY2026 was the launch of a new automated production line at Celestion's Ipswich facility in the U.K., dedicated to the Ten Squared (TSQ) range of large-format drivers spanning the 18-to-24-inch format. The flagship of this investment is the TSQ2460 which has achieved rapid adoption among engineers and systems integrators serving major touring productions globally. Celestion's manufacturing facilities in the U.K., Thailand, and China continue to provide operational flexibility to serve global markets efficiently while managing the implications of evolving trade policy.

For the first time, Celestion is leveraging its century of acoustic engineering expertise and brand heritage to expand into the consumer sector. Launched in December 2025, the "Hometainer" is a multi-purpose entertainment system that applies Celestion's professional acoustic components to a refined domestic form factor. Hometainer fills an underserved gap in the market between underpowered consumer-grade equipment and commercially-scaled professional installations. The system is designed principally for the rapidly growing Asian premium home Karaoke market. By addressing the prosumer audio market, Celestion meaningfully diversifies its revenue base beyond live performance venues and professional studio applications.

Other Industrial Investments

This business segment mainly includes the Group's investments in Meiloon Industrial Co., Ltd., Shinwa Industries (H.K.) Limited and Wisefull. Segment profit increased from HK\$11.3 million in FY2025 to HK\$38.5 million in FY2026, mainly due to the improved share of results from Wisefull.

Capital Resource and Liquidity

During FY2026, the Group entered into a 3-year green and sustainability-linked syndicated loan facility of HK\$675 million with 10 major banks, and a 3-year sustainability-linked syndicated loan facility of HK\$504 million with 5 banks. These loan facilities enhanced the maturity profile of the Group's loan portfolio and strengthened overall liquidity of the Group. As at 31 March 2026, the Group recorded a net current asset position of HK\$23.7 million, as compared with a net current liability position of HK\$159.4 million as at 31 March 2025.

流動比率(按流動資產除以流動負債計算)於2026年3月31日為1.01(2025年3月31日：0.96)。

集團之負債比率(定義為其銀行借款淨額除以權益總額的比率)於2026年3月31日為99.0%(2025年3月31日：98.4%)。

營運可持續性

於2026年度，集團持續推展「廢棄物零填埋」認證(Zero Waste to Landfill「ZWTL」)，在可持續生產方面取得實質進展。目前，集團共有6間電池生產設施獲UL Solutions頒發ZWTL認證：其中4間成功獲頒白金級認證(2025年3月31日：3)，證明達至100%廢棄物轉移率；另有2間取得金級認證(2025年3月31日：3)，達到最少95%廢棄物轉移率。上述認證充分體現集團能於地域分佈廣泛的生產網絡中，以工業規模持續維持最高環保營運標準。

本集團所有電池生產基地均取得ISO 14001環境管理認證，其中大部分亦同時取得ISO 45001職業健康與安全管理體系認證。各生產設施之社會責任標準均按照amfori商界社會責任審核倡議(Business Social Compliance Initiative，「BSCI」)進行獨立審核，而且全數均達致滿意或以上評級。為進一步將可持續發展理念融入為共同目標，集團正推行一項評核機制，將具體環境、社會及管治(ESG)指標納入全球員工之表現評核中。

上述營運優化措施體現並支持集團承諾於2050年前實現範疇一及範疇二營運層面淨零碳排放之目標。以2024年度為基準，集團已訂立階段性減排目標，計劃於2030年前減少20%，並於2040年前減少60%。於2025年度，集團於範疇一及範疇二溫室氣體排放量較基準年度減少4.1%。碳排放數據已由獨立第三方進行核證，確保減排進展具備年度可追溯性，並符合上市規則之相關規定。氣候風險披露亦已顯著提升，集團於最近一期可持續發展報告中，已符合《國際財務報告準則》第S2號標準之大部分規定。為落實推行上述減碳目標，本公司可持續發展督導委員會已批准減排計劃，裝置太陽能發電及綠色能源採購措施，並獲由5家銀行提供5.04億港元之可持續發展掛鉤銀團貸款作為資金支持。

集團透過加強供應商參與及完善採購管治機制，將上述原則延伸延至整個價值鏈。集團已正式推行《供應商行為守則》，並配合定期合規審核及為供應商夥伴提供可持續發展培訓，以確保有效落實相關標準。

The current ratio, calculated as the ratio of current assets to current liabilities, was 1.01 as at 31 March 2026 (31 March 2025: 0.96).

The Group's gearing ratio, defined as the Group's net bank borrowings expressed as a percentage of total equity, as at 31 March 2026 was 99.0% (31 March 2025: 98.4%).

Operational Sustainability

The Group's commitment to sustainable manufacturing advanced meaningfully in FY2026 with the continued expansion of its Zero Waste to Landfill ("ZWTL") programme. Six of the Group's battery manufacturing facilities have now achieved ZWTL certification from UL Solutions: 4 at Platinum level (31 March 2025: 3), requiring 100% diversion of waste from landfill, and 2 at Gold level (31 March 2025: 3), requiring a minimum diversion rate of 95%. Together, these certifications demonstrate that the highest environmental operating standards can be maintained at industrial scale across a geographically diverse manufacturing base.

All of the Group's battery manufacturing sites have obtained ISO 14001 certification for environmental management systems, with the majority having additionally secured ISO 45001 certification for occupational health and safety management systems. Social responsibility standards across these facilities are independently audited under the amfori's Business Social Compliance Initiative ("BSCI"), with all sites achieving satisfactory or above grades. To further embed sustainability as a shared objective, the Group is implementing an appraisal scheme that integrates specific ESG targets into the performance evaluations of all employees globally.

These operational improvements support the Group's commitment to achieving net zero operational carbon emissions in Scopes 1 and 2 by 2050. Against the FY2024 baseline, the Group has established interim reduction targets of 20% by 2030 and 60% by 2040. In FY2025, the Group recorded a 4.1% reduction in Scope 1 and Scope 2 greenhouse gas emissions against this baseline. Carbon emissions data is independently verified by a third party, ensuring annual traceability of progress and compliance with listing requirements. Climate risk disclosure has also been materially strengthened, with the Group achieving compliance with the majority of IFRS S2 standard requirements in its most recent Sustainability Report. Supporting this trajectory, a carbon reduction plan approved by the Sustainability Steering Committee of the Company combines on-site solar energy generation with off-site green energy procurement, underpinned by a HK\$504 million syndicated sustainability-linked loan facility secured with a consortium of 5 banking partners.

The Group extends these principles across its value chain through strengthened supplier engagement and procurement governance. A formal Supplier Code of Conduct has been implemented, supported by regular compliance audits and sustainability training for supply chain partners.

在產品層面，本集團於2026年度進一步推展可持續包裝計劃，把歐洲市場超過1,000款GP品牌消費類電池產品之塑膠包裝更換為紙包裝，每年減少48噸塑膠使用量及30噸整體物料廢棄量。此外，GP能源科技之鎳鋅電池技術已投入商業化應用，主要針對數據中心及重要基礎設施後備電源市場，進一步落實集團於產品層面的可持續發展承諾。鎳鋅電池之可回收率超過90%，且不含需特別處置之有害物質，其於產品生命週期終結階段之環境足跡較傳統鋰離子電池顯著較低。

展望

預期截至2027年3月31日止財政年度的全球宏觀經濟環境仍然充滿挑戰，地區軍事衝突、持續的地緣政治緊張局勢、貿易政策的演變以及持續的通脹壓力，將繼續令消費需求受壓。

儘管面對上述不利因素，集團仍展現柔韌性，主要憑藉其對核心品牌的策略性投資、高增長之商用儲能解決方案，及長期致力分散地域產能。基於集團在中國以外擁有廣泛的業務布局，其中包括在東南亞及英國等地區設有八間生產設施，集團董事評估貿易政策不斷演變的潛在影響在可控範圍內，由中國直接出口至美國的產品之風險相較同業而言，受影響程度相對有限。

為應對宏觀經濟的不確定性，集團繼續密切監察相關發展，並調整營運策略以維持盈利能力，同時確保能夠迅速回應客戶需求。相關措施包括透過強化東南亞的產能，進一步投資其「China Plus One(中國加一)」策略，以滿足美國及其他全球市場需求。集團早年率先落實擴大中國以外生產版圖已令其穩佔優勢，因該等設施的營運已日趨成熟，如越南胡志明市的鹼性電池工廠目前已全面投產。儘管持續的地緣政治緊張局勢及貿易政策演變對集團的直接影響相對較小，董事局預期宏觀經濟環境可能推動同業之間的整合。就中長期而言，由於集團在中國以外已建立完善的生產基礎，董事預料業內任何整合將有利其發展，並已準備就緒以掌握數據中心儲能領域快速增長之機遇。

At the product level, the Group advanced its packaging sustainability programme in FY2026, replacing plastic packaging with paper-based alternatives across more than 1,000 GP-branded consumer battery products in Europe, achieving an annual reduction of 48 tonnes of plastic and 30 tonnes of total material waste. The commercial introduction of GP Energy Tech's NiZn battery technology – principally targeting data center and critical infrastructure backup power applications – further extends these product-level commitments. With a recyclability profile exceeding 90% and no hazardous materials requiring special disposal, NiZn carries a materially lower environmental footprint at end-of-life than conventional Lithium-ion alternatives.

Outlook

Global macroeconomic conditions are expected to remain challenging in the financial year ending 31 March 2027 ("FY2027"), characterised by regional armed conflicts, persistent geopolitical tensions, evolving trade policies, and inflationary pressures that continue to weigh on consumer demand.

Despite these headwinds, the Group has demonstrated resilience, underpinned by strategic investments in its core brands, high-growth commercial energy storage solutions, and a long-standing commitment to geographic manufacturing diversification. The Directors have assessed the potential impact of evolving trade policies as manageable, given the Group's extensive footprint outside of China, which includes eight regional manufacturing facilities across Southeast Asia and U.K. The exposures of products directly exported from China to the U.S. are relatively limited compared to competitors.

To address macroeconomic uncertainties, the Group continues to monitor developments closely and adapt its business strategies in order to maintain profitability while remaining responsive to customer needs. This includes further investment in the Group's "China Plus One" strategy by enhancing production capacity in Southeast Asia to serve the U.S. and other global markets. The Group's early commitment to expanding its manufacturing footprint outside of China has proven to be an advantage as these facilities started reaching operational maturity. For example, the Ho Chi Minh City Alkaline battery plant is currently operating at full capacity. Despite the Group's relatively limited exposure to persistent geopolitical tensions and evolving trade policies, the Directors anticipate that the macroeconomic environment may lead to industry consolidation amongst competitors. In the mid-to-long term, the Directors expect the Group to be well positioned to benefit from any industry consolidation, due, in a large part, to its well-established manufacturing bases outside of China and its readiness to capture the rapid growth of the data center energy storage sector.

集團繼續致力於核心業務的創新與產品開發。在電池業務方面，集團正將資源調配至毛利更高的特種產品，例如市場對於物聯網(IoT)及智能家居的鈕型電池的需求仍然殷切。此外，集團亦正擴大其直銷電子商貿業務，以精簡供應鏈並降低交易成本。透過向消費者宣傳具創新快充技術的充電池解決方案之效益，集團正開拓與其可持續核心承諾一致的新商機。

GP能源科技於2027年度之始已制定清晰的營運路線圖，在重要即時供電應用領域推進其鎳鋅電池技術商業規模化。隨著東莞廠房已於2026年1月順利投產，6月中全面大量投產，集團預期將於2027年度第二季交付首批商業訂單。馬來西亞廠房亦按計劃於2027年3月前投產。此等安排將進一步拓展集團的生產版圖，以滿足數據中心及重要基礎設施日益增長的需求。

有別於鋰離子，鎳鋅電池的化學系統具不易燃性，可排除熱失控風險，此安全優勢對現代人工智能數據中心高密度伺服器環境尤為重要。鎳鋅的功率密度可達傳統電池的三倍，且回收率超過90%，能同時提供卓越性能及環保效益，以滿足數據中心營運商及重要基礎設施客戶日益嚴格之空間節省要求及企業淨零排放目標。

在電子及音響業務方面，KEF將繼續拓展其無線音樂系統產品組合，並加強分銷覆蓋及擴展直達消費者的接觸渠道，並以其全球旗艦體驗中心網絡及多項具影響力的「Sound by KEF」合作項目作為支持。KEF亦將透過增加情感差異化強化品牌推廣，全力開拓高端消費者市場。Celestion則於英國萊士域治啟用一條全自動新生產線(專供生產Ten Squared(TSQ)系列大型高階專業音箱)而成功切入並打開新的市場領域，其旗艦TSQ 24吋驅動單元迅速進佔表演／音樂會市場與高效能居家音響系統。2025年12月，Celestion以Hometainer正式進軍專業消費者市場，此系列為第二代多用途娛樂系統，整體設計兼具親居家美學，以快速增長的亞洲消費者卡拉OK市場為目標。

The Group remains committed to innovation and product development across its core business segments. In the Battery Business, the Group is shifting resources toward higher-margin specialty products, such as coin cells for IoT and smart home applications, where demand remains robust. Additionally, the Group is expanding its direct-to-consumer e-commerce activities to streamline the supply chain and reduce transaction costs. By marketing to consumers the benefits of innovative fast-charging rechargeable battery solutions, the Group is creating new opportunities that align with its core commitment to sustainability.

GP Energy Tech enters FY2027 with a clear operational roadmap for the commercial scale-up of its NiZn battery technology, for critical immediate power applications. Following the successful commissioning of the Dongguan facility in January 2026, the Group commenced full mass production in mid-June 2026, with initial commercial order deliveries anticipated in the second quarter of FY2027. The new Malaysian facility remains on track to come online by March 2027, which will further diversify the Group's manufacturing footprint to serve growing demand of the Group's NiZn products from data centers and critical infrastructure.

Unlike Lithium-ion, NiZn battery chemistry is intrinsically non-flammable and eliminates the risk of thermal runaway – a critical safety advantage in the dense server environment of modern AI data centers. With up to three times the power density of conventional battery chemistries and greater than 90% recyclability, NiZn delivers both the performance and the environmental profile that data center operators and critical infrastructure clients increasingly require to meet stringent space-saving requirements and strict corporate net-zero mandates.

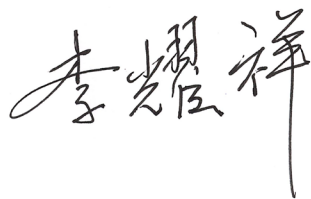
In the E&A Business, KEF will continue to expand its wireless audio systems portfolio and drive distribution penetration and expansion in direct-to-consumer touchpoints. This is supported by its global network of flagship Experience Centers and high-profile “Sound by KEF” partnerships. KEF will also enhance brand marketing with additional emotional differentiation to attract more premium customers. Celestion is successfully disrupting new segments, supported by the commissioning of a new fully automatic production line in Ipswich, U.K., dedicated to the Ten Squared (TSQ) range of large-format premium professional audio speakers. The flagship TSQ 24-inch drivers are seeing rapid adoption in the concert market and in high-performance home audio systems. In December 2025, Celestion entered the prosumer market with the launch of the Hometainer, a series of second-generation multi-purpose entertainment systems featuring a home-friendly aesthetic design primarily targeting the fast-growing Asian consumer Karaoke market.

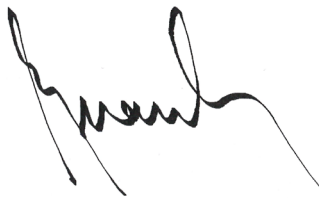

The Group intends to accelerate the divestment of non-core assets, including unused factories and vacant land in China and Malaysia. By consolidating operations into more efficient, multi-level automated facilities, the Group is freeing up prime industrial properties for disposal or rental income generation. These initiatives, coupled with securing substantive new sustainability-linked loan facilities from a consortium of banks, will further strengthen the Group's financial position and provide the flexibility necessary for future growth, specifically in integrating advanced technologies into its energy storage architectures.

While global trading and macroeconomic conditions present ongoing challenges, the Group's diversified manufacturing footprint, strong brand development momentum and leadership in sustainable data-center-ready energy storage technology position the Group well to navigate these uncertainties. Having committed to achieving Net Zero carbon emissions in Scopes 1 and 2 by 2050 – with interim reduction targets of 20% by 2030 and 60% by 2040 – the Group remains confident in delivering long-term value to shareholders through sustainability, improved profitability, and continued expansion of its premium brand portfolio.

CORPORATE GOVERNANCE REPORT

企業管治報告

A. 企業管治原則及實踐

金山科技工業有限公司(「金山科技」或「本公司」,連同其附屬公司統稱為「本集團」)董事局(「董事局」或「董事」)堅信良好的企業管治有助於創造長期價值,是本集團誠信的關鍵,對本集團的長期持續經營及表現至關重要,因此矢志實踐最高標準的企業管治。董事局已實施全面的企業管治政策及程序,以確保整個集團有更高的企業透明度、問責性、表現及誠信,並保障及提升金山科技股東(「股東」)的價值。

本公司一直參考市場趨勢以及監管機構頒佈的指引和要求,不斷檢討和優化我們的企業管治架構,務求在各方面均達到卓越的管治水平,並與國際和本地企業管治的最佳常規保持一致。

本企業管治報告(「企業管治報告」)載列本集團於截至2026年3月31日止財政年度(「2026財政年度」)內所實行的企業管治架構及常規,以及遵守守則條文的原則及規定,並採納香港聯合交易所有限公司(「聯交所」或「港交所」)證券上市規則(「上市規則」)附錄C1所載企業管治守則(「企業管治守則」)所建議的最佳常規(如適用)。

本公司已在所有重大方面遵守企業管治守則所載的原則及條文,惟偏離企業管治守則第二部份守則條文第C.2.1條除外,該條文規定主席及行政總裁的角色應有區分,不應由同一人擔任。偏離守則條文第C.2.1條的詳情,包括本公司的立場、經考慮的理由及解釋,載於本企業管治報告第77頁「董事局主席兼總裁」一節。

於2026財政年度,本公司已遵守部分自2025年7月1日起生效的經修訂企業管治守則規定,包括:(1)並無獨立非執行董事同時擔任超過六家香港上市發行人的董事職務;及(2)提名委員會每年檢討董事局多元化政策。本公司定期更新各董事局委員會的職權範圍,並持續推進相關工作,以確保本公司已準備就緒,遵守所有其餘新增或經修訂的規定。

A. CORPORATE GOVERNANCE PRINCIPLES AND PRACTICE

The board of directors (the “Board” or the “Directors”) of Gold Peak Technology Group Limited (“Gold Peak” or the “Company” and together with its subsidiaries, the “Group”) aspires to the highest standards of corporate governance as the Board firmly believes that good corporate governance supports long-term value creation and is key to the integrity of the Group and essential to the long-term sustainability of the Group’s operations and performance. The Board has implemented comprehensive corporate governance policies and procedures to ensure greater corporate transparency, accountability, performance and integrity across the Group and to protect and enhance value of Gold Peak’s shareholders (the “Shareholders”).

The Company has been constantly reviewing and enhancing our corporate governance framework by referring to market trends as well as guidelines and requirements issued by regulatory authorities and aims to achieve governance excellence in all respects and to be in line with international and local corporate governance best practices.

This Corporate Governance Report (“CG Report”) sets out the Gold Peak’s corporate governance framework and practices that were in place throughout the financial year ended 31 March 2026 (“FY2026”) and adherence to the principles and provisions of the code provisions, and adopted the recommended best practices, where appropriate, set out in the Corporate Governance Code (the “CG Code”) contained in Appendix C1 to The Rules Governing the Listing of Securities (the “Listing Rules”) on The Stock Exchange of Hong Kong Limited (the “Stock Exchange” or “HKEX”).

The Company has complied, in all material aspects, with the principles and provisions set out in the CG Code, except for the deviations from code provision C.2.1 of Part 2 of the CG Code, which provides that the roles of the chairman and the chief executive should be separate and should not be performed by the same individual. The details of the deviation from code provision C.2.1, including the Company’s position, considered reasons and explanations, are set out in the section headed “Board Chairman and Chief Executive” on page 77 of this CG Report.

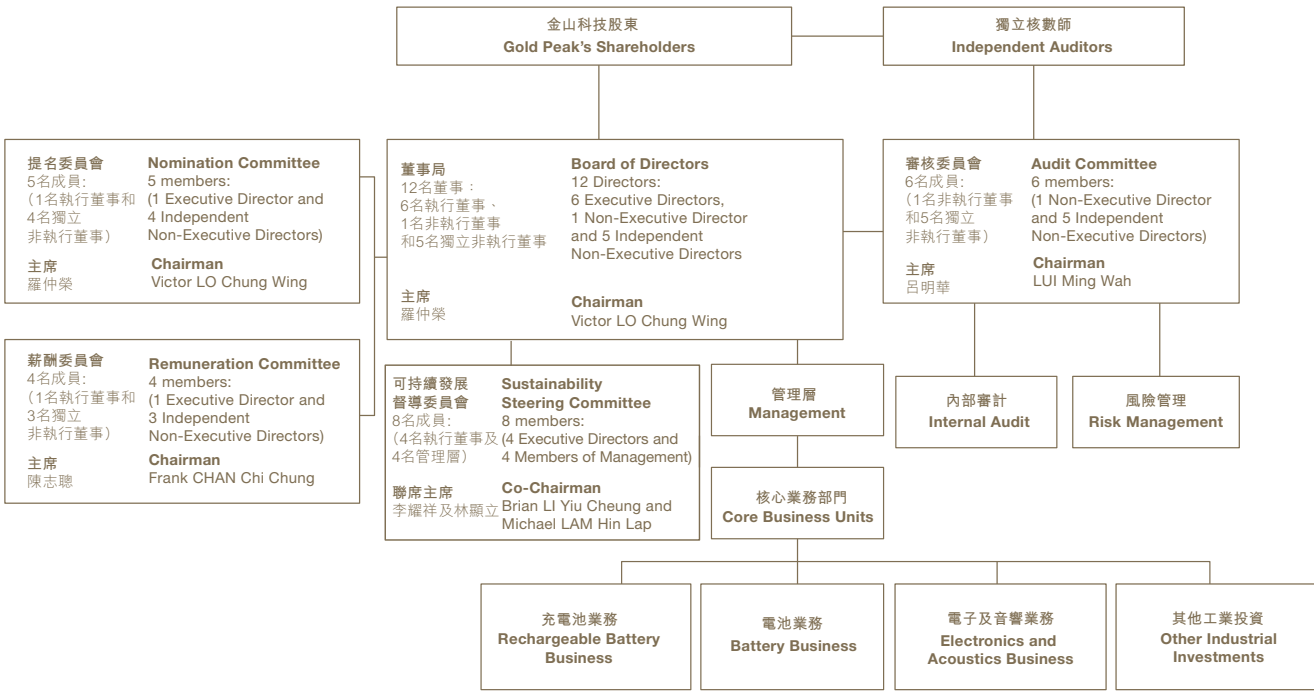
During FY2026, the Company has complied with some of the revised CG Code requirements effective 1 July 2025, including requirements where (1) no Independent Non-executive Director (“INED”) shall concurrently hold directorships in more than six Hong Kong-listed issuers; and (2) the Nomination Committee shall conduct an annual review of the Board Diversity Policy. The Company updates the terms of reference of its Board Committees in a regular manner and continuously works to ensure that the Company will be ready to comply with all remaining new or updated requirements.

The Group promotes its corporate culture in alignment with its core values and vision, which enables the Group to implement its long-term strategies and create sustainable value for its Shareholders and other stakeholders.

B. 董事局

董事局組成

董事局(「董事局」或「董事」)的主要重點是本集團的整體策略發展。董事局亦會監督本集團業務營運的財務表現及內部監控。

- (v) 執行董事梁玄博先生獲委任為副總裁，由2026年4月1日起生效。

由於陳其鑣先生於2025年8月18日辭世，本公司未能符合《上市規則》第3.10A條所規定之獨立非執行董事最低人數要求。有關不合規情況已於2025年10月1日獲本公司糾正，當時本公司物色到合適人選，並隨後委任嚴教授為獨立非執行董事。有關詳情，請參閱本公司分別於2025年8月20日及2025年9月17日刊發的公佈。

B. BOARD OF DIRECTORS

Board Composition

The principal focus of the board of directors (the “Board” or the “Directors”) is on the overall strategic development of the Group. The Board also monitors the financial performance and the internal controls of the Group’s business operations.

The Board currently has 12 members, comprising six Executive Directors (“EDs”) (one of whom is the Board Chairman), one Non-Executive Director (“NED”) and five Independent Non-Executive Directors (“INEDs”). The profile of each Director which includes key information regarding academic qualifications, directorships and chairmanships held in other listed companies, and other principal commitments, is set out on pages 39 to 52 of AR2026.

The following are the changes to the composition of the Board and its Board Committees (except for SSC) during the period from 1 April 2025 to the date of the AR 2026:

- (i) Mr CHAN Kei Bui, an INED, a member of each of the AC, the NC and the RC passed away on 18 August 2025;
- (ii) Prof Timothy TONG Wai Cheung, an INED and a member of the AC, was appointed as a member of RC with effect from 1 October 2025;
- (iii) Prof Eric YIM Chi Ming (“Prof Yim”) was appointed as an INED and a member of the AC and the NC with effect from 1 October 2025;
- (iv) Prof Miranda LOU Lai Wah (“Prof Lou”) was appointed as an INED, a member of the AC and the NC with effect from 1 November 2025; and
- (v) Mr Joseph LEUNG was appointed as the Deputy Chief Executive with effect from 1 April 2026.

In relation to the passing of Mr CHAN Kei Bui on 18 August 2025, the Company did not meet the minimum number of independent non-executive directors required under Rule 3.10A of the Listing Rules. Such non-compliance has been rectified by the Company on 1 October 2025, upon the identification of a suitable candidate and subsequent appointment of Prof YIM. Please refer to the announcements published by the Company on 20 August 2025 and 17 September 2025 respectively for further details.

董事局及董事局委員會定期召開會議，董事局會議每年至少舉行四次。2026年度共召開了四次董事局。在董事局例會上，董事局議程包括管理層就本集團的策略舉措和實施情況提供最新情況、關於本集團最新投資和發展的更新情況，以及對本集團財務和運營業績的審查。

2026年度四次董事局會議的重點如下：

- (i) 安排了兩次會議，以審閱及批准本集團截至2025年9月30日止半年度及2026財政年度的財務業績；和
- (ii) 安排了兩次會議，以審查本集團的季度經營業績，以及審查本公司的策略方向和舉措。

本公司的組織章程細則允許其董事局和董事局委員會的會議通過電話會議和視頻會議舉行。董事局及董事局委員會亦可透過傳閱書面決議案作出決定。

本公司向無法出席董事局或董事局委員會任何會議的董事提供會議材料，並鼓勵其與董事局主席或各董事局委員會主席或管理層提出討論要點或疑問。董事局認為，每位董事的貢獻不應只集中於其出席董事局及／或董事局委員會的會議。董事的貢獻應超越該等會議的正式環境範圍，透過分享觀點、建議、經驗及策略，以促進本公司的利益。董事們，無論是個別或共同，也與管理層、本集團業務單位和部門的負責人以及本集團的外部顧問接觸，以更好地了解本集團面臨的挑戰，並通過這些參與，為管理層提供寶貴的視角。

儘管董事局可能及已將其部分責任及職能轉授予董事局委員會及主要部門，但董事局表明其最終仍對本公司的表現及事務負責。

The Board and Board Committees conduct meetings regularly, with the Board meetings held at least four times a year. A total of four Board meetings were held in FY2026. At the regular Board meetings, the Board agenda includes updates by Management on the Group's strategic initiatives and implementation status, updates on the Group's latest investments and developments, and the review of the Group's financial and operational performance.

The focus of the four Board meetings in FY2026 was set out as follows:

- (i) two meetings were scheduled to review and approve the Group's financial results for half-year ended 30 September 2025 and FY2026; and
- (ii) two meetings were scheduled to review the Group's quarterly operational performance, as well as review the Company's strategic directions and initiatives.

The Company's Articles of Association allow for the meetings of its Board and the Board Committees to be held via teleconferencing and video-conferencing. The Board and the Board Committees may also make decisions by way of circulating written resolutions.

Directors who are unable to attend any meetings of the Board or the Board Committees, are provided with the meeting materials, and are encouraged to raise discussion points or queries with the Board Chairman or respective Board Committee Chairmen or Management. The Board is of the view that the contributions of each Director should not be focused solely on his/her attendance at meetings of the Board and/or the Board Committees. A Director's contributions should also extend beyond the confines of the formal environment of such meetings, through the sharing of views, advice, experience and strategic networks which would further the interests of the Company. The Directors, whether individually or collectively, also engage with Management, heads of the Group's business units and departments and the Group's external consultants in order to better understand the challenges faced by the Group and the input of the Directors, through such engagements, provide invaluable perspective to Management.

Although the Board may and has delegated some of its responsibilities and functions to the Board Committees and principal divisions, it acknowledges that it remains ultimately accountable for the performance and affairs of the Company.

管理層有責任及時向董事局和董事局委員會提供足夠的資訊，使其能夠做出明智的決定。提供的資訊必須完整可靠。為妥善履行其職責，董事未必在所有情況下都能夠純粹依賴管理層自願提供的資料，他們可能需要作進一步查詢。如果任何董事需要的資訊超出管理層自願提供的資訊，則該董事應在必要時進行進一步查詢。因此，董事局及個別董事應可獨立接觸本公司的高級管理層。

所有董事均有權查閱董事局文件及相關資料。這些文件和相關材料的形式和品質應足以使董事局能夠就提交其面前的事項做出明智的決定。在可能情況下，董事提出的查詢應得到及時和全面的回復。

董事局及董事局委員會會議記錄由公司秘書保存，應足夠詳細地記錄所考慮的事項及所達致的決定，包括董事提出的任何關注事項或表達的反對意見。會議記錄的初稿及最終定稿應在董事局會議舉行後的合理時間內送交全體董事，分別供其發表意見及作記錄。會議記錄可在任何合理時間公開讓任何董事在合理通知下查閱。

每名董事局成員均有權獲得公司秘書的意見和服務，並在合理要求及適當情況下尋求獨立專業意見，以協助他們履行對董事局的職責，費用由本公司承擔。

於回顧年度內，董事局成員之間並無任何關連（包括財務、業務、家庭關係及其他重大／關連關係）。

董事局的角色與職責

董事局的主要職能是領導和控制本公司。董事共同負責指導和監督本公司的事務。董事的其他職責包括但不限於維持對本公司的有效控制、給予本公司特定的策略方向、檢討、批准及監督基本財務及業務策略、計劃及主要企業行動、確保本公司遵守相關法律、法規及商業守則、以透明及迅速的方式與股東及相關持份者溝通，以及監督本公司的整體企業管治功能。

Management has an obligation to supply the Board and Board Committees with adequate information, in a timely manner, to enable it to make informed decisions. The information supplied must be complete and reliable. To properly fulfil their duties, Directors may not, in all circumstances, be able to rely purely on information voluntarily provided by Management, and they may need to make further enquiries. Where any Director requires more information than is volunteered by Management, that Director should make further enquiries where necessary. Accordingly, the Board and individual Directors should have separate and independent access to the Company's Senior Management.

All Directors are entitled to have access to Board papers and related materials. These papers and related materials should be in a form and quality sufficient to enable the Board to make informed decisions on matters placed before it. Queries raised by Directors should receive a prompt and full response, if possible.

Minutes of Board and Board Committee meetings, which are kept by the Company Secretary, should record in sufficient detail the matters considered and decisions reached, including any concerns raised by Directors or dissenting views expressed. Draft and final versions of minutes should be sent to all Directors for their comments and records respectively, within a reasonable time after the Board meeting is held. The minutes are open for inspection at any reasonable time on reasonable notice by any Director.

Each Board member is entitled to have access to the advice and services of the Company Secretary and, upon reasonable request and in appropriate circumstances, seek independent professional advice at the Company's expense, to assist them in performing their duties to the Board.

None of the members of the Board have any connections (including financial, business, family relationships and other material/related relationships) with each other during the year under review.

Board's Role and Responsibilities

The Board's primary function is to assume responsibility for leadership and control of the Company. The Directors are collectively responsible for directing and supervising the Company's affairs. Other duties of the Directors include but not limited to maintaining effective control of the Company, giving specific strategic direction to the Company, reviewing, approving and monitoring the fundamental financial and business strategies, plans and major corporate actions, ensuring that the Company complies with the relevant laws, regulations and codes of business practice, ensuring that the Company communicates with Shareholders and the relevant stakeholders transparently and promptly, and monitoring the overall corporate governance functions of the Company.

根據所有適用法律及上市規則，所有董事均須遵守相同的法律責任。他們在履行董事職責時，必須誠實和真誠地以本公司的整體利益為依歸，避免實際和潛在的利益和職責衝突，以合理的謹慎和勤勉行事，並客觀地做出符合本公司最佳利益的決策。董事局包含與本集團業務要求相稱的技能、經驗和多元化觀點的平衡。董事局由執行董事及非執行董事(包括獨立非執行董事)均衡組成，因此董事局具有強大的獨立元素，可有效行使獨立判斷。董事局設有董事局常規，因此董事局組成的任何變動(如有)均可在不受過度干擾的情況下進行管理。

本集團的企業管治職能由董事局共同履行。董事局確認共同監督本集團的企業管治職能，並同意遵守特定的書面職權範圍。於回顧年度內，董事局已檢討及監察以下企業管治職能：

- 本公司有關企業管治的政策及常規，並提出建議；
- 董事及高級管理人員的培訓及持續專業發展(「持續專業發展」)；
- 本公司有關遵守法律及監管規定的政策及常規；
- 適用於本公司僱員及董事的行為守則；及
- 本公司遵守企業管治守則的情況及於本企業管治報告內的披露。

董事局監督本公司及本集團的業務事務和表現，並負責制定本集團的策略方向、表現和業務營運。董事局透過與管理階層共同制定本公司的目的和目標，提供領導和整體指導，透過價值創造、創新和可持續發展，實現本集團的長期成功。

All Directors are subject to the same legal duties under all applicable laws and the Listing Rules. They are required, in the performance of their duties as Directors, to act honestly and in good faith in the interests of the Company as a whole, avoid actual and potential conflicts of interest and duty, apply reasonable care and diligence, and make decisions objectively in the best interests of the Company. The Board contains a balance of skills, experience and diversity of perspectives appropriate to the requirements of the Group's business. The Board includes a balanced composition of EDs and NEDs (including INEDs) so that there is a strong independent element on the Board, which can effectively exercise independent judgement. Board practice is in place so that any changes to the Board composition (if any) can be managed without undue disruption.

The corporate governance function of the Group is collectively performed by the Board. The Board acknowledges collective oversight of the corporate governance function of the Group and has confirmed compliance with a specific written terms of reference. During the year under review, the Board has reviewed and monitored the following corporate governance functions:

- the Company's policies and practices on corporate governance and made recommendations;
- the training and continuous professional development ("CPD") of Directors and Senior Management;
- the Company's policies and practices on compliance with legal and regulatory requirements;
- the code of conduct applicable to employees of the Company and Directors; and
- the Company's compliance with the CG Code and disclosure in this CG Report.

The Board oversees the business affairs and performance of the Company and the Group, and is responsible for shaping the strategic direction, performance and business operations of the Group. It provides leadership and overall guidance by setting goals and objectives of the Company together with Management to achieve long-term success for the Group through value creation, innovation and sustainability.

- (ii) 非執行董事不參與業務營運。他們會參與董事局會議，就策略、政策、績效、問責、資源、重要任命及行為標準等議題提出獨立判斷，並就管理層的決策提出建設性的質疑，以及為策略目標及政策的制定做出貢獻。他們可以參與審查管理層在實現策略目標方面的表現，以及執行董事和主要管理層（「主要管理層」）（非董事）的任命、評估和薪酬。非執行董事審查本集團在達成協定企業目標方面的表現，並監察績效報告。當發生潛在利益衝突時，非執行董事局起帶頭作用；
- (iii) 根據本公司組織章程細則第112條，每位董事均須至少每三年於股東周年大會上輪值退任。退任董事符合資格獲重新委任或重選；及
- (iv) 獨立非執行董事屬非執行董事，他們與任何執行董事及主要管理層均無關係，並符合上市規則及企業管治守則所載被視為「獨立」的條件，且被董事局確認為獨立，其職責與非執行董事類似，並額外對董事局及管理層提供獨立客觀的制衡。除上文「董事會組成」一節所披露外，於回顧年度內，本公司已遵守上市規則第3.10(1)及(2)條，以及第3.10A條有關董事局須有足夠數目的獨立及合資格非執行董事的規定。

Board's Role and Responsibilities (continued)

While all Directors are fiduciaries who exercise due diligence and objectively discharge their duties and responsibilities in the best interest of the Company, the Board has Directors of different designations with different roles:

- (i) EDs are members of Management who are involved in the day-to-day running of the business. They work closely with NEDs on the long-term sustainability and success of the businesses. They provide insights and recommendations on the Group's operations at the Board and Board Committee meetings;
- (ii) NEDs do not participate in the business operations. They participate in Board meetings to bring an independent judgement to bear on issues of strategy, policy, performance, accountability, resources, key appointments and standards of conduct and constructively challenge Management on its decisions, and contribute to the development of strategic goals and policies. They may participate in the review of Management's performance in achieving strategic objectives as well as the appointment, assessment and remuneration of the EDs and key management personnel ("KMP") (not being Directors). NEDs scrutinize the Group's performance in achieving agreed corporate goals and objectives, and monitoring performance reporting. NEDs take the lead where potential conflicts of interests arise;
- (iii) According to Article 112 of the Company's Articles of Association, every Director is subject to retirement by rotation at least every three years at the AGM. Retiring Directors are eligible for re-appointment or re-election; and
- (iv) INEDs are NEDs who are unrelated to any of the EDs and KMPs. They fulfill the independence criteria as set out in the Listing Rules and the CG Code, and are confirmed to be independent by the Board. INEDs have similar duties of the NEDs, and additionally provide an independent and objective check on the Board and Management. Save as disclosed in the section headed "Board Composition" above, the Company has complied with Rules 3.10(1) and (2), and 3.10A of the Listing Rules requiring a sufficient number of independent and qualified NEDs in the Board for the year under review.

董事局的角色與職責(續)

除香港公司條例(香港法例第622章)(「公司條例」)規定的法定職責外，董事局的主要職能為：

- (i) 批准本集團的策略計劃、重大投資和撤資建議及融資決定；
- (ii) 檢討本集團的財務表現及主要營運倡議；
- (iii) 確保必要的財務、營運及人力資源到位，以達成公司目標；
- (iv) 確保內部監控及風險管理架構及程序的充足性及有效性，以保障股東利益及本集團資產；
- (v) 審閱審核委員會就本集團內部監控系統、財務及審計相關事宜以及委任／罷免本公司外聘核數師(「外聘核數師」)的適當性及有效性提出的建議；
- (vi) 檢討及決定由提名委員會提出的提名建議；
- (vii) 檢討及通過由薪酬委員會提出的董事局及主要管理層薪酬架構建議；
- (viii) 承擔良好企業管治的責任，在其政策和決策中設定正確的「最高基準」；及
- (ix) 致力於將可持續發展融入本集團業務和營運的主要方面。

Board's Role and Responsibilities (continued)

In addition to statutory responsibilities under Hong Kong Companies Ordinance (Chapter 622 of the laws of Hong Kong) ("Companies Ordinance"), the Board's principal functions are:

- (i) to approve the Group's strategic plans, significant investment and divestment proposals and funding decisions;
- (ii) to review the Group's financial performance and key operational initiatives;
- (iii) to ensure necessary financial, operational and human resources are in place to meet the Company's goals;
- (iv) to ensure the adequacy and effectiveness of the framework and process for internal control and risk management for safeguarding of Shareholders' interests and the Group's assets;
- (v) to review the recommendation by the AC on adequacy and effectiveness of the Group's internal control system, financial and audit related matters and the appointment/removal of the external auditors of the Company ("External Auditors");
- (vi) to review and decide the nominations recommendation by the NC;
- (vii) to review and endorse the recommendation of framework of remuneration for the Board and KMPs by the RC;
- (viii) to assume responsibility for good corporate governance, setting the right 'tone at the top' in its policies and decisions; and
- (ix) to commit for integrating sustainability in key aspects of the Group's business and operations.

董事局程序與效能

董事局應定期召開會議，董事局會議每年至少舉行四次，大約每季舉行一次。董事局主席主要負責與全體董事協商，擬定及批准每次董事局會議的議程。所有定期董事局會議均已向全體董事發出至少14天的通知，如有需要，董事可將討論事項列入議程。

定期董事局會議的議程及隨附的董事局文件均於會議前的合理時間內全數寄發予全體董事。這些文件應及時發送，並至少在董事局或董事局委員會會議的預定日期前3天(或其他協定期限)發送。

董事局迎新、培訓及發展

在委任前，所有新董事均須根據上市規則第3.09D條的規定，接受由具資格就香港法律提供意見的律師事務所提供的法律意見(「法律意見」)。該法律意見涵蓋以下內容：

- 從策略、規劃及管理角度闡述董事的角色，以及企業管治的核心理念及相關趨勢；
- 董事根據一般法律(包括普通法及法例)及上市規則所承擔的一般及特定職責；及
- 向聯交所作出虛假聲明或提供虛假資料可能引致的法律後果。

於2026年度，下列新獲委任的獨立非執行董事已於下述各自日期接受法律意見，並以書面形式了解及確認其作為上市發行人董事所須履行的責任及義務。

Board Process and Effectiveness

The Board should meet regularly, and Board meetings are held at least four times a year at approximately quarterly intervals. The Board Chairman is primarily responsible for drawing up and approving the agenda for each Board meeting in consultation with all Directors. Notice of at least 14 days has been given to all Directors for all regular Board meetings and the Directors can include matters for discussion in the agenda if necessary.

Agenda and accompanying Board papers in respect of regular Board meetings are sent in full to all Directors within reasonable time prior to the meeting. These should be sent in a timely manner and at least three days before the intended date of a Board or Board Committee meeting (or other agreed period).

Board Orientation, Training and Development

Before appointment, all new Directors are required to obtain legal advice (the “Legal Advice”) from a firm of solicitors qualified to advise on Hong Kong law pursuant to Rule 3.09D of the Listing Rules. Such Legal Advice covers:

- the roles of a director from the strategic, planning and management perspectives, as well as the essence of corporate governance and the trends in these areas;
- the general and specific duties of a director under general law (common law and legislation) and the Listing Rules; and
- the possible legal consequences of making a false declaration or giving false information to the HKEX.

During FY2026, the following newly-appointed INEDs received the Legal Advice on the respective dates set out below, and they acknowledged and confirmed in writing their understanding of their obligations as a director of a listed issuer.

董事局迎新、培訓及發展(續)

本公司為新任董事提供迎新計劃，讓他們熟悉本集團的業務及其管治常規。該等迎新計劃包括參觀本集團的主要工廠及與各業務單位的管理層會面。新委任董事局獲告知(其中包括)作為董事局及董事局委員會成員的角色、義務、職責及責任、本集團的主要業務、本公司的管治常規及程序、內部監控及風險管理制度。新董事也應熟悉《公司條例》、《上市規則》以及作為聯交所上市公司董事的角色和責任。如首次出任董事之前並無擔任上市公司董事的經驗，則必須在獲委任日期起計18個月內完成不少於24小時的持續專業培訓課程；如首次出任董事之前三年內曾在聯交所以外的交易所擔任上市公司董事，則必須在獲委任日期起計18個月內完成不少於12小時的持續專業培訓課程，以獲取聯交所上市公司董事應有的相關知識。強制性培訓的重點是就合規、監管及企業管治事宜為公司董事提供全面培訓，於收到法律意見後，首次出任董事的人士應能對聯交所上市公司董事在《公司條例》、《上市規則》及《企業管治守則》規定下的角色及職責有廣泛的了解。

嚴教授為在新加坡交易所上市之GP Industries Limited的董事，並正進行持續專業培訓課程，以於2027年3月或之前完成不少於12小時的持續專業培訓課程。

The Company provides new Directors with orientation programmes to familiarize them with the business of the Group and its governance practices. Such orientation programmes include visiting the Group's principal factories and meeting with the Management of various business units. Newly appointed Directors are informed, among other things, the roles, obligations, duties and responsibilities as a member of the Board and Board Committees, the Group's principal business, the Company's governance practices and process, internal control and risk management system. New Directors are also expected to be familiar with the Companies Ordinance, the Listing Rules and the roles and responsibilities as a director of a HKEX-listed company. A first-time Director with no prior experience as a director of a listed company, must complete no less than 24 hours of CPD sessions within 18 months of the date of their appointment, and a first-time Director who has served as a director of a listed company on an exchange other than HKEX within three years prior to their appointment must complete no less than 12 hours of CPD training within 18 months of the date of their appointment, to acquire relevant knowledge of what is expected of a HKEX-listed company director. Upon receipt of the Legal Advice, which focuses on comprehensive training of company directors on compliance, regulatory and corporate governance matters, should provide the first-time Directors with a broad understanding of the roles and responsibilities of a director of a HKEX-listed company under the requirements of the Companies Ordinance, the Listing Rules and the CG Code.

Prof Yim is a director of GP Industries Limited, which is listed on Singapore Exchange, and is in progress to complete no less than 12 hours of CPD sessions on or before March 2027.

董事局迎新、培訓及發展 (續)

由於盧教授為首次出任董事，且過往並無擔任上市公司董事的經驗，她正進行持續專業培訓課程，以於2027年4月或之前完成不少於24小時的持續專業培訓課程。

董事局認同董事接受持續專業發展培訓／進修的重要性。本公司的專業顧問、核數師、管理層及公司秘書(「公司秘書」)會定期向全體董事提供本集團經營環境的最新發展，尤其是相關的新法律法規及不斷變化的業務風險、企業管治常規、環境、社會及管治／可持續發展、風險管理及與本公司及／或董事相關的財務報告準則。

於本年度，審核委員會成員亦定期聽取外聘核數師德勤•關黃陳方會計師行(「德勤」)有關適用會計準則的簡報。外聘核數師在向審核委員會提交年度審核計劃時，也會強調相關財務報告準則的重要變更。此外，擁有專業資格的董事也會根據相關專業團體的持續專業發展或教育要求參加培訓。提名委員會和董事局會獲告知董事於年內參加的培訓課程。作為提名委員會對董事局及董事局委員會的技能組合進行年度評估的一部分，提名委員會亦會在有需要時建議董事在特定範疇接受進一步培訓，以補充不時向董事提供的定期更新／簡報。於本年度，當時的提名委員會並無建議任何此類培訓。

除培訓課程／計劃及更新簡報外，董事如需有關本公司營運的任何進一步資料或澄清，亦可隨時聯絡管理層。

As Prof Lou is a first-time Director who has no prior experience as a director of a listed company, she is in progress to complete no less than 24 hours of CPD sessions on or before April 2027.

The Board recognizes that it is important for Directors to undergo CPD training/development. All Directors are routinely provided with updates on developments in the Group's operating environment, particularly on relevant new laws and regulations and changing business risks, corporate governance practices, ESG/sustainability, risk management and financial reporting standards which are relevant to the Company and/or the Directors by professional advisors, auditors, Management and the company secretary of the Company ("Company Secretary").

Members of the AC were also provided with regular briefings from the External Auditors, Deloitte Touche Tohmatsu ("Deloitte") on applicable Accounting Standards during the year. The External Auditors, in presenting its annual audit plan to the AC, also highlights the important changes in relevant financial reporting standards. In addition, Directors who have professional qualifications also attend trainings in accordance with the CPD or education requirements of the relevant professional bodies. The NC and the Board are kept informed of the training sessions attended by the Directors during the year. As part of the NC's annual assessment of the skill set of the Board and the Board Committees, the NC would also recommend further training for the Directors in specific areas, if required, to supplement the regular updates/briefings provided to the Directors from time to time. No such training was recommended by the then NC during the year.

Further to the training courses/programmes and briefing updates, Directors are also at liberty to approach Management should they require any further information or clarification concerning the Company's operations.

保留予董事局批准主要事項

特別留待董事局批准的主要事項包括：

- (i) 就本集團的策略方向、計劃和績效目標做出決定；
- (ii) 本集團對不同類別風險的風險偏好和承受能力，以及重大風險管理的風險策略和政策；
- (iii) 財務業績公佈、年報及經審核財務報表；
- (iv) 本集團的財務目標及年度預算；
- (v) 超出一定重大限額的重大投資或收購／出售建議；
- (vi) 股票發行；
- (vii) 企業和財務重組；
- (viii) 股息政策和支付；
- (ix) 董事局和主要管理層繼任計劃以及董事的提名／任命；
- (x) 整體可持續發展及氣候相關策略，包括重要議題及對本集團環境、社會及管治承諾及策略的進展及表現的檢討；以及
- (xi) 超出特定限制的關連交易。

管理層已充分了解需要董事局或董事局委員會批准的事項。為了提高運營效率，公司還制定了一個結構化的審批限額矩陣，其中規定了授予各級管理層的授權，以批准不超過預定限額的運營支出。

Key Matters Reserved to the Board's Approval

Key matters which are specifically reserved for approval by the Board include the following matters:

- (i) Decisions over the strategic direction, plans and performance objectives of the Group;
- (ii) The Group's risk appetite and risk tolerance for different categories of risk, as well as risk strategy and policies for material risk management;
- (iii) Financial results announcements, annual reports and audited financial statements;
- (iv) The Group's financial objectives and annual budget;
- (v) Major investment or acquisition/disposal proposals, exceeding certain material limits;
- (vi) Shares issuance;
- (vii) Corporate and financial restructuring;
- (viii) Dividend policy and payouts;
- (ix) Board and KMPs succession plans and nomination/appointment of Directors;
- (x) Overall sustainability and climate-related strategies, including material topics and reviews of the progress and performance of the Group's ESG commitments and strategy; and
- (xi) Connected Transactions exceeding certain limits.

Management is fully apprised of such matters which require the approval of the Board or the Board Committees. For operational efficiency, the Company also has a structured approval limits matrix which sets out the delegated authority to various levels of Management to approve operating expenditures up to pre-determined limits.

利益衝突

董事局本著誠信和本公司的最佳利益行事，以應有的謹慎、技能和勤勉盡責的態度行事，並避免利益衝突。董事以任何方式直接或間接於交易或建議交易中有利害關係，應根據公司條例和本公司組織章程細則聲明其利益的性質，並且在出現任何利益衝突(實際或潛在)的情況下，迴避參與審議並放棄對此類交易的決策，並在董事局及／或董事局委員會的會議記錄及／或決議中妥為記錄該等棄權。

如果董事局認為有利益衝突的董事參與為提高此類討論的有效性是必要的，並且允許其參與，則有利益衝突的董事需在討論過程中在適當時間內避席，以促進其他董事進行全面和坦誠的交流，並在任何情況下應迴避決策並放棄與利益衝突相關事項相關的表決。

倘若主要股東或董事在董事局考慮的事項上存在利益衝突，而董事局認為該事項為重大事項，則該事項應以董事局實體會議而非書面決議案處理。獨立非執行董事及密切關連人士如在交易中並無重大利益，應出席該董事局會議。

每名董事亦須每年提交其關連人士的詳情，以監察關連交易及關連人士交易。

Conflict of Interests

The Board acts in good faith and in the best interests of the Company by exercising due care, skills and diligence, and avoiding conflicts of interest. Directors, who are in any way, directly or indirectly, interested in a transaction or proposed transaction, declare the nature of their interests in accordance with the Companies Ordinance and the Company's Articles of Association, and in the case of any conflict of interest (actual or potential), recuse themselves from participating in the deliberation and abstain from decision making on such transactions, with abstention duly recorded within the minutes and/or the resolutions of the Board and/or the Board Committees.

In case the Board is of the opinion that the conflicted Director participation is necessary to enhance the efficacy of such discussion and his/her participation is permitted, the conflicted Director excuses himself/herself for an appropriate period during the discussions to facilitate full and frank exchange by the other Directors, and shall in any event recuse himself/herself from the decision making and to abstain from voting in relation to the conflict-related matters.

If a substantial shareholder or a Director has a conflict of interest in a matter to be considered by the Board which the Board has determined to be material, the matter should be dealt with by a physical Board meeting rather than a written resolution. INEDs who, and whose close associates, have no material interest in the transaction should be present at that Board meeting.

Each Director is also required to submit details of his/her associates for the purpose of monitoring connected transactions and related parties transactions ("RPTs") annually.

公司秘書

公司秘書是董事局在企業管治及其他監管合規事宜方面的主要顧問，並透過確保董事局內部的良好資訊流通及董事局政策及程序得到遵守，在支持董事局方面發揮重要作用。公司秘書的任何選擇、委任或罷免均須經董事局批准。公司秘書負責通過董事局主席就管治事宜向董事局提供建議，並促進董事的就職和專業發展。公司秘書向董事局主席彙報，所有董事均可獲得公司秘書的建議和服務，以確保董事局程序及所有適用的法律、規則及規例得到遵守。公司秘書應為本集團的僱員，並具備對本集團事務的日常知識。公司秘書的主要職責包括但不限於以下內容：

- 協助本公司制定及維持健全及有效的企業管治框架，以確保合規及良好的企業管治常規；
- 緊貼可能影響本集團業務及營運的法律、規則及法規的發展，並向董事局彙報該等發展；
- 確保董事局成員接受有關本集團業務發展及任何適用法律及法規的持續專業培訓；和
- 在決策過程中向董事局提供合規建議，並確保完全合規。

公司秘書梁志豐先生於回顧年度內已遵守上市規則第3.29條的規定，接受不少於15小時的相關專業培訓。

Company Secretary

Company Secretary is the key adviser to the Board on corporate governance and other regulatory compliance matters, and plays an important role in supporting the Board by ensuring good information flow within the Board and that Board policies and procedures are followed. Any selection, appointment or dismissal of the Company Secretary would be approved by the Board. The Company Secretary is responsible for advising the Board through the Board Chairman on governance matters and facilitating induction and professional development of Directors. The Company Secretary reports to the Board Chairman and all Directors have access to the advice and services of the Company Secretary to ensure that board procedures, and all applicable law, rules and regulations, are followed. The Company Secretary should be an employee of the Group and have day-to-day knowledge of the Group's affairs. The principal responsibilities of the Company Secretary include, but are not limited to, the following:

- assisting the Company develop and maintain a sound and effective corporate governance framework to ensure compliance and good corporate governance practices;
- keeping abreast of the developments in laws, rules and regulations that may affect the Group's business and operations, and briefing the Board on these developments;
- ensuring that the Board members receive CPD in relation to the Group's business developments and any applicable laws and regulations; and
- providing compliance advice to the Board in the decision-making process, and ensuring full compliance.

Mr LEUNG Chi Fung, the Company Secretary, has complied with Rule 3.29 of the Listing Rules by obtaining no less than 15 hours of relevant professional training during the year under review.

本公司目前採用單一的領導結構：羅仲榮先生是本公司董事局主席及行政總裁。董事局主席及行政總裁仍參與重大公司事務，包括集團的整體運營、策略性質事務和董事局管治。

Board Chairman and Chief Executive

Currently, the Company adopts a single leadership structure: Mr Victor LO is the Board Chairman and CEO of the Company. The Board Chairman and CEO remains involved in significant corporate matters, including overall operations of the Group, matters of strategic nature and governance of the Board.

作為董事局主席，羅仲榮先生是本公司領導董事局的最高級管理人員。他每年至少與非執行董事(包括獨立非執行董事)在沒有其他執行董事在場下舉行一次年度會議。他通過促進非執行董事的有效貢獻並確保執行董事和非執行董事之間的建設性關係，促進開放和辯論的文化。

As the Board Chairman, Mr Victor LO is the most senior executive in the Company to provide leadership to the Board. He holds at least one annual meeting with NEDs (including INEDs) without the presence of other EDs. He promotes a culture of openness and debate by facilitating the effective contribution of NEDs in particular and ensuring constructive relations between EDs and NEDs.

As the CEO, Mr Victor LO leads the members of the Executive Committee ("ExCo"), which comprises the EDs and Management, and is responsible for the Group's overall management, including overseeing the Group's operation, setting directions for new growth areas and developing business strategies. He plays an instrumental role in developing the business of the Group and has been providing the Group with strong leadership and vision.

偏離企業管治守則第二部守則條文C.2.1

本公司目前的單一領導結構偏離企業管治守則第二部分的守則規定C.2.1，該規定規定董事局主席和行政總裁為不同的人士，以確保適當的權力平衡、增強問責制和更大的董事局獨立決策能力。

董事局認為，由於本集團的主要業務由不同的董事局經營，因此目前的架構不會損害董事局與本集團管理層之間的權力平衡。董事局亦考慮了羅仲榮先生擔任董事局主席兼行政總裁的角色，以及他憑藉自己的地位和經驗為該職位帶來的優勢。本公司認為，將董事局主席和行政總裁的角色結合起來，可以帶來卓越的領導能力、明確的責任感和卓越的知識深度，以應對本集團的策略挑戰和發展機會。在考慮本集團業務的性質和規模後，現有的單一領導安排對本集團來說是有有效和適當的，並且有足夠的保障措施來防止權力和權限不均勻地集中在一個人身上。董事局認為，單一個人能夠有效地履行這兩個職位的職責。董事局及董事局委員會擁有足夠的獨立代表，為本集團及策略層面的決策提供多元化的思想和獨立客觀的元素。

此外，如本企業管治報告中「保留予董事局批准主要事項」一節所述，本公司已採納內部指引，列明特別保留予董事局決定及批准的事項，包括(a)提名／委任董事；及(b)重大投資或收購／出售建議。

因此，雖然本公司的董事局主席及行政總裁是同一人，但董事局認為，根據企業管治守則的意圖，本公司目前所採取的管治守則及其對本集團業務事務進行客觀判斷方面具有足夠的獨立性。其中沒有一個人擁有不受約束的決策權，儘管董事局主席及行政總裁的角色不是分開的。董事局在提名委員會的協助下，持續審查董事局主席及行政總裁的角色以及董事局的組成(包括獨立性)，以確保不會妨礙決策中的獨立性和客觀性原則。

自2026年4月1日起，董事局委任執行董事梁玄博先生為副行政總裁，從而進一步強化了本集團的行政管理制衡，並在現有的單一領導結構內加強制衡。彼協助行政總裁制定戰略規劃及進行本集團的整體管理，同時強化了繼任規劃及領導層支援，並維持董事局主席兼行政總裁所制定的戰略方向。

Deviation from code provision C.2.1 of Part 2 of the CG Code

The current single leadership structure of the Company deviates from code provision C.2.1 of Part 2 of the CG Code which stipulates that the Board Chairman and CEO to be separate persons to ensure an appropriate balance of power, increased accountability, and greater capacity of the Board for independent decision making.

The Board considers that the present structure will not impair the balance of power and authority between the Board and the Management of the Group as the Group's principal businesses are run by different boards of directors. The Board has also considered Mr Victor LO's roles as Board Chairman and CEO and the strengths he brings to such a role by virtue of his stature and experience. The Company is of the view that combining the roles of Board Chairman and CEO brings about exceptional leadership and clear accountability and unequalled depth of knowledge to deal with the Group's strategic challenges and growth opportunities. The existing single leadership arrangement is effective and appropriate for the Group after taking into consideration the nature and scale of the Group's businesses, and there are sufficient safeguards against an uneven concentration of power and authority in a single individual. The Board is satisfied that one person is able to effectively discharge the duties of both positions. There is sufficient independent representation on the Board and Board Committees which provide diversity of thought and an independent and objective element to the Group and strategic level decision making.

Furthermore, as discussed under the section headed "Key Matters Reserved to Board's Approval" of this CG Report, the Company has adopted internal guidelines setting forth matters that are specifically reserved for the Board's decision and approval, including (a) nomination/appointment of Directors; and (b) major investment or acquisition/disposal proposals.

As such, whilst the Board Chairman and CEO of the Company is the same person, the Board is of the view that the governance practices currently in place by the Company and there is sufficient independence in its exercise of objective judgment on business affairs of the Group, in compliance with the intent of the CG Code, in which no one individual has unfettered powers of decision-making, notwithstanding that the roles of Board Chairman and CEO are not separate. The Board, with the assistance of the NC, continues to review the roles of the Board Chairman and CEO as well as the composition (including the independence) of the Board to ensure that it does not impede the principles of independence and objectivity in decision making.

With effect from 1 April 2026, the Board appointed Mr Joseph LEUNG, an ED, as the Deputy CEO, thereby further strengthening the Group's executive management framework and enhancing checks and balances within the existing single leadership structure. He assists the CEO in strategic planning and overall management of the Group, reinforcing succession planning and leadership support while preserving the strategic direction set by the Board Chairman and CEO.

多個董事局代表和時間承諾

每名董事均須在知悉其董事局代表相關事實後，在切實可行的範圍內儘快申報，並每年向提名委員會確認其是否在同時履行不同董事局代表承諾的時間有任何問題，以影響其提供足夠時間及精力履行其作為本公司董事的職責的能力。在考慮提名董事重選時，提名委員會會考慮擁有多個上市公司董事局代表及／或其他主要責任的董事所面對的同時履行承諾的時間。提名委員會每年都會對董事所擔任的董事職位(包括各集團的董事職位及行政人員委任)進行檢討。

根據分析、董事的年度確認以及董事對本公司的承諾和貢獻，這也體現在他們出席和參與2026財政年度董事局和董事局委員會會議的程度，提名委員會認為所有董事都能夠履行並一直充分履行其作為本公司董事的職責，以及為本公司的事務提供足夠的時間和精力。

新《上市規則》第3.12A條將適用於2025年7月1日或之後開始的財政年度的企業管治報告及年報，規定獨立非執行董事不得同時擔任超過六家香港上市公司的董事職務(「超額兼任獨立非執行董事」)。作為過渡安排，截至2028年6月30日的超額兼任獨立非執行董事必須在任何該等香港上市公司於2028年7月1日或之後舉行的最早年度股東周年大會結束前遵守此規定。

提名委員會注意到，包括在本公司擔任的董事職務在內，現時每名董事擔任上市公司董事局代表的人數介乎一至五家，低於新上市規則第3.12A條的規定。

Multiple Board Representations and Time Commitments

Each Director is required to declare his/her board representations as soon as is practicable after the relevant facts have come to his/her knowledge, and confirm annually to the NC as to whether he/she has any issue with competing time commitments which may impact his/her ability to provide sufficient time and attention to his/her duties as a Director of the Company. When considering the re-nomination of Directors for re-election, the NC takes into account the competing time commitments faced by Directors with multiple listed company board representations and/or other principal commitments. An analysis of the directorships (which includes directorships by groups and executive appointments) held by the Directors is reviewed annually by the NC.

Based on the analysis, the Directors' annual confirmation and the Directors' commitments and contributions to the Company, which are also evident in their level of attendance and participation at Board and Board Committee meetings for FY2026, the NC is satisfied that all Directors are able to carry out and have been adequately carrying out their duties as Directors of the Company, as well as sufficient time and attention are given to the affairs of the Company.

The new Rule 3.12A of the Listing Rules, which will apply to CG Reports and annual reports in respect of financial years commencing on or after 1 July 2025, requires an INED must not concurrently hold more than six Hong Kong-listed companies' directorship ("Overboarding INED"). As a transitional arrangement, an Overboarding INED as at 30 June 2028 must comply with this requirement by the conclusion of the earliest AGM held on or after 1 July 2028 by any of these Hong Kong-listed companies.

The NC noted that including the directorship held in the Company, the number of listed company board representations currently held by each of the Directors ranged from one to five in number, which is lower than the requirement of the new Rule 3.12A of the Listing Rules.

完整、充足和及時的信息和獲取信息

管理層準備每月的管理帳目和業務分析，並由行政委員會審查。在每次會議之前，董事局和董事局委員會成員均會收到管理層提交的會議議程和相關文件，其中包含完整、充分和及時的資訊，以便對將在各會議上考慮的問題進行全面審議。行政委員會列席該等會議，而能就討論事項提供額外見解的外聘核數師及專業顧問則按需要獲邀出席有關會議。

管理層每月向董事局提供本集團主要財務資訊摘要。在季度董事局會議上，管理層會向董事局提交本集團財務表現的最新情況，包括分析業績，並披露和解釋比較期間之間的重大差異，以便董事局能夠對本集團的表現、狀況和前景做出平衡和明智的評估。此外，管理層還在需要時向董事局提供更多資訊或臨時報告。通過定期管理會議、分發討論文件和非正式會議(例如通過電信進行討論)，向董事局成員諮詢或了解本集團的最新發展情況。

董事局及董事局委員會可自由要求管理層就其職權範圍內的所有事宜作出進一步澄清及提供資料。

董事獨立性及董事局獨立性水準

於2026年年報日期，董事局由12名成員組成。根據提名委員會的建議及根據上市規則第3.13條的規定及企業管治守則的條文，董事局已確定其中五名為獨立非執行董事，為董事局提供強大而獨立的元素，以作出客觀判斷。尚未就任何董事委任替代董事。

在檢討獨立非執行董事的獨立性時，提名委員會已考慮適用的《上市規則》及《企業管治守則》及其隨附的《實務指引》(統稱「獨立性指引」)。在考慮獨立非執行董事的獨立性時，提名委員會還考慮了以下因素：

- (i) 董事合法或實益持有的本公司股份總數；
- (ii) 其他董事職位；

Complete, Adequate and Timely Information and Access to Information

Management prepares monthly management accounts and business analysis, which are reviewed by the ExCo. Prior to each meeting, members of the Board and the Board Committees are provided with the meeting agenda and the relevant papers submitted by Management, containing complete, adequate and timely information to enable full deliberation on the issues to be considered at the respective meetings. The ExCo is in attendance at such meetings, whilst the External Auditors and professional advisors who can provide additional insight into the matters for discussion are invited as required to attend the relevant meetings.

Management provides the Board with a summary of the Group's key financial information each month. During quarterly Board meetings, Management presents to the Board quarterly updates on the Group's financial performance including an analysis of the same, with material variances between the comparative periods disclosed and explained, to enable the Board to make a balanced and informed assessment of the Group's performance, position and prospect. In addition, Management also provides the Board with further information or ad hoc reports as and when required. Board members are consulted or updated with latest developments of the Group with regular management meetings, circulation of discussion papers and informal meetings such as discussions via tele-communications.

The Board and the Board Committees are free to request for further clarification and information from Management on all matters within their purview.

Directors' Independence and Level of Independence of the Board

As at the date of the AR2026, the Board comprises 12 members. Based on the NC's recommendation and pursuant to requirements under Rule 3.13 of the Listing Rules and provisions of the CG Code, the Board has determined that being comprised of five INEDs provides a strong and independent element on the Board to exercise objective judgement. No alternate Directors have been appointed in respect of any of the Directors.

When reviewing the independence of the INEDs, the NC has considered the applicable Listing Rule and the guidelines for independence set out in provision of the CG Code and its accompanying Practice Guidance (collectively, the "Independence Guidance"). As part of the consideration of the INEDs' independence, the NC has also taken into account the following:

- (i) total number of shares in the Company held legally or beneficially by the Director;
- (ii) other directorships;

提名委員會的每名獨立非執行董事均於提名委員會對其獨立性商議時避席。

All Directors are required to disclose all relationships or appointments which may impair their independence to the Board on a timely basis and complete an annual declaration in the form of a self-assessment questionnaire which sets out the circumstances where a Director is deemed not to be independent, and submit it to the NC for final review. The NC and Company Secretary are responsible for collecting the results and reporting to the Board.

For FY2026, each INED has provided a written confirmation to the Company about his/her independence and, where applicable, the interests of his/her immediate family member(s) (as defined under the Listing Rules). The Nomination Committee has reviewed the said confirmations and assessed the independence of the INEDs and continues to consider each of them to be independent.

As at the date of this CG Report, the Board, through the Nomination Committee, has reviewed the implementation and effectiveness of the below mechanisms to ensure that independent views and input are available to the Board.

董事局定期檢討其架構、人數及組成，以確保其在專業知識、技能及經驗方面取得平衡，以切合本公司業務需要。董事局透過向提名委員會轉授權力，盡其所能確保獲委任加入董事局的董事具備對本集團業務至關重要的技術、業務、財務及管理技能方面的背景、經驗及知識，並確保每位董事通過其獨特貢獻，為董事局帶來獨立及客觀的見解，以便作出平衡及深思熟慮的決策。

Board Membership and Succession

The Board reviews its own structure, size and composition regularly to ensure that it has a balance of expertise, skills and experience appropriate to the needs of the business of the Company. The Board, through the delegation of its authority to the NC, has used its best efforts to ensure that Directors appointed to the Board possess the background, experience and knowledge in technology, business, finance and management skills critical to the Group's business and that each Director, through his/her unique contributions, brings to the Board an independent and objective perspective to enable balanced and well-considered decisions to be made.

The Company has entered into a letter of appointment with each of the NED and the INEDs pursuant to which they are appointed for a specific term of three years subject to retirement by rotation and re-election at the AGM in accordance with the provisions of the Company's Articles of Association.

提名政策載列甄選、委任／重新委任本公司董事之準則及程序。提名委員會至少每年審查一次董事局的組成，並就董事局的變動向董事局提出建議。被提名的候選人將被要求提交必要的資訊，以便董事局評估其是否適合。董事局須確保提名、遴選及委任／再度委任的程序符合上市規則、公司條例及本公司組織章程細則的規定。提名委員會定期檢討提名政策，以確保其有效性。

董事提名

提名委員會每年檢討有關董事的提名，以選舉／重選董事。在考慮提名董事參選／重選時，提名委員會會考慮其獨立性、對董事局效率的貢獻(包括其參與董事局及董事局委員會會議及坦誠程度)以及其投入的時間，尤其是對於身兼多個董事局代表及／或其他主要職務的董事。提名委員會就董事周年提名選舉／重選的建議提交董事局決定，然後提交本公司股東周年大會給股東考慮及批准。

董事的甄選、委任及再度委任

提名委員會負責就董事局任命向董事局提出建議，監察董事局和高級管理層的繼任和領導發展計劃，並對董事承諾，及董事局規模、多元化及獨立性進行年度審查。

董事局繼任計劃

董事局相信，有序的繼任和續任是經過仔細規劃的結果，其中會不斷審查董事局的適當組成。在這方面，董事局已制定正式的機制，以適時更新董事局成員及同步甄選新董事的程序，以便可以借鑒任期較長的董事的經驗，同時利用新任命的董事為董事局商議帶來的新的外部觀點和見解。提名委員會領導有關程序，並就委任新董事及重新提名董事向董事局提出建議。

Nomination Policy

The nomination policy sets out the criteria and procedures for the selection, appointment/re-appointment of Directors of the Company. The NC reviews the composition of the Board at least annually and makes recommendations to the Board on the changes of the Board. Proposed candidate(s) will be asked to submit the necessary information for the Board to assess their suitability. The Board shall ensure that the procedures of nomination, selection and appointment/re-appointment are in compliance with the Listing Rules, the Companies Ordinance and the Company's Articles of Association. The NC reviews the nomination policy on a regular basis so as to ensure its effectiveness.

Nomination of Directors

The NC reviews annually the nomination of the relevant Directors for election/re-election. When considering the nomination of Directors for election/re-election, the NC takes into account their independence, contribution to the effectiveness of the Board (which includes their participation and candour at Board and Board Committee meetings) as well as their time commitment especially for Directors who have multiple board representations and/or other principal commitments. The recommendation of the NC on the annual nomination of the Directors for election/re-election is submitted to the Board for decision and thereafter tabled at the AGM of the Company for consideration and approval by Shareholders.

Selection, Appointment and Re-appointment of Directors

The NC is responsible for making recommendations to the Board on Board appointments, overseeing the Board and Senior Management's succession and leadership development plans, conducting annual review of Directors' commitments, and the size, diversity and independence of the Board.

Board Succession Planning

The Board believes that orderly succession and renewal are achieved as a result of careful planning, where the appropriate composition of the Board is continually under review. In this regard, the Board has put in place a formal process for the timely renewal of Board members and the simultaneous selection of new Directors, so as to leverage the experience of long-serving Directors while tapping into the new external perspectives and insights from more recent appointees for the Board's deliberation. The NC leads such process and makes recommendations to the Board on the appointment of new Directors and re-nomination of Directors.

- (i) 提名委員會每年都會審查董事技能、知識、經驗、背景多樣性(包括性別和年齡)和董事局規模的平衡和組合，這將有助於決策。在這審查中，提名委員會還將考慮本公司的需求、董事局的能力和董事的服務任期分佈。
- (ii) 根據此審查並與管理層協商，提名委員會進一步評估是否缺少擁有任何這些屬性的代表，如缺少，將確定特定任命的角色和理想能力。
- (iii) 提名委員會在所有情況下都將考慮以下客觀標準，這些標準被確定為董事局和董事局委員會有效所必需的：
 - 正直

- (iv) 如果需要，可以使用外部幫助來尋找潛在的候選人。董事和管理層也可以提出集體技能及推薦潛在候選人，以供提名委員會評估。
- (v) 提名委員會與入圍候選人會面，以評估是否適合，並確保候選人了解所需的期望和承諾水準。
- (vi) 提名委員會向董事局提出建議以供批准。

Process for appointment of new Directors

- (i) The NC reviews annually the balance and mix of skills, knowledge, experience, diversity of profiles (including gender and age) and Board size which would facilitate decision-making. In this review, the NC would also take into account the needs of the Company, the competencies of the Board and service tenure spread of the Directors.
- (ii) In light of such review and in consultation with Management, the NC will further assess if there is any inadequate representation in respect of any of those attributes and if so, will determine the role and the desirable competencies for a particular appointment.
- (iii) The NC will in all cases take into consideration the following objective criteria identified as necessary for the Board and Board Committees to be effective:
 - Integrity
 - Independent mindedness
 - Able to commit time and effort to carry out duties and responsibilities effectively
 - Track record of making good decisions
 - Experience in high-performing companies
 - Financial literacy
- (iv) External help may be used to source for potential candidates if need be. Directors and Management may also make collective skills and recommendations on potential candidates for NC's assessment.
- (v) NC meets with the short-listed candidate(s) to assess suitability and to ensure that the candidate(s) is/are aware of the expectations and the level of commitment required.
- (vi) NC makes recommendations to the Board for approval.

重新提名退任董事的程序

根據本公司之組織章程細則，目前不少於三分之一之董事須於每年本公司之股東周年大會上退任，而董事局於上屆股東周年大會後委任之董事之任期僅至下一屆股東周年大會為止。如果符合資格，這些董事可以提交重選連任。

提名委員會參考其同僚對個別董事的表現及其任期的評估結果，檢討每名董事的資格、獨立性、貢獻及表現(例如出席情況、準備情況、參與及坦誠程度)。

提名委員會向董事局提出建議以供批准。

A. 退休和重新提名

根據本公司組織章程細則第112條，李耀祥博士、羅宏澤先生、劉堃先生及唐偉章教授將於截至2027年3月31日止年度之應屆股東周年大會(「2026年股東周年大會」)上輪值退任董事，及符合資格並願意膺選連任。根據本公司組織章程細則第95條，分別於2025年10月1日及2025年11月1日獲委任加入董事局的嚴志明教授及盧麗華教授將填補臨時空缺或作為董事會增補成員任職至2026年股東周年大會，屆時符合資格膺選連任。

提名委員會已審閱上述董事的資格、貢獻及表現，並考慮到近期同僚評估的結果，認為上述董事已對本公司的事務付出足夠的時間及關注，並能有效地履行其董事職責。董事局在提名委員會的推薦下，信納及批准在即將舉行的2026年股東周年大會上重新提名彼等重選。

有關該等董事之詳細資料，載於2026年年報第39至52頁「董事及高級管理層」一節。

本公司沒有任命任何替代董事。

Process for re-nomination of retiring Directors

Pursuant to the Company's Articles of Association, not less than one-third of the Directors for the time being shall retire from office at the Company's AGM every year, and a Director appointed by the Board after the last AGM shall only hold office until the next AGM. If eligible, these Directors may submit themselves for re-election.

The NC reviews each Director's eligibility, independence, contribution and performance (such as attendance, preparedness, participation and candour), with reference to the results of the assessment of the performance of the individual Director by his/her peers and his/her tenure.

The NC makes recommendations to the Board for approval.

A. Retirements and Re-nominations

In accordance with Article 112 of the Company's Articles of Association, Dr Brian LI Yiu Cheung, Mr Waltery LAW Wang Chak, Mr Christopher LAU Kwan and Prof Timothy TONG Wai Cheung shall retire from the Board as Directors by rotation at the forthcoming AGM in year ending 31 March 2027 ("2026 AGM") and, being eligible, they have offered themselves for re-election. In accordance with Article 95 of the Company's Articles of Association, Prof Eric YIM Chi Ming and Prof Miranda LOU Lai Wah, who were appointed to the Board on 1 October 2025 and 1 November 2025, respectively, to either fill a casual vacancy or as an addition to the Board, shall hold office until the 2026 AGM and shall then be eligible for re-election.

The NC has reviewed the abovementioned Directors' eligibilities, contributions and performance, and taking into account the results of the recent peer assessment, are of the view that the Directors have given sufficient time and attention to the affairs of the Company and have been able to discharge their duties as Directors effectively. The Board, at the recommendation of the NC, is satisfied and approved the re-nominations of their re-election, at the upcoming 2026 AGM.

Detailed information on those Directors can be found in the section headed "Directors and Senior Management" on pages 39 to 52 of AR2026.

The Company has not appointed any alternate Director.

B. 確定董事的獨立性

提名委員會的任務是確定董事的獨立性。提名委員會在董事獲委任時確定其獨立性，並根據企業管治守則的相關守則條文，至少每年審查董事的獨立性。有關獨立非執行董事獨立性年度檢討結果的進一步詳情，請參閱本企業管治報告「董事獨立性及董事局獨立性水準」一節。

本公司收到各獨立非執行董事的年度獨立性確認書。提名委員會已審閱該等確認書，並已根據上市規則第3.13條評估各獨立非執行董事的獨立性，認為各獨立非執行董事均為獨立人士。因此董事局採納提名委員會的意見，認為所有獨立非執行董事均為獨立人士。

董事局發展

提名委員會檢討董事的培訓及發展，以確保董事持續獲得適當的發展，以履行其在董事局及董事局委員會(如適用)中的角色。董事局收到最新情況更新及／或簡報，以協助他們妥善履行職責。簡報會由受邀演講者在內部進行，或在外部進行，費用由本公司承擔。

提名委員會亦負責確保沒有聯交所上市公司董事經驗的新任董事接受強制性培訓，以確保新董事知悉其職責及義務，有關詳情載於本企業管治報告「董事局迎新、培訓及發展」一節。

在持續專業發展方面，本公司將為新委任董事提供入職培訓包，包括必要的資料及簡報，並鼓勵董事參加專業發展課程及研討會，以確保他們知悉其於上市規則及其他監管規定下的責任。所有董事均已及將接受持續專業培訓，以發展及更新他們作為上市公司董事的知識及技能。

為遵守自2025年7月1日起生效的最新《上市規則》要求，除上述現有資源外，公司亦已為董事局成員安排有系統的持續專業發展培訓計劃，涵蓋當中包括《上市規則》第3.09G條所載的五個範疇，可按其方便時間參與。鑒於《上市規則》新要求適用於財政年度於2025年7月1日或之後開始的企業管治報告，公司將於下一年度的報告中繼續完善相關披露，按《上市規則》要求提供進一步詳情。

B. Determining Independence of Directors

The NC is tasked to determine the independence of the Directors. The NC determines the independence of a Director when he or she is appointed, and review at least annually the Directors' independence according to the relevant code provisions of the CG Code. Please refer to the section headed "Directors' Independence and Level of Independence of the Board" of this CG Report for further details of the results of the annual review of independence of the INEDs.

The Company has received from each of the INEDs an annual confirmation of his independence. The NC has reviewed such confirmations and assessed the independence of each of the INEDs in accordance with Rule 3.13 of the Listing Rules and considered each of them to be independent. The Board adopted the view of the NC and accordingly considers all the INEDs to be independent.

Board Development

The NC reviews the training and development of the Directors to ensure that Directors receive appropriate development on a continuing basis, to perform their roles on the Board and where applicable, the Board Committees. The Directors are provided with updates and/or briefings to assist them to properly discharge their duties. The briefings are conducted either internally with invited speakers, or externally, at the Company's expense.

The NC is also responsible for ensuring that new Directors with no prior experience as directors of a HKEX-listed company must undergo Mandatory Training to ensure that new Directors are aware of their duties and obligations, and the details of which are set out in the section headed "Board Orientation, Training and Development" in this CG Report.

In respect of CPD, the Company will provide an induction package including necessary information and briefings for newly-appointed Directors and Directors are encouraged to participate in professional development courses and seminars to ensure that they are aware of their responsibilities under the Listing Rules and other regulatory requirements. Ongoing professional training had been and will be offered to all Directors to develop and refresh their knowledge and skills as directors of a listed company.

In order to comply with the new Listing Rules requirements, effective 1 July 2025, in addition to the existing resources mentioned in the above, the Company has arranged a structured CPD training programme covering, inter alia, the five topics set out in Rule 3.09G of the Listing Rules for members of the Board to attend at their convenience. Since the new Listing Rules requirements apply to corporate governance reports in respect of financial years commencing on or after 1 July 2025, the Company will continue to refine the disclosures in next year's report to provide further details as required by the Listing Rules.

When reviewing and assessing the size and composition of the Board and Board Committees and making recommendations to the Board annually including the appointment/re-appointment of Directors, the NC will consider all aspects of diversity based on targets and timelines set for promoting and achieving diversity on the Board to arrive at an optimal balanced composition of the Board. As prescribed under the Diversity Policy, the final decision on the selection of Directors will be based on merits against objective criteria and targets considered by the NC annually and recommended to the Board for approval.

The NC will monitor the implementation of its Diversity Policy and review the Diversity Policy from time to time as appropriate, to ensure its effectiveness. The NC will continue its identification and evaluation of suitable candidates to ensure there is diversity (including gender diversity) on the Board. The NC and the Board agreed that there was no need to set a specific target for ethnicity/nationality so long as the candidates provide distinguishing qualities that complement and expand the skills and experience of the Board as a whole.

Having considered the scope and nature of the Group's operations, the requirements of the businesses and the need to avoid undue disruptions from changes to the composition of the Board and Board Committees, the Board, in concurrence with the NC, is satisfied that the current board size and the existing composition of the Board and the Board Committees provide for diversity in line with the Diversity Policy with a good balance of age, educational background, experience, skill, industry knowledge, professional qualifications, gender and length of service, which serve to support the Company in achieving its strategic objectives and sustainable growth and development, fosters constructive debate and facilitates effective decision making. The Board and NC will constantly examine its size with a view to determining its impact upon its effectiveness.

The self-assessment questionnaire qualitative criteria used by the NC to evaluate the Board covers five key areas relating to Board structure, the Board's review of the Company's strategy and performance, Board's oversight on the Company's governance, including risk management and internal controls, and the effectiveness of the Board Chairman and Board processes. The quantitative criteria used to evaluate the overall Board performance comprises performance indicators which include a comparison of the Group's performance (including segmental performance) for the financial period under review against the Group's performance for the corresponding period in previous years, and other indicators such as the Company's share price performance over a historical period.

When assessing the overall Board performance, the NC takes into consideration the feedback from individual Directors on areas relating to the Board's qualitative criteria as stated above and the result of the quantitative assessment. The results of the overall evaluation of the Board by the NC, including its recommendation for improvements, if any, are presented to the Board.

Effectiveness of the Board

Based on the summary of findings of the evaluation for FY2026 together with the feedback and recommendations from each Director, the NC and the Board concluded that the overall performance of the Board was consistently good in all aspect and met its performance objectives for FY2026 and no major issues or findings that required the attention of the Board have been identified.

The RC reviews and recommends to the Board the remuneration packages or policies for the EDs, CEO and the KMPs after considering, among other things, the performance of the Group and the contributions from such individual Director/KMPs. No Director individually decides or is involved in the determination of his/her own remuneration. The RC's recommendations are submitted for endorsement by the Board.

In carrying out the above-mentioned duties, the RC shall, inter alia:

- (i) to consider all aspects of remuneration (including director's fees, salaries, allowances, bonuses, options, share-based incentives and awards, benefits in kind and termination payments), to ensure fairness in assessment of remuneration, and avoid rewarding poor performances;
- (ii) to determine if the level and structure of remuneration of the Board and KMPs are appropriate to the specific role and circumstances of each Director and KMPs, and to recognise their performance, potential and responsibilities in proportion to the sustained performance and value creation of the Company, taking into account the strategic objectives of the Company;
- (iii) to measure performance of Directors and KMPs who are in control function principally based on the achievement of the objectives of their functions;
- (iv) to consider reliable, up-to-date information on the remuneration practices of other companies and the relevant market benchmarks. Such information can be obtained by commissioning or purchasing any appropriate reports, surveys or information or through the appointment of external consultants. These will be at the expense of the Company, subject to the budgetary constraints imposed by the Board;
- (v) to ensure that a significant and appropriate proportion of EDs' and KMPs' remuneration is structured so as to link rewards to corporate and individual performance. Performance-related remuneration is aligned with the interests of Shareholders and other stakeholders and promotes the long-term success of the Company;

薪酬委員會還將審查本公司根據與執行董事和主要管理層簽訂的服務合約承擔的責任(責任在這些服務合約終止時可能產生)以確保這些服務合約包含公平合理的終止條款，而不是過於寬鬆。薪酬委員會旨在保持公平，避免獎勵不佳表現。

董事及主要管理層的薪酬水平及組合

本公司採用的執行董事和主要管理層的薪酬政策一般包括基本工資和與本公司和個別執行董事或主要管理層的績效掛鉤的可變獎金。目前，本公司沒有任何股票期權或激勵性股份計劃。

在釐定薪酬待遇時，會參考薪酬政策考慮以下因素：

- 相關財務和非財務目標的平衡計分卡，包括適當的風險和合規目標，按表現進行區分
- 一般商業和經濟狀況
- 供需波動和競爭條件變化等適當市場的變化
- 個人對本集團的貢獻
- 符合本集團價值觀、文化和品格期望的正確行為
- 保留人才的考量和個人潛力

(vi) to ensure remuneration of the INEDs is appropriate to the level of contribution, taking into consideration factors such as efforts, time spent and responsibilities, and that INEDs are not over-compensated to the extent that the independence of the INEDs may be compromised; and

(vii) to evaluate if remuneration is appropriate to attract, retain and motivate Directors to provide good stewardship of the Company and KMPs to successfully manage the Company for the long term.

The RC will also review the Company's obligations under the service agreement entered into with the EDs and KMPs that would arise in the event of termination of these service agreements. This is to ensure that such service agreements contain fair and reasonable termination clauses which are not overly generous. The RC aims to be fair and avoid rewarding poor performance.

Level and Mix of Remuneration of Directors and KMPs

The remuneration policy for the EDs and KMPs adopted by the Company generally comprises a basic salary and a variable bonus that is linked to the performance of the Company and individual ED or KMPs. Currently, the Company does not have any share option or incentive share scheme.

The following factors are considered with reference to the Remuneration Policy when determining their remuneration packages:

- balanced scorecard of relevant financial and non-financial objectives including appropriate risk and compliance objectives, differentiated by performance
- general business and economic conditions
- changes in appropriate markets such as supply/demand fluctuations and changes in competitive conditions
- individual contributions to the Group
- right behaviours aligned with the Group values, culture and conduct expectation
- retention consideration and individual potential

董事及主要管理層的薪酬水平及組合(續)

任何董事或主要管理層均沒有參與決定其自身的薪酬。

本公司不使用合約條款允許本集團在財務業績錯報或因不當行為導致本公司財務損失的特殊情況下向執行董事和主要管理層收回薪酬的激勵部分。如這些人士違反了受託責任，本公司應該能夠對他們追究責任。

薪酬委員會每年都會審查執行董事和主要管理層的薪酬結構，以確定其是否能有效地吸引、保留和激勵他們。該審查包括與本集團人力資源部門編製的現有行業資料的比較。

薪酬委員會對執行董事、行政總裁和主要管理層的薪酬待遇進行年度審查，在考慮其表現、本公司業績和市場平均水準等因素後確定執行董事、行政總裁和主要管理層的薪酬。

執行董事獲得名義董事袍金。本公司提倡以表現為基礎的執行董事和主要管理層的薪酬制度，該制度具有靈活性和對市場的反應能力，包括基本工資和其他固定津貼，以及基於本集團和個人表現的可變業績獎金，如管理能力、執行能力、交際能力和業務規劃能力。此舉旨在使薪酬與股東利益、本公司和個人表現掛鉤，以促進本集團的長遠可持續發展。

非執行董事薪酬政策

非執行董事(包括獨立非執行董事)的薪酬結構在釐定時考慮了多項因素，例如非執行董事各自在董事局及董事局委員會中的角色及責任、業務變動、企業管治常規及監管規則，以及其貢獻水準，包括出席董事局及董事局委員會會議(於正式會議場地及以外地方出席)的出席率及所使用的時間。每位非執行董事的薪酬包括基本袍金和在董事局委員會提供服務的額外袍金。鑑於各董事局委員會主席所承擔的責任較大，因此審核委員會及薪酬委員會主席的薪酬亦較各董事局委員會的成員高。為確保獨立非執行董事的客觀性及獨立性，本公司不會向獨立非執行董事提供具業績表現相關元素的股本薪酬。

董事薪酬結構定期與同類上市公司進行基準比較，以確保其公平適當。

Level and Mix of Remuneration of Directors and KMPs (continued)

No individual Director or KMP is involved in deciding his/her own remuneration.

The Company does not use contractual provisions to allow the Group to reclaim incentive components of remuneration from the EDs and KMPs in exceptional circumstances of misstatement of financial results, or of misconduct resulting in financial loss to the Company. The Company should be able to avail itself to remedies against these personnel in the event of such breach of fiduciary duties.

The remuneration structure of the EDs and KMPs is reviewed annually by the RC to determine whether it is effective in attracting, retaining and motivating them. The review includes comparisons against available industry information compiled by the Group's human resource department.

An annual review of the remuneration package of the EDs, CEO and KMPs is carried out by the RC to ensure that the remuneration of the EDs, CEO, and KMPs after taking into consideration, among other things, their performance and that of the Company, and the market averages.

The EDs are paid nominal Directors' fees. The Company advocates a performance-based remuneration system for EDs and KMPs that is flexible and responsive to the market, comprising a base salary and other fixed allowances, as well as variable performance bonus which is based on the Group's performance and the individual's performance such as management skills, process skills, people skills and business planning skills. This is designed to align remuneration with the interests of Shareholders and link rewards to corporate and individual performance so as to promote the long-term sustainability of the Group.

Policy in Respect of Non-executive Directors' Remuneration

The fee structure for the NEDs (including INEDs) is determined after taking into account factors such as, the NEDs' respective roles and responsibilities on the Board and Board Committees, the changes in the business, corporate governance practices and regulatory rules and level of contributions including attendance and time spent at and outside the formal environment of the Board and Board Committees meetings. Each NED's remuneration comprises a basic fee and an additional fee for services performed on Board Committees. AC and RC Chairmen are also paid a higher fee compared with the members of the respective Board Committees in view of the greater responsibility carried by that office. No equity-based remuneration with performance-related elements is granted to INEDs by the Company to ensure their objectivity and independence.

The Directors' fee structure is regularly benchmarked with comparable listed companies to ensure that their remuneration is fair and appropriate.

關連人士交易

本公司已就與利益關係人士的任何交易採用內部政策，並規定了審查和批准本公司關連人士交易的程序。

審核委員會對本集團的關連人士交易進行了審查，以確保交易符合上市規則並在2026年年報中適當披露。審核委員會相信，除向審核委員會報告的事項外，沒有涉及董事、控股股東或其關連人士利益的重大合約。因此，審核委員會認為與識別、評估、審查、批准和報告關連人士交易相關的內部監控的足夠。

Information relating to the remuneration of Directors on a named basis for FY2026 is set out in note 9 under the heading "Directors' and Chief Executive's remuneration and Five Highest Paid Employees" on pages 207 to 209 of the Group's AR2026.

Related Party Transactions ("RPTs")

During FY2026, the Group entered into certain transactions with "related parties" as defined under the applicable accounting standards. Related party transactions are disclosed in note 43 to the Group Consolidated Financial Statements on page 255 of the Group's AR2026.

The Company has adopted an internal policy in respect of any transaction with interested persons and has set out the procedures for review and approval of the Company's RPTs.

The AC conducted a review of the Group's RPTs to ensure that the transactions were in accordance with the Listing Rules and properly disclosed in the AR2026. The AC is satisfied that other than those reported to the AC, there were no material contracts involving the interests of the Directors, the controlling Shareholders or their associates. The AC is therefore satisfied over the adequacy of internal controls relating to the identification, evaluation, review, approval and reporting of RPTs.

財務報告

董事局致力於向股東提交的年報及中期報告中，就本集團的表現、狀況及前景作出清晰、平衡及易於理解的評估，並適時作出適當披露及公佈。在批准任何財務或其他資料前，管理層應向董事局提供足夠的解釋及資料，包括預算、管理帳目及與將要提交董事局的事宜有關的背景資料，以便董事局對提交董事局審批的財務及其他資料作出知情評估。此外，管理層定期向所有董事報告最新情況，就本集團的表現、狀況及前景作出平衡及易於理解的評估，並提供足夠詳情，使董事局整體及各董事能夠履行其根據上市規則第5.01條及第17章履行其職責。

董事局承認其有責任編製本集團每個財政年度的財務報表，真實及公平地反映本集團的狀況以及本集團的利潤和現金流量。在編製財務報表時，已採納國際財務報告準則、香港財務報告準則、香港公司條例的披露規定及上市規則的適用披露條文，並持續使用及應用適當的會計政策，並適當地作出合理的判斷和估計。董事局並不知悉任何與可能對本公司持續經營能力造成重大影響的事件或情況有關的重大不確定因素。因此，董事局已按持續經營基準編製本公司的財務報表。

董事局確認其有責任在本公司的年報及中期報告、公佈、上市規則規定的財務披露、向監管機構提交的報告中，以及根據其他法定要求披露的資料中，提出平衡、清晰及易於理解的評估。

Financial Reporting

The Board aims to present a clear, balanced and comprehensible assessment of the Group's performance, position and prospects in the annual and interim reports to the Shareholders, and make appropriate disclosure and announcements in a timely manner. Before approval of any financial or other information, Management should provide sufficient explanation and information, including budget, management accounts and background information relating to matters to be brought forward to the Board, to the Board to enable it to make an informed assessment of financial and other information put before the Board for approval. In addition, Management provides all Directors with regular updates giving a balanced and understandable assessment of the Group's performance, position and prospects in sufficient detail to enable the Board as a whole and each Director to discharge their duties under rule 5.01 and Chapter 17 of the Listing Rules.

The Board acknowledges its responsibility for preparing the Group's financial statements for each financial year which give a true and fair view of the state of affairs of the Group and of the profits and cash flows of the Group. In the preparation of financial statements, International Financial Reporting Standards, Hong Kong Financial Reporting Standards, the disclosure requirements of the Hong Kong Companies Ordinance and applicable disclosure provisions of the Listing Rules have been adopted, the appropriate accounting policies have been consistently used and applied, and reasonable judgements and estimates are properly made. The Board is not aware of any material uncertainties relating to events or conditions that might cast significant doubt upon the Company's ability to continue in business. Accordingly, the Board has prepared the financial statements of the Company on a going concern basis.

The Board acknowledges its responsibility to present a balanced, clear and understandable assessment in the Company's annual and interim reports, announcements, financial disclosures required under the Listing Rules, and reports to the regulators as well as information required to be disclosed pursuant to other statutory requirements.

外聘核數師和審計質量評估

本公司的外聘核數師德勤已向審核委員會確認，他們在擔任本公司的外聘核數師方面是獨立的。德勤的工作範圍和職責在2026年年報的「獨立核數師報告書」一節中說明。

董事局和審核委員會在外聘核數師的選擇、任命、辭職或解僱方面沒有分歧。

有效的審計不僅可以獨立評審實體的財務報表是否沒有重大錯報(即提供真實和公正的觀點)，還可以識別被審計實體內部監控中的弱點。審計的目的是增強使用者對財務報表可信度的信心，財務報表包含可靠和相關的資訊，供投資者和其他持份者作出明智的決定。雖然審計品質的主要責任在於外聘核數師，但為了投資者和其他持份者的利益，審核委員會在監督核數師如何提高和保持審計品質方面發揮著關鍵作用。

從本財政年度的審計品質角度而言，審核委員會接受了本公司外聘核數師的年度評估。審核委員會考慮了以下因素：

- 管治和領導力；
- 遵守相關的道德要求(包括但不限於獨立性)；
- 行業知識和技術能力；
- 委聘表現與資源；
- 與審核委員會的溝通和互動；和
- 監控過程。

根據評估結果，審核委員會認為德勤作為本公司的現任核數師，其維持的審計品質足以且適合本公司的審計工作。

External Auditor and Audit Quality Evaluation

The Company's External Auditors, Deloitte, has confirmed to the AC that they are independent with respect to acting as external auditor to the Company. The work scope and responsibilities of Deloitte are stated in the section entitled "Independent Auditor's Report" to the AR2026.

There was no disagreement between the Board and the AC on the selection, appointment, resignation or dismissal of the External Auditors.

An effective audit not only provides independent assurance on whether an entity's financial statements are free from material misstatements (i.e. give a true and fair view), but may also identify weaknesses in internal controls of the audited entity. The purpose of an audit is to enhance users' confidence in the credibility of financial statements, which contain reliable and relevant information for investors and other stakeholders to make informed decisions. While the primary responsibility for audit quality rests with External Auditors, the AC in the interests of investors and other stakeholders, plays a pivotal role in monitoring how auditors enhance and maintain audit quality.

The AC underwent the annual evaluation of the Company's External Auditors, from an audit quality perspective for the financial year. The following factors have been taken into account by AC:

- governance and leadership;
- compliance with relevant ethical requirements (including but not limited to independence);
- industry knowledge and technical competence;
- engagement performance and resources;
- communication and interaction with the AC; and
- monitoring process.

Based on the evaluation results, the AC considered Deloitte, as the Company's incumbent auditors, maintained audit quality that was sufficient and appropriate for the Company's audit engagement.

外聘核數師的評估

在2026財政年度和往年一樣，審核委員會審查了外聘核數師編製的年度審計計劃和報告，討論了審計範圍、審計的重要性、重大風險和審計重點領域、內部監控計劃、內部專家的參與、審計的時間安排和審計質量指標。

在審計質量指標方面，審核委員會特別審查以下領域：審計所使用的時間、團隊的經驗、團隊接受的培訓是否足夠、內部和外部工作檢查的結果、是否符合獨立性要求、品質控制、員工監督和員工流失率。

審核委員會對外聘核數師的獨立性和客觀性、審計工作方法、建議的審計費用以及給予他們的非審計費用進行了審查。

審核委員會在批准外聘核數師的薪酬方面發揮著關鍵作用。審核委員會確保審計費用不會達到影響審計質量的水平，並在評估審計費用的合理性時考慮關鍵因素，包括審計的性質、規模和複雜性以及市場競爭。

審核委員會將根據委聘的要求支付此類費用，以確保獲分配具有適當專業知識和經驗的充足資源，以便能夠根據專業標準和適用的法律和法規要求進行審計。

審核委員會從以下幾個方面評估了審計費用的合理性：

- 本集團的規模及結構包括：(i)總資產、營業額及淨收入；(ii)附屬公司及關連實體的數量及相對重要性；(iii)本集團開展業務的地理位置數量；及(iv)本集團經營的業務分類；
- 本集團業務的性質及複雜程度，包括：(i)本集團主要業務的性質；(ii)本集團財務報告及財務報告內部監控的有效性；(iii)是否預期會使用電腦輔助審計工具，以及應否讓科技專家參與；及(iv)本集團的業務是否在業務分部數量方面屬多元化；

Evaluation of External Auditors

During FY2026 and as in past years, the AC reviewed the annual audit plans and reports prepared by External Auditors, discussed on the planned audit scope, materiality in auditing, significant risks and areas of audit focus, internal control plans, involvement of internal specialists, timing of audit and audit quality indicators.

In respect of the audit quality indicators, the AC reviews, in particular, the following areas: audit hours spent, experience of the team, adequacy of training received by the team, results of internal and external inspection of their work, compliance with independence requirement, quality control, staff oversight, and staff attrition rate.

The AC undertook a review of the independence and objectivity of the External Auditors, their approach of the audit work, their proposed audit fees as well as the non-audit fees awarded to them.

The AC plays a pivotal role in approving the remuneration of External Auditors. The AC ensures audit fees are not at a level that compromises audit quality and considers key factors including the nature, size, and complexity of the audit as well as market competition in assessing the reasonableness of audit fees.

The AC would award such fees, commensurate with the demands of the engagement, as would ensure that sufficient resources with appropriate expertise and experience will be allotted to enable the audit to be performed in accordance with professional standards and applicable legal and regulatory requirements.

The AC has assessed the reasonableness of the audit fee in following aspects:

- size and structure of the Group in terms of: (i) total assets, revenue and net income; (ii) number and relative significance of subsidiaries and associated entities; (iii) number of geographical locations where the Group conducts business; and (iv) lines of business operated by the Group;
- nature and complexity of the Group's businesses in terms of: (i) nature of the Group's principal activities; (ii) effectiveness of the Group's financial reporting and internal control over financial reporting; (iii) whether computer-aided audit tools are expected to be used and technology specialists should be involved; and (iv) whether the Group's businesses are diversified in terms of number of business segments;

- 審計費用明細：(i)按員工的資歷(即審計合夥人、審計經理、專家和其他團隊成員專責審計的小時數)；(ii)按本集團業務的地理位置(即核數師事務所向每個地點的核數師分配的審計費用金額)；及(iii)按本集團的業務分部劃分(即核數師事務所分配給每個業務分部的審計費用金額)；
- 其他因素，包括：(i)核數師向從事類似行業運營的實體收取的審計費用；及(ii)其他規模及性質相近的上市實體就類似複雜程度的審計所支付的費用。

審核委員會了解到，德勤根據職責的嚴重性、複雜程度、工作要求、所需的工作條件和工作時間，以及實際參與審計工作的各級員工的專業知識和工作經驗等因素提出審計費用。

審核委員會認為，在考慮上述因素後，德勤的審計費用合理，處於正常市場水準，且不顯著低於其他公司，足以使該公司能夠根據專業標準和適用的法律和監管要求執行審計業務。

- other factors, in terms of: (i) audit fees charged by the audit firm for entities that operate in a similar industry; and (ii) fees paid by other listed entities of similar size and nature for audits of similar complexity.

The AC was aware that Deloitte proposed the audit fees based on factors such as severity of responsibilities, complexity, work requirements, required working conditions and working hours, and professional knowledge and work experience of staff at all levels actually participating in the audit engagement.

The AC considered that, having taken into account the factors mentioned above, the audit fee of Deloitte was reasonable, was within normal market level and not significantly lower than other firms, and was sufficient to enable the firm to perform the audit engagement in accordance with professional standards and applicable legal and regulatory requirements.

非審計服務主要是環境、社會及管治報告、稅務管理及諮詢。

本公司已採納核數師非審計服務政策，為本集團的非審計服務業務設定參數，以符合適用法律、法規及本公司的企業管治原則。本政策適用於外聘核數師，包括(i)與核數師事務所處於共同控制、擁有權或管理權下的任何實體；或(ii)被了解所有相關情況的合理且知情的第三方合理地視為核數師事務所在國內或國際上一部分的任何實體。

為了保持外聘核數師的獨立性，就非審計服務而聘用核數師，須經審核委員會批准。當審核委員會確定例外情況符合本公司的最佳利益，並且確定此類例外情況不會損害核數師的獨立性時，審核委員會可以批准例外情況。

為使審核委員會批准由外聘核數師提供的任何非審計服務，核數師應提供一份書面聲明，表明此類非審計服務不會損害其獨立性。

The AC has reviewed all non-audit services rendered and fees charged by Deloitte and its member firms and is of the opinion that such services received would not affect the auditor's independence. During FY2026, the aggregate amount of fees paid and payable to Deloitte and its member firms is as follows (excluding fees paid or payable by the Group's associates):

Non-audit services were mainly ESG reporting, tax management and consultation.

The Company has adopted an auditor's non-audit services policy to set parameters for the Group's non-audit services engagements consistent with applicable laws, regulations and the Company's corporate governance principles. The policy is applicable to the External Auditors including (i) any entity that is under common control, ownership or management with the audit firm; or (ii) any entity that a reasonable and informed third party having knowledge of all relevant circumstances would reasonably consider as part of the audit firm nationally or internationally.

In order to maintain the independence of the External Auditors the engagement of the auditors in relation to non-audit services shall be subject to the approval by the AC. The AC may approve exceptions when it determines that such an exception is in the best interests of the Company and it is determined that such an exception does not impair the independence of the auditor.

For the purpose of the AC's approval of any non-audit services to be provided by the External Auditors, the auditors shall provide a written statement to the effect that such non-audit services do not impair its independence.

在評估核數師的獨立性或客觀性與非審計服務的關係時，審核委員會將考慮：

- 非審計服務的性質、相關費用水平以及相對於核數師事務所的單獨和整體費用水平；和
- 提供非審計服務的個人的薪酬標準。

審核委員會負責監督外聘核數師的獨立性以確保財務報表的真正客觀性，審查非審計服務的範圍，並批准應付給核數師的費用。審核委員會須就核數師提供的非核數服務而需要採取行動或改善的任何事宜，向董事局彙報。

審核委員會審查了德勤在2026財政年度內提供的非審計服務的性質和服務收費，並認為這些非審計服務不會對核數師的獨立性產生不利影響。

審核委員會將定期審查核數師非審計服務政策的實施和有效性，以確保該政策始終與本公司的需求相關，並反映當前的監管要求和良好企業管治常規，還將討論和考慮可能需要的任何修訂。

在2026財政年度內，審核委員會對核數師非審計服務政策的實施和有效性進行了審查，並認為該政策得到了有效實施。

經考慮會計與企業監管局發佈的《審計質量指標披露框架》，審核委員會已向董事局建議重新任命德勤為外聘核數師。

C. ACCOUNTABILITY AND AUDIT (continued)

Evaluation of External Auditors (continued)

When assessing the auditors' independence or objectivity in relation to non-audit services, the AC would consider:

- whether the skills and experience of the auditors make it a suitable supplier of non-audit services;
- whether there are safeguards in place to ensure that there is no threat (or any such threat will be reduced to an acceptable level) to the objectivity and independence of the audit because the auditors provide non-audit services;
- the nature of the non-audit services, the related fee levels and fee levels individually and in total relative to the audit firm; and
- the criteria for the compensation of the individuals performing the non-audit services.

The AC is responsible for monitoring the independence of the External Auditors to ensure true objectivity in the financial statements, reviewing scope of non-audit services and approving fees payable to the auditors. The AC shall report to the Board on any matters where action or improvement is needed in relation to non-audit services provided by the auditors.

The AC has reviewed the nature and the service charges of non-audit services performed by Deloitte during FY2026 and considered that these non-audit services have no adverse effect on the independence of the auditors.

The AC would regularly review the implementation and effectiveness of the auditors' non-audit services policy to ensure that the policy remains relevant to the Company's needs and reflects both current regulatory requirements and good corporate governance practice, and will also discuss and consider any revisions that may be required.

During FY2026, the AC has conducted the review of the implementation and effectiveness of the auditors' non-audit services policy, and concluded that the policy was implemented effectively.

The AC has recommended to the Board, the re-appointment of Deloitte, as External Auditor taking into consideration the Audit Quality Indicators Disclosure Framework published by Accounting and Corporate Regulatory Authority.

C. 問責制和審計 (續)

外聘核數師的評估 (續)

根據審核委員會的建議，董事局批准在即將召開的2026年股東周年大會上建議再次任命德勤•關黃陳方會計師行為獨立外聘核數師，以供股東批准。

審核委員會可全面接觸管理層和員工，並得到他們的充分合作。審核委員會擁有邀請任何董事或任何管理層成員參加其會議的全權酌情權。

D. 風險管理及內部監控

風險管理框架

董事局明白，完善的風險管理及內部監控系統應納入本集團的營運，並構成其文化的一部分。該系統應能夠快速應對因本集團內部因素和業務環境變化而引起的業務風險變化。它應包括立即向適當管理層報告發現的任何重大風險管理和控制失敗或弱點的程式，以及正在採取的糾正措施的詳細資訊。因此，董事局已建立必要的風險管治架構，以確保其風險管理框架、政策和流程得到有效執行。

董事局全面負責風險管治，包括確定風險策略、風險偏好和風險限額，以及風險政策。與策略、外部和可預防風險管理有關的所有事項均由審核委員會負責。

本集團已在審核委員會內部訂立了職權範圍，以監督企業風險。審核委員會負責界定企業在實現其策略目標時可以承擔的風險水準。審核委員會還直接監督由風險管理總裁(「風險管理總裁」)管理的企業風險管理(「企業風險管理」)計劃的適當建立和維護。

C. ACCOUNTABILITY AND AUDIT (continued)

Evaluation of External Auditors (continued)

On the recommendation of the AC, the Board approved the re-appointment of Deloitte Touche Tohmatsu as the independent External Auditors at the forthcoming 2026 AGM for Shareholders' approval.

The AC has full access to, and has the full co-operation of Management and staff. It also has full discretion to invite any Director or any member of Management to attend its meetings.

D. RISK MANAGEMENT AND INTERNAL CONTROL

Risk Management Framework

The Board is aware that a sound system of risk management and internal control should be embedded in the operations of the Group and form part of its culture. This system should be capable of responding quickly to evolving risks to the business arising from factors within the Group and changes in the business environment. It should include procedures for reporting immediately to appropriate levels of management any significant risk management and control failings or weaknesses that are identified together with details of corrective action being taken. The Board has therefore established the necessary risk governance structure to ensure the effective execution of its risk management framework, policies and processes.

The Board has overall responsibility for the governance of risk, including determining the risk strategy, risk appetite and risk limits, as well as the risk policies. All matters pertaining to the management of strategic, external and preventable risks are the responsibility of the AC.

The Group has established terms of reference within the AC to oversee enterprise risk. The AC is responsible for defining the level of risk which the business can take in pursuit of its strategic objectives. The AC also has direct oversight for the proper setting up and maintenance of an enterprise risk management ("ERM") programme which is managed by the Chief Risk Officer ("CRO").

D. 風險管理及內部監控 (續)

風險管理框架 (續)

本公司維持充足及有效的內部監控系統(包括財務、營運、合規及資訊科技監控)及風險管理系統，以保障持份者的利益及本集團的資產。這包括內部監控手冊和企業風險管理計劃，提供適當級別的風險考慮和緩解。這些文件還考慮了Committee of Sponsoring Organisation for the Treadway Commission(「COSO」)制定的適當內部監控的主要要素，以及內部審計部(「內部審計部」)和其他評審供應商在整個財務期間所做的工作。這些文件每年由審核委員會和董事局進行審查，任何涉及超出本集團明確風險管治下訂立的風險邊界的決策均應獲得董事局的明確批准。

董事局確定風險偏好及風險承受能力的水平，以符合追求業務目標。本集團制定風險政策，規定企業風險管理在本集團內的運作，並涵蓋企業風險管理的職責、報告要求和風險評估流程。

審核委員會直接監督本集團的企業風險管理，確保管理層設計、實施和維持充足且有效的內部監控系統，包括與本集團內各項業務相關的財務、營運、合規及資訊技術控制，並相應地解決風險敞口。本集團採取減輕和降低可預防風險的風險敞口水平的立場。透過向風險主人和風險管理總裁直接負責，追蹤和控制剩餘風險至可接受的水平。企業風險管理計劃滿足了這一需求，並確保對風險管理活動進行定期監控。

風險管理總裁負責確保本集團風險狀況是最新，並反映業務面臨的潛在和相關風險敞口。在進行風險管治時，董事局會考慮策略風險，並在決定如何管理、避免或為此類外部和策略事項制定應急計劃方面發揮積極作用。所有其他風險在定期風險評估中考慮。在該等評估中，本集團會檢討現有及潛在風險，並根據就該等風險的影響及可能性的集體評估(根據本集團本財政年度的風險管理計劃進行)以及為應對該等風險而實施的監控措施的有效性，調整風險狀況。審核委員會定期檢討風險狀況的變化以及現有業務常規或未來策略計劃未充分涵蓋的任何重大風險敞口。

D. RISK MANAGEMENT AND INTERNAL CONTROL (continued)

Risk Management Framework (continued)

The Company maintains an adequate and effective system of internal controls (including financial, operational, compliance and IT controls) and risk management systems to safeguard stakeholders' interests and the Group's assets. This contains a IC Manual and an ERM Programme, which provides the appropriate level of risk consideration and mitigation. These documents also take into consideration the leading elements for proper internal control established by the Committee of Sponsoring Organisation for the Treadway Commission ("COSO") as well as the work performed across the financial period by the Internal Audit Department ("IA Dept") and other assurance providers. These documents are reviewed by the AC and the Board annually and any decision making which entails going beyond the risk boundaries established under the defined risk governance of the Group is to obtain explicit Board approval.

The Board establishes the level of risk appetite and risk tolerance which is to be conformed within the pursuit of the business objectives. The Group has risk policies which define how ERM is operationalised within the Group and cover responsibilities for ERM, reporting requirements and the risk assessment process.

The AC with their direct oversight for ERM across the Group, ensures that Management devises, implements and maintains adequate and effective internal control systems, including financial, operational, compliance and information technology controls, which are relevant to the various businesses within the Group and address the risk exposures accordingly. The Group takes a stance to mitigate and reduce the level of risk exposure for preventable risks. This is done by providing direct accountability to the risk owners and the CRO to track and manage the residual risk to acceptable levels. The ERM programme caters for this and ensures that regular monitoring of risk management activities are in place.

The CRO is responsible for ensuring that the Group risk profile is up-to-date and reflects the potential and relevant risk exposures to the business. Strategic risks are considered during the risk governance exercise and the Board takes an active role in determining how to manage, avoid or build contingencies for such external and strategic matters. All other risks are considered during periodic risk assessment exercises. In such exercises, prevailing and potential risks are reviewed and the risk profile is adjusted based on a collective assessment of the impact and likelihood of these risks (conducted in accordance with the Group's risk management programme for the financial year), as well as the effectiveness of controls in place to address them. The AC is periodically apprised of the changes to risk profile and any major risk exposures that are insufficiently covered by existing business practices or future strategic initiatives.

D. 風險管理及內部監控 (續)

風險管理框架 (續)

在審核委員會的協助下，董事局持續評估本集團風險管理和內部監控系統（「風險管理和內部監控系統」）的充足性和有效性。董事局已制定既定程序監控本集團承擔風險的偏好，以及預期進行的最低風險管理活動。此外，設有一個正式的企業風險管理計劃，允許管理層將業務風險的重要變化傳達給審核委員會和董事局。這樣可以確定資源和工作的優先順序，以解決對業務更相關和更關鍵的風險。

除此之外，董事局還與審核委員會和管理層合作，設定組織目標，確定實現這些目標的策略，並建立必要的風險管治和控制框架，以管理實現這些目標的風險。

三線模型

管理層實現組織目標的責任包括一線和二線職能。一線職能主要負責通過設計和實施適當的緩解控制措施來管理組織風險，由擁有和管理風險的運營管理層負責。一線職責直接與提供產品和／或服務給組織客戶有關，及包括支援功能的職能。

第二條職能包括風險管理和合規職能，由風險管理總裁領導，以建立和／或監控第一條職能。二線職能協助管理風險，促進監控和及早發現合理的風險。必要時，會提請審核委員會注意，以分配和重新部署資源以應對風險敞口。

風險管理職能旨在促進和監控管理層在整個組織內實施有效的風險管理常規，協助風險主人確定目標風險敞口並提供適當的風險報告。合規職能的主要目的是監控對適用法律和法規的遵守情況。一個組織內通常有多個合規團隊，負責健康與安全、人力資源、法律、供應鏈、環境或品質等領域。

D. RISK MANAGEMENT AND INTERNAL CONTROL (continued)

Risk Management Framework (continued)

The Board has, with the assistance of the AC, evaluated the adequacy and effectiveness of the Group's risk management and internal control systems ("RMICS") on an ongoing basis. There is already an established process in place for the Board to drive the Group's propensity for taking risk and the minimum risk management activities that are expected to be conducted. There is also a formal ERM programme which allows Management to communicate the key changes to business risk to the AC and thereon the Board. This enables the prioritisation of resources and efforts to address the more pertinent and critical risks to the business.

Aside to this, the Board works with the AC and Management to set up organisational objectives, defining strategies to achieve them and establishing the necessary governance risk management and control frameworks to manage the risks to their achievement.

The Three Lines Model

Management's responsibility to achieve organisational objectives comprises both first and second line roles. The first line roles are primarily responsible for managing organisational risks through designing and implementing appropriate mitigating controls, rests with operational management who own and manage risks. First line roles most directly aligned with the delivery of products and/or services to customers of the organisation, and include the roles of support functions.

The second line comprises risk management and compliance functions, which is being headed by the CRO, to help build and/or monitor the first line. Second line roles provide assistance with managing risk, facilitates monitoring and early detection of plausible risks. These are brought to the attention of the AC where needed, to assign and re-deploy resources to counter the risk exposure.

Risk management functions are designed to facilitate and monitor the implementation of effective risk management practices by Management throughout the organisation, assisting risk owners in defining target risk exposure and providing adequate risk reporting. The principal purpose of compliance functions is to monitor compliance with applicable laws and regulations. It is common for multiple compliance teams to operate within an organisation, with responsibility in areas such as health and safety, human resources, legal, supply chain, environmental or quality.

D. 風險管理及內部監控 (續)

三線模型 (續)

作為最後一道防線，本集團還設有內部審計（「內部審計」）。第三條線的主要功能是提供風險評審。內部審計為管治、風險管理和內部監控（包括一線和二線控制）的有效性作出評審。內部審計獨立於管理層，直接向審核委員會彙報。

外聘核數師還可以通過考慮與財務報告相關的管治和控制結構來發揮重要作用。

內部審計和外聘核數師根據各自的職權範圍和任命，向審核委員會報告與內部監控相關的任何審計結果，審核委員會審查管理層為採納內部審計和外聘核數師的建議而採取的行動是否充分。

審核委員會尋求上述各方的評審，並全面評估是否存在任何可能影響董事局對內部監控狀況發表意見的重大差距或事宜和重點。這運作每年進行一次。

董事局承認其有責任持續監控和審查本集團風險管理和內部監控系統的充足性和有效性。然而，由管理層及本集團相關人士實施的本集團風險管理和內部監控系統旨在管理而非消除未能實現業務目標的風險，並且只能就重大錯誤陳述或損失提供合理而非絕對的保證。這些業務目標包括：(i) 運營效率和有效性；(ii) 財務報告的可靠性；(iii) 遵守適用的法律和法規；以及 (iv) 風險管理的有效性。

董事及管理層積極參與風險評估、審查應對措施及討論重大事項。

董事局每年檢討本集團的風險管理及內部監控系統及其涵蓋財務、營運、合規監控及風險管理職能的成效，並特別考慮以下因素：

- (i) 自上次年度檢討以來，重大風險（包括環境、社會及管治風險）的性質及程度，以及本集團應對業務及外圍環境變化的能力的轉變；

D. RISK MANAGEMENT AND INTERNAL CONTROL (continued)

The Three Lines Model (continued)

As a final line, the Group also maintains an in-house Internal Audit ("IA"). The principal function of the third line is to provide risk assurance. IA provides assurance on the effectiveness of governance, risk management and internal controls, including first and second line controls. IA is independent of Management with a direct reporting line to the AC.

External Auditors can also play an important role through their considerations of the governance and control structure where this is relevant to financial reporting.

The IA and External Auditors, pursuant to their respective terms of reference and appointment, report to the AC any audit findings relating to internal controls, and the AC reviews the adequacy of the actions taken by Management to address the recommendations of the IA and External Auditors.

The AC seeks assurance from all the above-mentioned parties and holistically assesses if there are any material gaps or concerns and highlights which would impact the ability of the Board to opine on the state of internal control. Such an exercise is conducted annually.

The Board acknowledges its responsibility for monitoring and reviewing the adequacy and effectiveness of the Group's RMICS on an ongoing basis. However, the Group's RMICS implemented by the Management and relevant parties of the Group are designed to manage rather than eliminate the risk of failure to achieve the business objectives, and can only provide reasonable and not absolute assurance against material misstatement or loss. These business objectives includes: (i) efficiency and effectiveness of operations; (ii) reliability of financial reporting; (iii) compliance with applicable laws and regulations; and (iv) effectiveness of risk management.

Directors and the Management actively engage in the risk assessment, the review of response measures and the discussion with respect to major issues.

The Board has conducted an annual review on the system of risk management and internal control of the Group and its effectiveness covering the financial, operational, compliance controls and risk management functions, in particular, considered the following factors:

- (i) the changes, since the last annual review, in the nature and extent of significant risks (including ESG risks), and the Group's ability to respond to changes in its business and the external environment;

- (ii) 管理層持續監控風險 (包括環境、社會及管治風險) 和內部監控系統的範圍和品質，以及 (如適用) 其內部審計職能部門和其他評審服務供應商的工作；
- (iii) 向董事局 (或董事局委員會) 傳達監察結果的程度及頻率，以便董事局評估對本集團的監控及風險管理的有效性；
- (iv) 在此期間發現的重大監控失敗或弱點。此外，它們對本集團的財務業績或狀況產生 (可能已經或將來可能產生) 重大影響的不可預見結果或意外事件的程度；和
- (v) 本集團財務報告及上市規則合規流程的有效性。

系統有效性審查程序

董事局每年都會對風險管理和內部監控系統的有效性進行全面評估。董事局在以下具體程序中嚴格履行了風險管理和內部監控系統的監督職能：

- (i) 檢討本公司的財務監控、內部監控及風險管理系統；
- (ii) 與管理層討論風險管理和內部監控系統，以確保管理層履行了其職責，建立了有效的內部監控和風險管理系統。討論內容包括：本公司在會計、內部審計及財務彙報職能方面的資源、員工資歷及經驗、培訓及相關預算，以及相關僱員是否足夠；
- (iii) 主動或應董事局的委託，研究有關風險管理和內部監控系統事項的重大調查結果，並研究管理層對這些調查結果的回應；和
- (iv) 確保內部審計與外聘核數師之間的協調，並確保內部審計的職能在本公司內部有足夠資源和妥善實施，並檢討和監督其有效性。

D. RISK MANAGEMENT AND INTERNAL CONTROL (continued)

- (ii) the scope and quality of Management's ongoing monitoring of risks (including ESG risks) and of the internal control systems, and where applicable, the work of its IA function and other assurance providers;
- (iii) the extent and frequency of communication of monitoring results to the Board (or Board Committee(s)) which enables it to assess control of the Group and the effectiveness of risk management;
- (iv) significant control failings or weaknesses that have been identified during the period. Also, the extent to which they have resulted in unforeseen outcomes or contingencies that have had, could have had, or may in the future have, a material impact on the Group's financial performance or condition; and
- (v) the effectiveness of the Group's processes for financial reporting and Listing Rule compliance.

Review Procedure for Systems Effectiveness

The Board makes a comprehensive assessment of the effectiveness of RMICS annually. The Board has strictly implemented the supervision function of RMICS in the following specific procedures:

- (i) reviewed financial controls, internal control and risk management systems of the Company;
- (ii) discussed the RMICS with the Management to ensure that the Management has performed its duty to have effective internal control and risk management systems. The discussion included whether the resources, staff qualification and experience, training and relevant budget of the Company in accounting, IA, and financial reporting functions, as to whether their relevant employee is sufficient or not;
- (iii) considered major investigation findings on RMICS matters on its own initiative or as delegated by the Board and research on the management's response to these findings; and
- (iv) ensured coordination between the IA and External Auditors, and also ensure the IA function is sufficiently resourced and properly in place inside the Company, and review and supervise its effectiveness.

D. 風險管理及內部監控 (續)

系統有效性審查程序

管理層負責持續實施風險管理和內部監控系統，並每年向董事局報告實施情況。管理層於2026財政年度主要進行以下有關風險管理及內部監控的工作：

- (i) 更新統一風險框架和完整風險池，定期開展內部風險檢查和風險評估；
- (ii) 進行分析及監察策略、營運、財務、市場推廣、技術及合規方面的重大風險相關活動，以應對近期營商環境的變化以及電池、充電池及音響行業的相關規則及法規；
- (iii) 定期進行定量風險管理，優化定量風險測量指標，以支援風險評估和風險監控程序；
- (iv) 通過營業單位定量自我評估與內部審計部門定性評估相結合的方式，對內部監控制度進行審查，以持續監察內部監控制度的運作情況；和
- (v) 建立以風險為導向的內部審計工作，按照批准的內部審計計劃有效開展年度內部審計工作，定期與管理層和審核委員會溝通並向審核委員會彙報年度內部審計工作的重要發現，並跟進整改事宜。

董事局已收到管理層關於本集團風險管理和內部監控系統的有效性和充分性的確認。董事局通過內部審計部進行的上述審查結果，對本集團風險管理和內部監控系統的有效性和充足性進行了分析和評估，認為本集團在2026財政年度保持了充足和有效的風險管理和內部監控系統。

董事局致力實施有效及穩健的風險管理及內部監控系統，以保障股東的利益及本集團的資產。

內部審計部審查和評估本集團風險管理及內部監控系統的充分性和有效性。風險管理和內部審計審查的結果以及建議會定期向審核委員會報告。

D. RISK MANAGEMENT AND INTERNAL CONTROL (continued)

Review Procedure for Systems Effectiveness (continued)

The Management takes responsibilities for implementing RMICS on an on-going basis and reporting the implementation position to the Board annually. The Management has primarily conducted the following works in relation to risk management and internal control during FY2026:

- (i) updated a unified risk framework and completed risk pool, and carried out internal risk examination and risk assessments on a regular basis;
- (ii) carried out relevant activities to analyze and monitor the major risks, in terms of strategic, operational, financial, marketing, technological and compliance aspects, in responses to the recent changes in business environment and relevant rules and regulation of the battery, rechargeable battery and audio industries;
- (iii) carried out quantitative risk management regularly with the aim of optimising quantitative risk measurement indexes to support the risk assessment and risk monitoring procedures;
- (iv) conducted a review of internal control system through combination of quantitative self-assessment by the business units and qualitative evaluation by the IA department, so as to continuously monitor the operation of the internal control systems; and
- (v) established risk-oriented internal audit work, effectively carried out the annual IA work in accordance with the approved internal audit plan, regularly communicated with, and reported to, the Management and the AC about significant findings from the annual IA work and followed up the rectification matters.

The Board has received confirmation from Management on the effectiveness and adequacy of the Group's RMICS. The Board performed analysis and appraisal of the effectiveness and adequacy of the RMICS of the Group through the outcome of the abovementioned review performed by the IA Dept, considered and was of the opinion that the Group has maintained adequate and effective RMICS for FY2026.

The Board is committed to implementing an effective and sound risk management and internal control system to safeguard the interest of the Shareholders and the Group's assets.

The IA Dept reviews and assesses the adequacy and effectiveness of the Group's RMICS. The results of risk management and IA reviews as well as recommendations are reported to the AC regularly.

D. 風險管理及內部監控 (續)

內部審計

內部審計部門目前有6名員工，獨立於被其審計的活動。在履行其職責時，內部審計部組織及協調管理層識別及評估本集團所承受的風險供董事局考慮，並促使管理層設計、實施及管理合適的內部監控及風險管理系統，以促進董事局採納政策。除內部審計部外，所有員工都對其職責範圍內的風險管理和內部監控的實施負責。

內部審計主管的主要彙報線是向審核委員會彙報。審核委員會審查和／或批准內部審計主管的任命、辭職和解僱。內部審計主管可以不受限制地接觸審核委員會、董事局和管理層，以及與執行審計相關的本集團所有文件、記錄、財產和人員，並在本公司內具有適當的地位。

審核委員會定期評估內部審計的資源充足性、薪酬、績效評估以及與外部專業服務提供者達成的所有外包安排(如有)。

內部審計的所有成員(包括內部審計主管)均具備相關資格和經驗。內部審計主管是註冊內部核數師，並持有內部審核師協會頒發的內部審計專業證書。管理層為內部審計提供充足的時間和資源，以促進內部審計的妥善完成並向審核委員會報告任何重大事項。

內部審計在執行工作時採用COSO建立的內部監控框架，而內部審計計劃則以風險為本制訂。內部審計已採納國際內部審計實務框架內的《國際內部審計專業實務標準》內部進行內部審計。這可確保內部審計保持對內部審計函數的屬性和性能標準的適當一致性。內部審計成員亦透過參加由合資格的外間機構及團體舉辦的專業技術培訓課程，接受持續專業發展培訓。

D. RISK MANAGEMENT AND INTERNAL CONTROL (continued)

Internal Audit

The IA function, which presently has a staff strength of six, is independent of the activities it audits. In performing its responsibilities, the IA Dept has organized and coordinated the Management to identify and assess the risks exposed to the Group for the Board's consideration and motivate the Management to design, implement and manage suitable internal control and risk management systems to facilitate policies adopted by the Board. In addition to the IA Dept, all employees are accountable for the implementation of risk management and internal control under each of scope of their responsibilities.

The Head of IA's primary reporting line is to the AC. The appointment, resignation and dismissal of the Head of IA is reviewed and/or approved by the AC. The Head of IA has unfettered access to the AC, the Board and Management as well as all the Group's documents, records, properties and personnel relevant for the performance of audits and has appropriate standing within the Company.

The AC assesses on a regular basis, the resourcing adequacy of the IA, remuneration, performance evaluation and all outsourcing arrangements entered into with external professional services providers (if any).

All members of IA including the Head of IA have the relevant qualifications and experience. The Head of IA, is a Certified Internal Auditor and holds professional certifications in internal auditing issued by the Institute of Internal Auditors (the "IIA"). The IA is given sufficient time and resources dedicated by Management to facilitate the proper completion of internal audits and reporting of any material matters to the AC.

The IA adopts the internal control framework established by COSO when performing its work and the IA plan is developed through a risk centric approach. The IA has adopted and conducts its IA reviews based on the International Standards for the Professional Practice of Internal Auditing (the "IIA Standards") of the International Professional Practices Framework of the IIA. This ensures that the IA maintains the appropriate level of conformance to the attribute and performance standards of an IA function. Members of the IA also undergo CPD training through attendance at professional technical training sessions organised by qualified external institutions and bodies.

D. 風險管理及內部監控 (續)

內部審計 (續)

內部審計在半年度審核委員會會議正式彙報了內部審計的審核結果。審核委員會每年都會審查和批准年度內部審計計劃以及執行內部審計所需專業資源的任何進一步要求。內部審計審查的主要結果亦會與風險管理團隊及風險管理總裁分享，以便於在風險評估過程中將本集團的風險納入考慮範圍。

作為為內部監控意見提供依據的工作的一部分，審核委員會還評估了以下調查結果：

- (i) 內部審計對其範圍內的活動或實體執行的審核；
- (ii) 對風險管理框架的評價；和
- (iii) 評估風險管理和對財務、運營和合規風險的內部監控的充分性，主要由一線和二線角色管理負債。

審核委員會還評估外聘核數師在財務審計過程中發現的任何弱點或重大違規行為，以及為解決所報告問題而採取的補救措施的有效性(如有)。

內部審計的品質會被定期評估，以確保符合國際內部審計師協會標準。

內部審計職能制定了品質保證和改進計劃(「品質保證和改進計劃」)，以確保其審計活動符合國際內部審計師協會標準。作為品質保證和改進計劃的一部分，外部質量保證審查由外部組織的合格專業人員至少每五年進行一次。在截至2023年3月31日的財政年度，安永會計師事務所(「安永」)被任命根據國際內部審計師協會標準1312-國際專業實務框架的外部評估進行外部質量保證審查。質量保證審查涵蓋屬性標準(執行內部審計的職能和個人的屬性)和表現標準(界定內部審計的性質並提供品質標準來衡量這些服務的表現)。根據安永的評估，內部審計職能在所有重大方面均符合國際內部核數師協會標準的要求。

審核委員會認為內部審計職能是獨立、有效且資源充足。

D. RISK MANAGEMENT AND INTERNAL CONTROL (continued)

Internal Audit (continued)

The IA formally reports the findings from the IA reviews conducted at the half yearly AC meetings. On an annual basis, the AC reviews and approves annual IA plan as well as any further requirements in professional resources to conduct the required IA reviews. The key findings from the IA reviews are also shared with the risk management team and the CRO, to facilitate the necessary inclusion in the consideration of the Group's risks during the risk assessment process.

As part of the work done to provide the basis for the opinion on internal control, the AC also assesses the findings of:

- (i) the IA visits performed on the activities or entities within its scope;
- (ii) the evaluation of the framework of risk governance; and
- (iii) the assessment of adequacy of risk management and internal controls over financial, operational and compliance risk as principally managed by the first and second line roles.

The AC also evaluates any weaknesses or material non-compliance identified by the External Auditors during the course of their financial audit, and the effectiveness of remediation actions taken to address the issues reported (if any).

The quality of the IA is regularly assessed to ensure compliance with the IIA Standards.

The IA function has a Quality Assurance and Improvement Programme ("QAIP") in place to ensure that its audit activities conform to the IIA Standards. As part of the QAIP, an external Quality Assurance Review is carried out at least once every five years by qualified professionals from an external organisation. In the financial year ended 31 March 2023, Ernst & Young ("EY") was appointed to conduct the external QAR, based on Standard 1312 – External Assessments of International Professional Practices Framework of the IIA. The QAR covered the attribute standards (attributes of the function and individuals that perform IA) and the performance standards (which defines the nature of IA and provides quality criteria to measure the performance of these services). Based on EY's assessment, the IA function has been rated to have conformed with the requirements of the IIA Standards in all material respects.

The AC considers that the IA function is independent, effective and adequately resourced.

股東權利 – 召開股東特別大會及呈提建議的程序

根據本公司組織章程細則第68條及公司條例第566至568條，持有所有有權於本公司股東大會上投票的股東總表決權最少5%的股東（「請求人」）可要求董事召開本公司股東特別大會（「股東大會」）。

書面要求必須述明將在股東大會上處理的事務的一般性質，並必須由請求人簽署並送交本公司註冊辦事處，位址為：香港新界白石角，香港科學園第三期，科技大道西12號9樓（「註冊辦事處」），收件者為公司秘書。該請求可由多份類似形式的文件組成，並可能包括可適當動議並打算在股東大會上動議的決議案文本。

倘董事於彼等受到該規定所規限日期後21天內未有在召開股東大會通告發出日期後28天內召開股東大會，則請求人或任何佔全體請求人總表決權過半數之請求人，可自行召開股東大會。股東大會須於董事受到召開股東大會規定所規限日期後的三個月內召開。請求人因董事沒有妥為召開股東大會而招致的任何合理開支，須由本公司付還予請求人。

股東權利 – 要求傳閱股東周年大會決議案的程序

根據公司條例第615條，(a)在全體有權在該請求所關乎之股東周年大會上就該決議案表決之股東之總表決權佔最少2.5%的股東；或(b)最少50名有權在該請求所關乎之股東周年大會上就該決議案表決之股東，可就傳閱股東周年大會的決議案提出書面請求。該書面請求須：(a)指明將予發出通告所關乎之決議案；(b)由請求人簽署；(c)送交註冊辦事處，並註明致公司秘書；及(d)於該請求所關乎之股東周年大會六個星期前，或如較遲時間，該股東周年大會通告發出之時送抵本公司。有關進一步詳情，股東請參閱公司條例第580及615條。

E. SHAREHOLDERS' RIGHTS, COMMUNICATIONS WITH SHAREHOLDERS AND INVESTORS' RELATION

Shareholders' Right – Procedures for Convening an Extraordinary General Meeting and Putting Forward Proposals

Pursuant to Article 68 of the Company's Articles of Association and Sections 566 to 568 of the Companies Ordinance, Shareholders holding at least 5% of the total voting rights of all the Shareholders having a right to vote at general meetings of the Company (the "Requisitionists"), may request the Directors to convene an extraordinary general meeting of the Company ("General Meeting").

The written requisition must state the general nature of the business to be dealt with at the General Meeting and must be signed by the Requisitionists and sent to the registered office of the Company which is located at 9/F, Building 12W, 12 Science Park West Avenue, Phase 3, Hong Kong Science Park, Pak Shek Kok, New Territories, Hong Kong (the "Registered Office") for the attention of the Company Secretary. The requisition may consist of several documents in like form and may include the text of a resolution that may properly be moved and is intended to be moved at the General Meeting.

If the Directors do not, within 21 days after the date on which they become subject to the requirement, proceed duly to convene a General Meeting for a day not more than 28 days after the date of the notice convening the General Meeting, the Requisitionists, or any of them representing more than one half of the total voting rights of all of them, may themselves convene a General Meeting. The General Meeting must be called for a date not more than three months after the date on which the Directors become subject to the requirement to call a General Meeting. Any reasonable expenses incurred by the Requisitionists by reason of the failure of the Directors duly to call a General Meeting shall be repaid to the Requisitionists by the Company.

Shareholders' Right – Procedures for Requesting Circulation of a Resolution for an AGM

Pursuant to Section 615 of the Companies Ordinance, Shareholders may submit a written requisition to circulate a resolution at an AGM if they: (a) represent at least 2.5% of the total voting rights of all Shareholders having a right to vote on the resolution at the AGM to which the request relates; or (b) are at least 50 Shareholders having a right to vote on the resolution at the AGM to which the request relates. The written requisition must: (a) identify the resolution of which notice is to be given; (b) be signed by the requisitionists; (c) be sent to the Registered Office for the attention of the Company Secretary; and (d) be received by the Company not later than six weeks before the AGM to which the request relates or if later, the time at which notice is given of that AGM. Shareholders are requested to refer to Sections 580 and 615 of the Companies Ordinance for further details.

股東權利 – 提名人選參選董事的程序

股東提名人選參選董事的程序詳情，已登載於本公司網站www.goldpeak.com的「股東提名董事程序」一欄。

股東權利 – 向董事局查詢

本公司組織章程細則並無規定任何股東可向董事局提出查詢的程序。股東可隨時致函本公司總辦事處(地址為香港新界白石角，香港科學園第三期，科技大道西12號9樓)或電郵至ir@goldpeak.com。有關香港的股份過戶登記事宜，股東應聯絡香港的股份過戶登記處，即卓佳投資者服務有限公司，位址為香港夏慤道16號遠東金融中心17樓。

股東參與股東大會

本公司的股東大會一般在公共交通工具方便前往的本港主要商貿區舉行，確保股東有機會有效參與該等會議並在該等會議上投票。

本公司透過向股東發送通知及透過聯交所網站及在本公司網站(www.goldpeak.com)上公佈股東會議通告，以及向全體股東發送或提供報告或通函通知股東這些會議。為提供充足時間供股東審閱，股東周年大會通告及年報將於預定股東周年大會日期前14天透過聯交所及本公司網站公佈。我們鼓勵股東出席股東大會，以確保高水準的參與和問責制。

作為本集團對環境可持續發展承諾的一部分，本公司將以電子通訊方式向其股東發佈年度股東大會通告和代表委任表格。此外，本公司只會在收到已填妥的年報申請表格後，才會將年報印本寄予股東。

除在須經股東批准的關連交易(定義見上市規則)中被視為「關連人士」外，所有股東均有權在股東大會上投票。此外，在股東大會上，公司秘書和股份過戶登記處的代表也可以向股東提供有關管理會議規則的資訊，包括投票程序。

Shareholders' Right – Procedures to Propose a Person for Election as a Director

The details of the procedure for Shareholders to nominate a person to stand for election as Director are posted on the Company's website under the heading "Procedure for Nomination of Directors" at www.goldpeak.com.

Shareholders' Right – Enquiries to the Board

No procedure set in the Articles of Association of the Company is available for any Shareholder to put forward an enquiry to the Board. A Shareholder may, of course, at any time write to the Board at the Company's principal office at 9/F, Building 12W, 12 Science Park West Avenue, Hong Kong Science Park, New Territories, Hong Kong or by email to ir@goldpeak.com. In relation to share registration matters in Hong Kong, a member shall contact the branch share registrar in Hong Kong, namely Tricor Investor Services Limited at 17/F, Far East Finance Centre, 16 Harcourt Road, Hong Kong.

Shareholders' Participation in General Meetings

The Company's General Meetings are generally held physically in major business districts in Hong Kong which are easily accessible by public transportation, ensuring that Shareholders have the opportunity to participate effectively and vote at such meetings.

Shareholders are informed of the meetings through notices sent to them and via HKEX and made available on the Company's website at www.goldpeak.com, and reports or circulars sent or made available to all Shareholders. In order to provide ample time for the Shareholders to review, the notice of AGM, together with the annual report, is announced via HKEX and the Company's website fourteen days before the scheduled AGM date. Shareholders are encouraged to attend the General Meetings to ensure a high level of participation and accountability.

As part of the Group's commitment towards environmental sustainability, the Company will disseminate the notice of AGM and proxy form to its Shareholders by electronic means. In addition, printed annual report will only be sent to Shareholders upon receipt of duly completed annual report request forms.

All Shareholders, other than those who are considered the "Connected Persons" in connected transactions (as defined in the Listing Rules) subject to the approval by the Shareholders, are entitled to vote at General Meetings. In addition, at a General Meeting, the Company Secretary and representatives from the share registrar's office are also available to provide Shareholders with information on the rules that govern the meeting, including voting procedures.

股東參與股東大會(續)

委任代表的規則，包括投票將以投票方式進行的資訊，均載於股東大會通告中。根據本公司組織章程細則，如果任何股東無法參加實體會議，他／她可以指定一名或以上之代表，通過提前發送的代表表格出席會議，並於投票表決時代表他／她投票。代表委任表格必須在股東大會設定的時間前至少48小時送交召開股東大會通告或通告隨附的文件中指定的地點。代表委任表格連同股東大會通告一併寄予所有股東。這將使間接投資者(例如提供託管服務的銀行和資本市場服務牌照持有人)能夠被任命為代表參加實體會議。此類間接投資者將享有與直接投資者相同的在實體會議上投票的權利。

與股東的互動

股東被邀請在股東大會之前向會議主席提交他們對將要討論和決定的動議可能提出的問題。股東在會議前提交的實質性和相關問題的回答，將在活動開始前上載至聯交所及本公司的網站，並在股東大會上予以解決。本公司執行董事將在股東周年大會上報告，向股東提供進一步的闡述。

在股東大會上，股東獲邀就待討論及決定的決議提出任何進一步的問題，並有機會就影響本公司的事宜與董事及管理層交流意見及提出問題，與董事及管理層討論，並在股東大會上就決議進行表決。每個不同的問題都作為單獨的決議提出。該等決議包括對股東具有重要意義的事項，例如(如適用)建議修訂章程、授權發行額外股份、轉讓重要資產、重選董事及獨立非執行董事的薪酬。在會議上提出決議的理由載於會議通知或其附錄中。但是，如果問題相互關連形成一項重要提案，本公司可以提出「捆綁決議」，並將在會議通告或其附錄中列出理由和重大影響。有關股東周年大會議程中各個事項的詳細資訊，請參閱股東周年大會通告的解釋說明。

Shareholders' Participation in General Meetings (continued)

The rules for the appointment of proxies, including information that voting will be conducted by way of poll, are set out in the notice of General Meetings. In accordance with the Company's Articles of Association, if any Shareholder is unable to participate at the physical meeting, he/she is allowed to appoint one or more proxies to attend and, on a poll, vote on his/her behalf at the meeting through proxy forms sent in advance. The proxy forms must be deposited at such place or places specified in the notice or document accompanying the notice convening the General Meetings at least 48 hours before the time set for the General Meetings. The proxy form is sent with the notices of General Meetings to all Shareholders. This will enable indirect investors, such as banks and capital markets services licence holders which provide custodial services, to be appointed as proxies to participate in the physical meetings. Such indirect investors, where so appointed, will have the same rights as direct investors to vote at the physical meeting.

Interaction with Shareholders

Shareholders are invited to submit questions they may have on the motions to be debated and decided upon, to the Chairman of the meetings prior to the General Meetings. Responses to substantial and relevant questions submitted by Shareholders prior to the meetings are uploaded to HKEX and the Company's website prior to the events and addressed at the General Meetings. The EDs of the Company will give a presentation at the AGM, providing further elaboration to Shareholders.

At General Meetings, Shareholders are invited to put forth any further questions they may have on the motions to be debated and decided upon, and are given the opportunity to communicate their views and raise questions and discuss with the Directors and Management on matters affecting the Company, and vote on the resolutions at General Meetings. Each distinct issue is proposed as a separate resolution. Such resolutions include matters of significance to Shareholders such as, where applicable, proposed amendments to the Constitution, the authorization to issue additional shares, the transfer of significant assets, re-election of Directors, and the remuneration of INEDs. The rationale for the resolutions to be proposed at the meeting is set out in the notices to the meeting or their accompanying appendices. However, where the issues are interdependent and linked so as to form one significant proposal, the Company may propose "bundled resolutions" and will set out the reasons and material implication in the notices to the meeting or its accompanying appendices. Detailed information on each item in the AGM agenda is provided in the explanatory notes to the notice of AGM.

2025股東周年大會

2025年股東周年大會以實體會議形式舉行，地點為香港九龍尖沙咀東部科學館道17號唯港薈一樓 Silverbox宴會廳4。參與2025年股東周年大會的股東可進行即時投票。此外，彼等亦可於2025年股東周年大會舉行前或會議進行期間提交問題，及/或委任代表代其出席2025年股東周年大會、發言及投票。

除呂明華博士(獨立非執行董事)外，全體董事(包括董事局主席以及審核委員會、提名委員會、薪酬委員會及可持續發展督導委員會主席)、主要管理層(非董事者)及外聘核數師均已出席2025年股東周年大會。

於2025年股東周年大會上通過決議案

主席於2025年股東周年大會上，就各項實質上獨立的事項分別提呈獨立決議案。在審議決議案前，主席根據本公司組織章程細則第76條所賦予其作為2025年股東周年大會主席的權力，要求以電子方式就所有決議案進行投票表決。2025年股東周年大會共通過8項決議案(其中第3號決議案包含六項獨立決議案)，所有決議案均獲得超過97.93%的投票贊成。決議案全文載於日期為2025年7月30日的2025年股東周年大會通函中(當中載有2025年股東周年大會通告)，而2025年股東周年大會的投票表決結果亦已刊載於本公司及聯交所的網站。

即將舉行的2026年股東周年大會

即將舉行的2026年股東周年大會已定於2026年9月2日(星期三)以實體會議形式舉行。本公司將以郵寄方式向要求索取公司通訊印刷本的股東發出通知，告知2026年股東週年大會的相關安排。

要求索取公司通訊印刷本的股東將透過郵寄方式收取2026年股東周年大會通告，並獲發一份可分拆的代表委任表格及年度報告索取表格，以供使用。上述文件亦將於本公司的公司網站刊載。2026年股東周年大會通告及隨附的代表委任表格亦將於聯交所網站刊登。

此外，為配合本公司對環境可持續發展的承諾，本公司僅會於收到股東填妥的年報索取表格後，向其寄發印刷本年報。有關股東(或如屬公司股東，其正式委任的受委代表或代表)出席2026年股東周年大會、於會議舉行前或會議進行期間提交問題，以及於會上投票的安排，將載於本公司另行於聯交所網站刊發的公告。

2025 AGM

The 2025 AGM was held in the form of physical meeting at Silverbox Ballroom 4, 1/F, Hotel ICON, 17 Science Museum Road, Tsim Sha Tsui East, Kowloon, Hong Kong on 2 September 2025. Shareholders who participated at the 2025 AGM were able to vote in real-time. They could also be able to submit questions in advance or during the 2025 AGM and/or appoint proxy(ies) to attend, speak and vote on their behalf at the 2025 AGM.

Save for Dr LUI Ming Wah (INED), all the Directors, including the Board Chairman and the chairmen of the AC, NC, RC and SSC, together with the KMPs (not being Directors) as well as the External Auditors were in attendance at the 2025 AGM.

Resolutions passed at the 2025 AGM

The Chairman proposed separate resolutions for each substantially separate issue at the 2025 AGM. Before the resolutions were considered, the Chairman exercised his right as the Chairman of the 2025 AGM under Article 76 of the Company's Articles of Association to call a poll on all resolutions conducted by electronic means. A total of 8 resolutions were passed at the 2025 AGM (with resolution no. 3 comprising six separate resolutions), all of which were supported by over 97.93% of the votes cast. The full text of the resolutions is set out in the 2025 AGM Circular (which comprised the Notice of the 2025 AGM) dated 30 July 2025 and the poll results of the 2025 AGM are available on the respective websites of the Company and the HKEX.

Forthcoming 2026 AGM

The forthcoming 2026 AGM has been scheduled to be held in the form of physical meeting on Wednesday 2 September 2026. Shareholders who have requested to receive print copies of the corporate communications, will be informed of arrangements for the 2026 AGM through a notification sent by post.

Shareholders who have requested to receive print copies of the corporate communications, will receive, via post, the Notice of the 2026 AGM together with a copy each of the detachable proxy form and annual report request form for Shareholders' use. These documents will also be made available on the Company's corporate website. The Notice of the 2026 AGM and the accompanying proxy form will be published on the HKEX website.

Further, as part of the Company's commitment towards environmental sustainability, printed annual reports will only be sent to Shareholders upon receipt of duly completed annual report request forms. Arrangements relating to attendance at the 2026 AGM, submission of questions in advance of, or at the 2026 AGM and voting at the 2026 AGM by Shareholders or their duly appointed proxy(ies) or representative(s) in the case of corporate Shareholder(s), are set out in a separate announcement to be released by the Company on HKEX.

決議和表決的進行

為確保透明度，本公司對出席實體會議的股東／代理人進行投票，以表決股東大會上提出的所有決議。股東將被告知股東大會規則，包括投票程序。本公司將任命監票人來計算和驗證會議上的投票。贊成或反對決議案的總票數及百分比會在股東大會後透過本公司公司網站及聯交所網站適時公佈。每股有權獲得一票表決權。

在可能的情況下，所有董事將出席股東大會。董事局主席和每個董事局委員會都必須出席股東大會回答問題。如有需要，外聘核數師亦會出席該等會議，以協助董事解答股東的問題。

本公司組織章程細則允許在股東大會上進行缺席投票。如果股東無法出席股東大會，他們可委任代理人代其出席、發言和投票。

股東大會記錄

公司秘書準備股東大會記錄，其中包括股東對會議議程的實質性和相關意見或疑問，以及董事局和管理層的回應。這些會議記錄可應股東的要求提供。

所有董事，包括董事局主席、各董事局委員會主席、管理層、外聘核數師及法律顧問(如有需要)將出席股東大會，以解答股東的疑問。在每次股東周年大會上，執行董事都會作出報告，向股東介紹本公司上一年的運營和財務業績。在其他股東大會中，負責就已提呈表決的事項提供建議的外部專業顧問被邀請出席會議，以便股東直接向這些專業顧問尋求必要的澄清。

董事出席2025年股東周年大會的情況在本企業管治報告「董事局和董事局委員會會議」一節中披露。

Conduct of Resolutions and Voting

To ensure transparency, the Company conducts poll voting for Shareholders/proxies present at the physical meeting for all the resolutions proposed at the General Meeting. Shareholders are also informed of the rules, including voting procedures, governing such General Meetings. A scrutineer will be appointed to count and validate the votes cast at the meetings. The total number of votes cast for or against the resolutions and the respective percentages are also announced in a timely manner after the General Meeting via the Company's corporate and HKEX websites. Each share is entitled to one vote.

Where possible, all Directors will attend the General Meetings. The chairmen of the Board and each Board Committee are required to be present to address questions at General Meetings. External Auditors are also present at such meetings to assist the Directors to address Shareholders' queries, if necessary.

The Company's Articles of Association allow for absentia voting at General Meetings. Where Shareholders are unable to attend General Meetings, they may appoint proxies to attend, speak and vote on their behalf.

Minutes of General Meetings

The Company Secretary prepares minutes of General Meetings, which incorporate substantial and relevant comments or queries from Shareholders relating to the agenda of the meeting and responses from the Board and Management. These minutes are available to Shareholders upon their requests.

All Directors, including the Board Chairman, the chairmen of the respective Board Committees, Management, the External Auditors and legal advisors (where necessary) are present at General Meetings to address queries from the Shareholders. At each AGM, the EDs deliver presentations to update Shareholders on the Company's operations and financial performance in the preceding year. At other General Meetings, external professional advisors engaged in advising the matters being put to vote are invited to attend the meetings, so that the Shareholders can seek necessary clarification directly from these professional advisors.

Attendance of Directors at the 2025 AGM is disclosed under the section headed "Board and Board Committee Meetings" of this CG Report.

投資者關係

在2026財政年度，本公司已於2025年9月2日舉行的2025年年度股東周年大會上通過特別決議案修訂其組織章程細則。除上述所披露者外，於2026財政年度內，本公司之組織章程細則並無任何變動。本公司最新之組織章程細則已登載於本公司公司網站及聯交所之網站。

董事局已採納股東通訊政策（「通訊政策」），旨在鼓勵及促進與股東的有效溝通。其目的是確保本公司為股東行使其權利時提供及時、清晰、可靠及相關的資料。通訊政策包括股東如何召開股東大會、可向董事局提出查詢的程序以及向股東大會提出建議的程序。上述內容的充分聯繫方式可以在通訊政策中找到。本公司還提供董事選舉程序，為股東如何提名個人擔任董事提供指引。通訊政策及董事提名董事程序於本公司的公司網站公佈。年內，本公司已檢討通訊政策，並認為其切實有效。

本公司致力建立投資者的信心及信任，重視與股東及投資界的公開溝通，並已制定投資者關係政策，概述本公司的原則及框架，就有關本集團及／或影響本集團的事宜，向投資者、分析員及其他持份者提供及時、準確、平衡、清晰及相關的資料。

本公司定期就本集團的策略、運營和財務業績作出更新，讓投資者更好地了解本集團的業務和增長動力。

Investor Relations

During FY2026, the Company amended its Articles of Association by a special resolution passed at the 2025 AGM held on 2 September 2025. Save as disclosed above, there were no changes to the Company's Articles of Association during FY2026. The latest Articles of Association of the Company have been posted on the Company's corporate and HKEX websites.

The Board has adopted a Shareholders' communication policy (the "Communication Policy") which aims at promoting and facilitating effective communication with its Shareholders. The objective is to ensure that the Company provides timely, clear, reliable and relevant information for its Shareholders in exercising their rights. The Communication Policy includes how Shareholders can convene a General Meeting, the procedures by which enquiries may be put to the Board and the procedures for putting forward proposals at Shareholders' meeting. Sufficient contact details for the above can also be found in the Communication Policy. A procedure for election of Directors was also adopted to provide guidelines on how Shareholders can nominate an individual as Director. The Communication Policy and the procedures for nomination of directors are published on the Company's corporate website. During the year, the Company has reviewed the Communication Policy and considers it to be practical and effective.

The Company is committed to building investor confidence and trust and values open communication with Shareholders and the investment community and has in place an Investor Relations Policy which outlines the principles and framework for the Company to provide investors, analysts and other stakeholders with timely, accurate, balanced, clear and pertinent information on matters pertaining to and/or affecting the Group.

The Company provides investors with a better understanding of the Group's business and growth drivers, with regular updates on the Group's strategies, operations and financial performance.

Shareholder Communication

Shareholders and investors can contact the Company or access information on the Company's corporate website at www.goldpeak.com which has a dedicated 'Investor Relations' (IR) section that provides, inter alia, information on the Board, the Company's latest and past years' Corporate Governance Reports, Sustainability Reports, Annual Reports, Announcements, Press Releases and Financial Results as released by the Company on HKEX, and other information which may be relevant to investors.

The Company has adopted arrangements for electronic dissemination of corporate communications on 1 April 2026 in accordance with the Listing Rules, the Companies Ordinance and the Articles of Association of the Company. Corporate communications are published in both English and Chinese on the websites of the Company and HKEXnews. Shareholders may request to receive printed copies of corporate communications free of charge in accordance with the arrangements published on the Company's corporate website.

The Company ensures that all Shareholders are treated fairly and equitably, and informed simultaneously in an accurate and comprehensive manner regarding all material developments that impact the Company and the Group via HKEX, in line with the Company's disclosure obligation pursuant to the Listing Rules and the Companies Ordinance. There is a dedicated team in place to respond to queries from investors and maintain regular dialogue with Shareholders and a dedicated investor relations email account at ir@goldpeak.com has been set up.

Pertinent information is communicated to Shareholders primarily through timely announcements released via HKEX. To ensure the announcements are as descriptive, detailed and forthcoming as possible, the announcements are reviewed by the Board and the Company Secretary before they are released. In addition, where appropriate, announcements are prepared with the assistance of other professional advisors, such as legal advisors and financial advisors.

Corporate Website

The Company's corporate website is one of the conduits through which the Group engages with its stakeholders. Stakeholders can obtain background information and published financial information about the Group, as well as contact information should more information be required.

股息政策

本公司致力公平及可持續地回報股東，同時平衡股息支付與其資本要求，以確保在考慮本集團的財務表現、短期及長期資本要求、未來投資計劃及董事局認為適當的其他因素(包括一般全球及商業經濟狀況及任何監管因素)後，實現本公司的最佳利益。任何中期股息的支付或經股東周年大會批准後支付的末期股息，將公平及及時地支付予所有股東。本公司日期為2026年6月24日本公司2026財政年度全年業績公佈中提述，董事決議建議向於2026年9月11日(星期五)收市時載於本公司股東名冊的股東派發每股0.7港仙的末期股息。

舉報政策

本公司已制定舉報政策和程序，本公司員工和外部人員可以保密(無論匿名還是其他方式)對與會計、財務報告、內部監控、欺詐行為、賄賂和貪污、以及本公司或其附屬公司的管理層和員工涉嫌犯下的其他不當行為和違規行為、審計事項或其他事項提出問題，而不必擔心任何形式的報復。審核委員會有責任監督舉報政策，以確保在內部審計主管的協助下對其進行適當管理，根據相關程序，安排對提出的問題進行獨立調查，並採取適當的跟進行動。

根據舉報政策：

- (i) 已設有安排讓審核委員會對此類事項進行獨立調查並審查跟進行動的結果；
- (ii) 舉報人的身份被保密，並將受到保護，免受不利或不公平的待遇；及
- (iii) 明確禁止管理層對舉報人進行任何形式的報復。

Dividend Policy

The Company is committed to rewarding Shareholders fairly and sustainably, while balancing the payment of dividends with its capital requirements to ensure that the best interests of the Company are served, after taking into account the Group's financial performance, short and long-term capital requirements, future investment plans and other factors as the Board may deem appropriate including general global and business economic conditions and any regulatory factors. Any payment of interim dividend or, upon receipt of Shareholders' approval at AGMs, final dividend, will be paid to all Shareholders in an equitable and timely manner. As stated in the announcement of the Company dated 24 June 2026 relating to the annual results of the Company for FY2026, the Directors resolved to recommend the payment of a final dividend of HK0.7 cent per share to Shareholders whose names appear on the Register of Members of the Company at the close of business on Friday, 11 September 2026.

Whistleblowing Policy

The Company has established a whistleblowing policy and procedure where employees of the Company and outsiders can in confidence, whether anonymously or otherwise, raise concerns on possible improprieties and irregularities relating to accounting, financial reporting, internal controls, fraudulent acts, bribery and corruption, other matters allegedly committed by Management and staff of the Company or its subsidiaries, auditing matters or other matters without fear of reprisals in any form. The AC has the responsibility of overseeing this policy to ensure that it is properly administered with the assistance of the Head of IA. Under these procedures, arrangements are in place for independent investigation of such matters raised and for appropriate follow-up action to be taken.

Pursuant to the whistleblowing policy:

- (i) arrangements are in place for independent investigations by the AC of such matters and review of the outcome of the follow-up actions;
- (ii) the identity of the whistleblower is kept confidential and will be protected against detrimental or unfair treatment; and
- (iii) any form of disadvantage or reprisal against the whistleblower by Management is expressly prohibited.

F. 可持續性

董事局明白，可持續發展是本集團在提升持份者價值方面取得長遠成功的關鍵。在第三方的協助下，本公司每年進行重要性評估，以確定對本公司持份者很重要的關鍵環境、社會及管治問題。這些問題是本公司年度可持續發展報告的基礎。

在制定業務策略時，董事局會充份考慮環境、社會及管治事宜所帶來的風險及機遇，包括符合國際及本地標準的披露要求，以及為實現淨零經濟而須履行的企業及社會責任。

董事局已將監督和監督本集團可持續發展工作的責任委託給管理層，管理層包括執行董事、部門主管和業務單位負責人。本集團的可持續發展督導委員會負責評估及確定與本集團業務相關的環境、健康及安全相關風險。

Whistleblowing Policy (continued)

A copy of the whistleblowing policy and reporting procedure is posted on the Group's intranet encouraging the report of any behaviour or actions that anyone reasonably believes might be suspicious, against any rules/regulations/accounting standards and internal policies.

Details on the dedicated channels of communication (email and postal address) have also been made available on the Group's intranet and corporate website. A dedicated whistle-blowing email account at internal.audit@goldpeak.com has been set up for the Head of IA to receive complaints and information from all employees of the Group or other persons in order to facilitate and encourage the reporting of such matters. The AC monitors the whistleblowing complaints based on reports prepared by the Head of IA and ensures appropriate follow-up actions are taken.

F. SUSTAINABILITY

The Board recognises sustainability as the key to the Group's long-term success in enhancing the stakeholder value. Facilitated by a third party, the Company conducts materiality assessments annually to determine the key ESG issues that are important to the Company's stakeholders. These issues are foundational to the Company's annual sustainability reporting.

In formulating its business strategies, due consideration is given by the Board to risks and opportunities arising from the ESG issues, including disclosure requirements pertinent to international and local standards, and the corporate and social responsibility in contribution towards a net-zero economy.

The Board has delegated the responsibility for monitoring and overseeing the Group's sustainability efforts to Management, comprising the EDs and heads of departments, and heads of business units. The Group's SSC is tasked to evaluate and determine the environmental, health and safety related risks pertaining to the Group's businesses.

可持續發展和環境、社會及管治

本集團已建立全面的可持續發展及環境、社會及管治管治框架，為將可持續發展納入本集團業務奠定堅實基礎，並確保本集團的發展策略及其實施均考慮本集團持份者的利益及期望。該全面框架促進了溝通，並介定了團隊的角色和職責，以妥善解決環境、社會及管治問題。

董事局將可持續發展事宜納入本集團的策略制定中。相應的環境、社會及管治目標、指標、舉措和進展由行政委員會和部門主管審查，並報告給董事局批准。

金山科技的環境、社會及管治報告可在公司網站上獲取。本集團在2026財政年度的可持續發展努力和績效將在本公司的2026年度環境、社會及管治報告中更詳細地討論。符合上市規則要求的2026年度環境、社會及管治報告預計將於2026年7月下旬推出。

董事局和管理層致力於誠信經營，遵守最高標準的商業道德，並遵守所有適用的法律和監管要求。董事局已採納《董事商業行為及道德守則》（「道德守則」），並將該道德守則納入各項公司政策。《道德準則》旨在指導董事處理以下道德風險領域，並設定一個將誠信和問責制放在首位的框架：

- (i) 避免在本公司機會和其他董事局任命中發生利益衝突；
- (ii) 對董事在履行董事職責時可能獲悉的機密或專有資料保密；
- (iii) 確保遵守法律、規則和法規，包括與本公司證券交易相關的法律、規則和法規；和
- (iv) 確保公平地處理本集團的持份者，包括客戶、供應商、競爭對手和員工。

Sustainability and ESG Governance

The Group has established a comprehensive Sustainability and ESG governance framework that provides a strong foundation for incorporating sustainability into the Group's businesses and ensuring that the Group's stakeholders' interests and expectations are taken into account in the Group's development strategies and implementations. The comprehensive framework facilitates communications and defines the roles and responsibilities of the team to properly address ESG issues.

The Board incorporates sustainability issues into the strategic formulation of the Group. Corresponding ESG targets, metrics, initiatives, and progress are reviewed by the ExCo, and heads of departments and reported to the Board for approval.

Gold Peak's ESG Reports are available on its corporate website. The Group's sustainability efforts and performance for FY2026 will be discussed in more detail in the Company's 2026 ESG report. The 2026 ESG report, which meets the requirement of the Listing Rules, is expected to be available by late July 2026.

G. CORPORATE VALUE AND CONDUCT OF BUSINESS

The Board and Management are committed to conducting business with integrity and consistent with the highest standards of business ethics, and in compliance with all applicable laws and regulatory requirements. The Board has adopted a Code of Business Conduct and Ethics for the Directors (the "Ethics Code") and incorporated the Ethics Code in various corporate policies. The Ethics Code serves to guide the Directors on the following areas of ethical risk and sets a framework where integrity and accountability are paramount:

- (i) to avoid conflict of interest in corporate opportunities and other board appointments;
- (ii) to maintain confidentiality of confidential or proprietary information that a Director may learn of when discharging his/her duties as a Director;
- (iii) to ensure compliance with laws, rules and regulations, including those relating to the dealing in the Company's securities; and
- (iv) to ensure fair dealing with the Group's stakeholders including customers, suppliers, competitors and employees.

《道德準則》要求董事實踐和促進道德行為。通過採用道德準則，董事局確認將採取措施確保公司鼓勵其員工當對在任何特定情況下的最佳行動方案有疑問時，尋求主管、經理和適當人員的指導；和報告任何違反法律和公司政策的行為。

《道德守則》亦訂明董事舉報不當商業操守及不道德行為的溝通管道。

本公司還制定了《內部商業操守和道德準則》，確定了本公司在可能具有道德影響的事項方面的商業原則和做法。該準則為員工提供了一個可溝通和易於理解的框架，讓他們在組織的各個層面以及在與客戶、供應商和員工的關係中遵守本公司的原則，如誠實、正直、責任和問責制，所有員工都可在本公司內聯網上查閱該準則。

該準則提供了有關以下問題的指引：

- 利益衝突和要進行的適當披露；
- 本公司對貪污和賄賂採取零容忍立場；
- 遵守適用的法律和法規，包括與保護環境以及節約能源和自然資源相關的法律和法規；
- 遵守本公司的政策及程序，包括有關內部監控及會計的政策及程序；
- 保護和正確使用本公司的資產、機密資訊和知識產權，包括尊重第三方的知識產權；和
- 在本公司業務行為、與客戶、供應商、競爭對手以及員工的關係中進行競爭和公平交易。

The Ethics Code requires Directors to practise and promote ethical behaviour. Through the adoption of the Ethics Code, the Board affirms it shall take steps to ensure the Company encourages its employees to seek guidance from supervisors, managers and appropriate personnel when in doubt about the best course of action in any particular situation; and to report any violations of laws and Company's policies.

The Ethics Code also sets out the channel of communication for the Directors to report matters concerning improper business conduct and unethical practices.

The Company has also in place an Internal Code of Business Conduct and Ethics crystallising the Company's business principles and practices with respect to matters which may have ethical implications. The code, which provides a communicable and understandable framework for employees to observe the Company's principles such as honesty, integrity, responsibility and accountability at all levels of the organisation and in the conduct of the Company's business in their relationships with customers, suppliers and amongst employees, is available on the Company's intranet and is easily accessible by all employees.

The code provides guidance on issues such as:

- conflicts of interest and the appropriate disclosures to be made;
- the Company's zero-tolerance stance against corruption and bribery;
- compliance with applicable laws and regulations including those relating to the protection of the environment and the conservation of energy and natural resources;
- compliance with the Company's policies and procedures, including those on internal controls and accounting;
- safeguarding and proper use of the Company's assets, confidential information and intellectual property rights, including the respect of the intellectual property rights of third parties; and
- competition and fair dealing in the conduct of the Company's business, in its relationships with customers, suppliers, competitors and towards its employees.

高道德標準的承諾是本公司企業形象和業務不可或缺的一部份，為配合董事局維持高道德標準的承諾，本公司制定了以下兩項關鍵的企業政策：

- (i) 反貪污政策和指南，規定了本集團公司和每個員工在遵守和維護本集團對所有形式的貪污、賄賂和敲詐的「零容忍」立場方面的責任，並為員工提供資訊和指導，以了解如何識別、處理、解決、避免和預防在他們的工作過程中可能出現的貪污、賄賂和敲詐勒索的情況。
- (ii) 欺詐政策和指南，為可能構成欺詐行為提供了指引，並強調實施、維護和遵守本集團內部監控框架及其政策和程序的重要性。

這些政策可在公司內聯網上找到，並已分發給本集團主要附屬公司的管理人員和員工。

部分政策也被翻譯成普通話，以分發給本集團的中國員工。

本集團的個人資料政策載列了本公司如何根據適用的監管要求管理和保護個人資料的政策。

In line with the Board's commitment to maintain high ethical standards which are integral to its corporate identity and business, the Company has the following two key corporate policies in place:

- (i) Anti-Corruption Policy and Guidelines which sets out the responsibilities of the Group companies and of each employee in observing and upholding the Group's 'zero-tolerance' position against all forms of corruption, bribery and extortion and provides information and guidance to employees on how to recognise, address, resolve, avoid and prevent instances of corruption, bribery and extortion which may arise in the course of their work.
- (ii) Fraud Policy and Guidelines which provides guidance on actions which may constitute fraudulent conduct and highlights the importance of the implementation, maintenance and compliance with the internal controls framework of the Group and its policies and procedures.

These policies are available on the Company's intranet and have also been disseminated to officers and employees of the Group's key subsidiaries.

Selected policies have also been translated into Mandarin for dissemination to employees of the Group in the People's Republic of China.

The Company's policy on how it manages and protects personal data in accordance with the applicable regulatory requirements is set out in the Group's Personal Data Policy.

H. 其他

董事的證券權益

董事在本公司及其相聯法團中的權益詳情載於「董事局報告書」第134頁和135頁的「董事及總裁於本公司及其關連公司證券之權益」部分。

遵守董事證券交易的證券交易守則

本公司已採納上市規則附錄C3所載的「上市發行人董事進行證券交易的標準守則」(「標準守則」)作為其董事及高級職員進行證券交易的行為守則。

標準守則概述了香港上市公司董事在處理公司證券時所需的守則標準，旨在防止內幕交易，並確保董事在交易本公司股份時負責任地行事，並適用於本公司、其董事和員工。標準守則的主要元素如下：

- (i) 絕對禁止內幕交易 – 董事及僱員在持有內幕消息時，不得交易本公司的證券。
- (ii) 禁售買賣期 – 董事及僱員一般禁止在財務業績公佈前的特定時段(例如，年度業績公佈前60天或中期業績公佈前30天)進行交易。
- (iii) 特殊情況 – 在禁售期內進行交易的有限例外情況，例如緊迫的財務承諾，但這些需要特定的程序和批准。
- (iv) 通知及批准 – 董事必須獲得主席或指定董事的批准方可進行交易，並在某些情況下通知聯交所。

本公司已進一步向所有董事作出具體查詢，並確認其遵守證券交易守則中有關董事於2026財政年度內進行證券交易的規定標準。於2026財政年度內，本公司並無發現任何不遵守《證券交易守則》的事件。

董事和高級職員保險

董事及高級職員獲安排彌償董事及高級職員責任保險，以免彼等在擔任本集團董事及高級職員期間履行職責時所招致的任何責任。如果證明董事和高級職員存在任何疏忽、欺詐、違反職責或違反信託的行為，則他們不應獲得賠償。

H. OTHERS

Directors' Interests in Securities

The details of Directors' interests in the Company and its associated corporations can be found under the section on "Directors' and Chief Executive's interests in securities of the Company and its associated corporations" on pages 134 and 135 of the Directors' report.

Compliance with the Code for Securities Transactions for Directors' Securities Transactions

The Company has adopted the "Model Code for Securities Transactions by Directors of Listed Issuers" set out in Appendix C3 to the Listing Rules (the "Model Code") as its code of conduct regarding the Directors' and Officers' securities transactions.

The Model Code outlines the required standard of conduct for directors of listed companies in Hong Kong regarding their dealings in the company's securities. This code aims to prevent insider dealing and ensure Directors act responsibly when trading in their Company's stock and apply to the Company, its Directors and employees. The key elements of the Model Code are set out as follows:

- (i) Absolute Prohibition on Dealing with Inside Information – Directors and employees are prohibited from dealing in their company's securities when they possess inside information.
- (ii) Black-out Periods – Directors and employees are generally prohibited from dealing during specific periods before the announcement of financial results (e.g., 60 days before annual results or 30 days before half-year results).
- (iii) Exceptional Circumstances – There are limited exceptions for dealing during black-out periods, such as pressing financial commitments, but these require specific procedures and approvals.
- (iv) Notification and Clearance – Directors must obtain clearance to deal from the chairman or a designated director and notify the Stock Exchange under certain circumstances.

The Company has further made specific enquiries to all the Directors and they have confirmed their compliance with the required standards set out in the Code for Securities Transactions regarding the Directors' securities transactions during FY2026. During FY2026, no incident of non-compliance with the Code of Securities Transactions was noted by the Company.

Directors' and Officers' Insurance

The Directors and officers are indemnified under a directors' and officers' liability insurance against any liability incurred by them in the discharge of their duties while holding offices as the Directors and officers of the Group. The Directors and officers shall not be indemnified where there is any negligence, fraud, breach of duty or breach of trust proven against them.

H. 其他 (續)

根據組織章程細則及其所允許的安排，本公司一向為董事及高級職員投購董事及高級職員責任保險（「責任保險」），而本公司董事及高級職員毋須承擔任何自付額。為確保保障充足，本公司每年均會因應保險市場的最新趨勢及其他相關因素，檢討本公司的責任保險保單。有關檢討包括將保障額與其他類似公司作比較，以及考慮是否需要為董事安排獨立保險保障。按2026財政年度完成的檢討認為，現有保障水平屬充分。基於此，加上本公司向董事提供的彌償保證、保單條款涵蓋範圍廣泛，以及承保保險公司的雄厚財務實力，故毋須安排額外保險保障。

As permitted under the Articles of Association, it has been the practice of the Company to arrange Directors' and Officers' ("D&O") Liability Insurance for which Directors and officers of the Company do not have to bear any excess. To ensure sufficient cover is provided, the Company undertakes an annual review of the Company's D&O insurance policy in light of recent trends in the insurance market and other relevant factors. The review benchmarks the amount of cover against other similar companies and considers whether separate cover will be required for Directors. The conclusion of the review in FY2026 was that the level of cover was adequate and, given this, together with the indemnity provided by the Company to Directors, the broad policy wording and the financial strength of the insurance panel, no additional cover was required.

環境政策及表現

環境

本集團成立工作小組有效地監控及減低廢棄物及排放，並設有措施減少有害及無害廢料和妥善處理工業廢水及有害廢棄物。此外，本集團訂立回收指引及計劃以減廢及有效地善用資源。

The Group strives to reduce energy consumption to alleviate effects on global warming. Green building concept has been employed to reduce energy consumption in its factories. Air-conditioning, electricity and water conservation have been closely tracked and reviewed to maintain a lean and an efficient operation. Product packaging is constantly reviewed in order to reduce material usage and minimise the impact on the environment.

The Group maintains a well-established supply chain management policy to monitor the quality of suppliers. Random audits at suppliers' production sites are conducted to ensure their continual compliance with the technical requirements and quality of products, health, safety and environment standards as well as business ethics.

The production of safe and quality products has always been the top priority of the Group. The Group strives to comply with all regulatory requirements pertaining to the health and safety of its products and services. Appropriate channels have been set up to receive customer feedback for continuous improvement.

HUMAN RESOURCES

The Group is supported by a motivated workforce of approximately 6,400 people worldwide. The Group strives to provide its employees with a safe and healthy workplace and offer them fair and competitive remuneration packages. Remuneration policies and packages are reviewed regularly to ensure that compensation and benefits are in line with the market of each territory.

The Group invests in employees through development programs to enhance their soft and hard skills as well as work competence in preparation for their career development. Employees participated in various workshops and training sessions on laws and regulations, management and leadership skills, as well as language and communication during the year.

The final dividend is subject to the approval of the Shareholders at the forthcoming annual general meeting of the Company to be held on Wednesday, 2 September 2026 ("2026 AGM"). Subject to the aforesaid approval, the recommended final dividend for FY2026 will be payable on or around Thursday, 24 September 2026. Interim dividend of 1.8 HK cents per share (2025: 1.5 HK cents) was paid by the Company on 8 January 2026 for FY2026.

意見

我們已審核刊載於第146頁至第271頁有關金山科技工業有限公司(「貴公司」)及其附屬公司(統稱為「貴集團」)的綜合財務報表，此綜合財務報表包括於2026年3月31日的綜合財務狀況表、截至該日止年度的綜合損益表、綜合損益及其他全面收益表、綜合權益變動表及綜合現金流量表，以及綜合財務報表附註，包括主要會計政策及其他解釋資料。

我們認為，該等綜合財務報表已根據香港會計師公會(「香港會計師公會」)頒佈的香港財務報告準則(「香港財務報告準則」)真實而公平地反映 貴集團於2026年3月31日的綜合財務狀況及 貴集團於截至該日止年度的綜合財務表現及綜合現金流量，並已按照香港公司條例適用之披露規定妥為編製。

In our opinion, the consolidated financial statements give a true and fair view of the consolidated financial position of the Group as at 31 March 2026, and of its consolidated financial performance and its consolidated cash flows for the year then ended in accordance with HKFRS Accounting Standards as issued by the Hong Kong Institute of Certified Public Accountants (“HKICPA”) and have been properly prepared in compliance with the Hong Kong Companies Ordinance.

BASIS FOR OPINION

We conducted our audit in accordance with Hong Kong Standards on Auditing (“HKSA”) as issued by the HKICPA. Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of the Consolidated Financial Statements section of our report. We are independent of the Group in accordance with the HKICPA’s Code of Ethics for Professional Accountants (the “Code”), as applicable to audits of financial statements of public interest entities. We have also fulfilled our other ethical responsibilities in accordance with the Code. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

所佔一間聯營公司權益之減值評估及應收該聯營公司貨款之預期信貸損失

我們識別所佔位於俄羅斯從事電池相關產品貿易的一間聯營公司(「該聯營公司」)權益之減值評估及應收該聯營公司貨款之預期信貸損失為關鍵審核事項，原因是涉及 貴集團管理層對評估作出重大判斷和估算。

誠如綜合財務報表附註4所披露，於2026年3月31日， 貴集團於該聯營公司之權益及應收該聯營公司貨款之賬面總值分別為129,100,000港元及55,600,000港元。於2026年3月31日， 貴集團管理層已就於該聯營公司之權益進行減值評估，並在獨立資格估值師(「估值師」)之協助下，就應收該聯營公司貨款進行預期信貸損失評估。

根據管理層的評估， 貴集團於該聯營公司的權益並無減值跡象。 貴集團並無就於該聯營公司之權益確認減值虧損，並回撥應收該聯營公司貨款之預期信貸損失撥備1,200,000港元。上述評估詳情於綜合財務報表附註16及36披露。

Impairment assessment on interest in an associate and ECL on trade receivables from the associate

We have identified the impairment assessment on interest in an associate which is engaged in trading of battery related products in Russia (the “Associate”) and expected credit loss (“ECL”) on trade receivables from the Associate as a key audit matter due to the significant judgement and estimation exercised by the management of the Group for the assessments.

As disclosed in note 4 to the consolidated financial statements, as at 31 March 2026, the gross carrying amount of the Group’s interest in the Associate and the trade receivables from the Associate were HK\$129.1 million and HK\$55.6 million, respectively. As at 31 March 2026, the management of the Group conducted an impairment assessment on the interest in the Associate and, with the assistance of an independent qualified valuer (the “Valuer”), the ECL on the trade receivables from the Associate.

Based on management’s assessment, no impairment indicators exist for the Group’s interest in the Associate. The Group recognised no impairment loss on its interest in the Associate and written back ECL provision on the trade receivables from the Associate of HK\$1.2 million. Details of the above assessments are disclosed in notes 16 and 36 to the consolidated financial statements.

- Understanding and evaluating the Group’s impairment assessment process, including identification of impairment indicator;
- Assessing the competence, capabilities and objectivity of the Valuer;
- Understanding and assessing the impact of the current geopolitical situation, capital control measures and sanctions on Russia to the interest in the Associate and evaluating the overall reasonableness of management’s impairment assessment on the interest in the Associate; and
- In respect of the ECL on trade receivables from the Associate, assessing the reasonableness of key assumptions adopted by the Valuer, including expected loss rate and, forward looking adjustments based on market available information.

應收貨款之預期信貸損失

我們識別應收貨款之預期信貸損失為關鍵審核事項，原因是應收貨款對貴集團之綜合財務狀況而言屬重大，且於評估貴集團應收貨款於報告期末之預期信貸損失涉及主觀判斷及管理層估算。

於2026年3月31日，貴集團之應收貨款淨額為1,338,000,000港元，佔貴集團總資產約16.4%。

誠如綜合財務報表附註36所披露，貴集團管理層經考慮應收貨款之內部信貸評級、賬齡、還款記錄及／或各應收貨款之逾期情況後，按集體基準估計應收貨款(不包括應收該聯營公司貨款及信貸減值債務人)之終身虧損額。估計損失率乃根據債務人預期年期內的歷史觀察違約率計算，並就前瞻性資料作出調整。應收貨款的虧損撥備金額按資產賬面值與估計未來現金流量現值之間的差額計量，並考慮預期未來信貸虧損。

誠如綜合財務報表附註36所披露，貴集團就應收貨款確認虧損撥備淨額2,100,000港元。撇除回撥應收該聯營公司貨款虧損撥備1,200,000港元，貴集團於本年度確認應收貨款虧損撥備3,300,000港元。於2026年3月31日，貴集團之應收貨款虧損撥備(包括應收該聯營公司貨款之預期信貸損失)為44,000,000港元。

ECL of trade receivables

We identified ECL of trade receivables as a key audit matter due to the significance of trade receivables to the Group's consolidated financial position and the involvement of subjective judgement and management estimates in evaluating the ECL of the Group's trade receivables at the end of the reporting period.

As at 31 March 2026, the Group's net trade receivables amounted to HK\$1,338 million and represented approximately 16.4% of the Group's total assets.

As disclosed in note 36 to the consolidated financial statements, the management of the Group estimates the amount of lifetime ECL of trade receivables excluding trade receivables from the Associate and credit-impaired debtors based on collective basis through grouping of various debtors that have similar loss patterns, after considering internal credit ratings of trade debtors, ageing, repayment history and/or past due status of respective trade receivables. Estimated loss rates are based on historical observed default rates over the expected life of the debtors and are adjusted for forward-looking information. The loss allowance amount of the trade receivables is measured as the difference between the asset's carrying amount and the present value of estimated future cash flows with the consideration of expected future credit losses.

As disclosed in note 36 to the consolidated financial statements, the Group recognised a net amount of HK\$2.1 million of loss allowance on trade receivables. Excluding the reversal of loss allowance on trade receivable from the Associate of HK\$1.2 million, the Group recognised loss allowance of HK\$3.3 million on trade receivables for the current year. The Group's ECL on trade receivables (including the ECL on trade receivable from the Associate) as at 31 March 2026 amounted to HK\$44.0 million.

Our procedures in relation to ECL of trade receivables included:

- Understanding key controls on how the management estimates the loss allowance for trade receivables;
- Testing the integrity of information used by management to develop the collective basis including trade receivables ageing analysis as at 31 March 2026, on a sample basis, by comparing individual items in the analysis with the relevant sales invoices;
- Challenging management's basis and judgement in determining loss allowance on trade receivables as at 31 March 2026, including their identification of credit-impaired trade receivables, the reasonableness of management's grouping of the remaining trade debtors into different categories on a collective basis, and the basis of estimated loss rates applied in each category on a collective basis (with reference to historical default rates and forward-looking information); and
- Evaluating the sufficiency and appropriateness of the disclosures regarding the ECL of trade receivables in notes 22 and 36 to the consolidated financial statements.

If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact. We have nothing to report in this regard.

Gold Peak Technology Group Limited (the “Company”) is a public limited company incorporated in Hong Kong and its shares are listed on The Stock Exchange of Hong Kong Limited (the “HKEX”). The addresses of the registered office and principal place of business of the Company are disclosed in the corporate information section of the annual report.

The consolidated financial statements are presented in Hong Kong dollars (“HK\$”), which is also the functional currency of the Company.

The Company acts as an investment holding company. The activities of its principal subsidiaries and associates are set out in notes 46 and 47, respectively.

HKFRS 18 Presentation and Disclosure in Financial Statements (“HKFRS 18”), which sets out requirements on presentation and disclosures in financial statements, will replace HKAS 1 “Presentation of Financial Statements” (“HKAS 1”). This new HKFRS Accounting Standard, while carrying forward many of the requirements in HKAS 1, introduces new requirements to present specified categories and defined subtotals in the statement of profit or loss; provide disclosures on management-defined performance measures (MPMs) in the notes to the financial statements and improve aggregation and disaggregation of information to be disclosed in the financial statements. In addition, some HKAS 1 paragraphs have been moved to HKAS 8 “Accounting Policies, Changes in Accounting Estimates and Errors” (the title of which will be changed to Basis of Preparation of Financial Statements upon effective of HKFRS 18) and HKFRS 7 “Financial Instruments: Disclosures”. Minor amendments to HKAS 7 “Statement of Cash Flows” and HKAS 33 “Earnings per Share” are also made.

HKFRS 18, and amendments to other standards, will be effective for annual periods beginning on or after 1 January 2027, with early application permitted. HKFRS 18 requires retrospective application with specific transition provisions. The application of the new standard is not expected to have significant impact on the financial performance and positions of the Group in terms of recognition and measurement. However, it is expected to affect the structure and presentation of the consolidated statement of profit or loss. Additional disclosures required for the Group’s MPMs will be disclosed in a separate note to the consolidated financial statements.

3. BASIS OF PREPARATION OF CONSOLIDATED FINANCIAL STATEMENTS AND MATERIAL ACCOUNTING POLICY INFORMATION

3.1 Basis of preparation of consolidated financial statements

The consolidated financial statements have been prepared in accordance with HKFRS Accounting Standards as issued by the HKICPA. For the purpose of preparation of the consolidated financial statements, information is considered material if such information is reasonably expected to influence decisions made by primary users. In addition, the consolidated financial statements include applicable disclosures required by the Rules Governing the Listing of Securities on HKEX and by the Hong Kong Companies Ordinance.

The consolidated financial statements have been prepared on the historical cost basis except for certain properties and financial instruments, that are measured at revalued amounts or fair values at the end of each reporting period, as explained in the accounting policies set out below.

非金融資產之公平值計量計及市場參與者以最佳方式運用資產，或向會以最佳方式運用資產之其他市場參與者出售有關資產，以產生經濟利益之能力。

對於按公平值交易之金融工具及投資物業，以及於其後期間計量公平值時使用不可觀察輸入數據之估值技術而言，該估值技術會作校正，致使於首次確認時，估值技術結果相等於交易價格。

此外，就財務報告而言，公平值計量根據公平值計量的輸入數據可觀察程度及公平值計量的輸入數據對其整體的重要性分類為第1級、第2級或第3級，詳情如下：

- 第1級輸入數據是實體於計量日期可以取得的相同資產或負債於活躍市場之報價(未經調整)；
- 第2級輸入數據是就資產或負債直接或間接地可觀察之輸入數據(第1級內包括的報價除外)；及
- 第3級輸入數據是資產或負債的不可觀察輸入數據。

Historical cost is generally based on the fair value of the consideration given in exchange for goods and services.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, regardless of whether that price is directly observable or estimated using another valuation technique. In estimating the fair value of an asset or a liability, the Group takes into account the characteristics of the asset or liability if market participants would take those characteristics into account when pricing the asset or liability at the measurement date. Fair value for measurement and/or disclosure purposes in these consolidated financial statements is determined on such a basis, except for share-based payment transactions that are within the scope of HKFRS 2 “Share-based Payment” (“HKFRS 2”), leasing transactions that are accounted for in accordance with HKFRS 16 “Lease” (“HKFRS 16”), and measurements that have some similarities to fair value but are not fair value, such as net realisable value in HKAS 2 “Inventories” or value in use in HKAS 36 “Impairment of Assets” (“HKAS 36”).

A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

For financial instruments and investment properties which are transacted at fair value and a valuation technique that unobservable inputs is to be used to measure fair value in subsequent periods, the valuation technique is calibrated so that an initial recognition the results of the valuation technique equals the transaction price.

In addition, for financial reporting purposes, fair value measurements are categorised into Level 1, 2 or 3 based on the degree to which the inputs to the fair value measurements are observable and the significance of the inputs to the fair value measurement in its entirety, which are described as follows:

- Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the entity can access at the measurement date;
- Level 2 inputs are inputs, other than quoted prices included within Level 1, that are observable for the asset or liability, either directly or indirectly; and
- Level 3 inputs are unobservable inputs for the asset or liability.

3.2 重大會計政策資料

綜合基準

本綜合財務報表包含本公司及由本公司及其附屬公司控制之實體之財務報表。取得控制權是指本公司：

- 對投資對象行使權力；
- 因參與投資對象之業務而獲得或有權獲得可變回報；及
- 有能力行使其權力以影響該等回報。

倘事實及情況反映上文所列三項控制因素其中一項或多項改變，則本集團會重估是否仍然控制被投資方。

當本集團取得附屬公司之控制權，便將該附屬公司綜合入賬；當本集團失去附屬公司之控制權，便停止將該附屬公司綜合入賬。具體而言，年內收購或出售之附屬公司之收入及支出會於本集團取得控制權當日起計入綜合損益，直至本集團對該附屬公司之控制權終止當日為止。

損益及其他全面收益各項目均歸屬於本公司股東及非控股權益。附屬公司的全面收益總額歸屬於本公司股東及非控股權益，即使此舉會導致非控股權益的結餘為負數。

在必要時，本集團會將附屬公司財務報表作出調整，以令其會計政策與本集團所採用者一致。

Basis of consolidation

The consolidated financial statements incorporate the financial statements of the Company and entities controlled by the Company and its subsidiaries. Control is achieved when the Company:

- has power over the investee;
- is exposed, or has rights, to variable returns from its involvement with the investee; and
- has the ability to use its power to affect its returns.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control listed above.

Consolidation of a subsidiary begins when the Group obtains control over the subsidiary and ceases when the Group loses control of the subsidiary. Specifically, income and expenses of a subsidiary acquired or disposed of during the year are included in the consolidated statement of profit or loss from the date the Group gains control until the date when the Group ceases to control the subsidiary.

Profit or loss and each item of other comprehensive income ("OCI") are attributed to the owners of the Company and to the non-controlling interests. Total comprehensive income of subsidiaries is attributed to the owners of the Company and to the non-controlling interests even if this results in the non-controlling interests having a deficit balance.

When necessary, adjustments are made to the financial statements of subsidiaries to bring their accounting policies into line with the Group's accounting policies.

All intragroup assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

Non-controlling interests in subsidiaries are presented separately from the Group's equity therein, which represent present ownership interests entitling their holders to a proportionate share of net assets of the relevant subsidiaries upon liquidation.

Changes in the Group's interests in subsidiaries that do not result in the Group losing control over the subsidiaries are accounted for as equity transactions. The carrying amounts of the Group's relevant components of equity and the non-controlling interests are adjusted to reflect the changes in their relative interests in the subsidiaries, including re-attribution of relevant reserves between the Group and the non-controlling interests according to the Group's and the non-controlling interests' proportionate interests.

Any difference between the amount by which the non-controlling interests are adjusted, and the fair value of the consideration paid or received is recognised directly in equity and attributed to owners of the Company.

When the Group loses control of a subsidiary, the assets and liabilities of that subsidiary and non-controlling interests (if any) are derecognised. A gain or loss is recognised in profit or loss and is calculated as the difference between (i) the aggregate of the fair value of the consideration received and the fair value of any retained interest and (ii) the carrying amount of the assets (including goodwill), and liabilities of the subsidiary attributable to the owners of the Company. All amounts previously recognised in OCI in relation to that subsidiary are accounted for as if the Group had directly disposed of the related assets or liabilities of the subsidiary (i.e. reclassified to profit or loss or transferred to another category of equity as specified/permitted by applicable HKFRS Accounting Standards). The fair value of any investment retained in the former subsidiary at the date when control is lost is regarded as the fair value on initial recognition for subsequent accounting under HKFRS 9 "Financial Instruments" ("HKFRS 9") or, when applicable, the cost on initial recognition of an investment in an associate.

Business combinations or assets acquisition

Optional concentration test

Effective from 1 April 2020, the Group can elect to apply an optional concentration test, on a transaction-by-transaction basis, that permits a simplified assessment of whether an acquired set of activities and assets is not a business. The concentration test is met if substantially all of the fair value of the gross assets acquired is concentrated in a single identifiable asset or group of similar identifiable assets. The gross assets under assessment exclude cash and cash equivalents, deferred tax assets, and goodwill resulting from the effects of deferred tax liabilities. If the concentration test is met, the set of activities and assets is determined not to be a business and no further assessment is needed.

資產收購

當本集團收購一組不構成業務之資產及負債，本集團首先將購買價分配至其後根據公平值模型計量的投資物業及金融資產／金融負債各自之公平值，隨後按於購買日期各自相對之公平值將購買價餘額分配至其他個別可識別資產及負債，藉此識別並確認所收購之個別可識別資產及所承擔負債。該項交易並無產生商譽或議價收購收益。

業務合併

業務乃包含可共同對創造產出的能力做出重大貢獻的輸入及實質性流程的一套整合活動及資產。倘收購的流程對繼續生產產出的能力至關重要，包括具備執行相關流程所必需的技能、知識或經驗的組織勞動力，或對持續生產產出的能力有重大貢獻，以及被認為屬獨特或稀缺，或在無重大成本、努力或持續生產產出能力出現延遲的情況下不可取代，則收購的流程被認為屬實質性。

收購附屬公司使用收購法列賬。業務合併轉讓之代價乃按公平值計量，公平值乃按於收購日本集團為交換被收購者之控制權而轉移之資產、產生之負債及發行股本權益之總額計算。相關收購成本一般於產生時在損益確認。

Asset acquisitions

When the Group acquires a group of assets and liabilities that do not constitute a business, the Group identifies and recognises the individual identifiable assets acquired and liabilities assumed by allocating the purchase price first to investment properties which are subsequently measured under fair value model and financial assets/financial liabilities at the respective fair values, the remaining balance of the purchase price is then allocated to the other identifiable assets and liabilities on the basis of their relative fair values at the date of purchase. Such a transaction does not give rise to goodwill or bargain purchase gain.

Business combinations

A business is an integrated set of activities and assets which includes an input and a substantive process that together significantly contribute to the ability to create outputs. The acquired processes are considered substantive if they are critical to the ability to continue producing outputs, including an organized workforce with the necessary skills, knowledge, or experience to perform the related processes or they significantly contribute to the ability to continue producing outputs and are considered unique or scarce or cannot be replaced without significant cost, effort, or delay in the ability to continue producing outputs.

Acquisitions of businesses are accounted for using the acquisition method. The consideration transferred in a business combination is measured at fair value, which is calculated as the sum of the acquisition-date fair values of the assets transferred by the Group, liabilities incurred by the Group to the former owners of the acquiree and the equity interests issued by the Group in exchange for control of the acquiree. Acquisition-related costs are generally recognised in profit or loss as incurred.

The identifiable assets acquired and liabilities assumed must meet the definitions of an asset and a liability in the Conceptual Framework for Financial Reporting (the “Conceptual Framework”) except for transactions and events within the scope of HKAS 37 “Provisions, Contingent Liabilities (“HK (IFRIC)-Int 21”) and Contingent Assets” (“HKAS 37”) or HK (IFRIC)-Int 21 Levies, in which the Group applies HKAS 37 or HK (IFRIC)-Int 21 instead of the Conceptual Framework to identify the liabilities it has assumed in a business combination. Goodwill is measured as the excess of the sum of the consideration transferred, the amount of any non-controlling interests in the acquiree, and the fair value of the acquirer’s previously held equity interest in the acquiree (if any) over the net amounts of the identifiable assets acquired and the liabilities assumed as at acquisition date. If, after re-assessment, the net amount of the identifiable assets acquired and liabilities assumed exceeds the sum of the consideration transferred, the amount of any non-controlling interests in the acquiree and the fair value of the acquirer’s previously held interest in the acquiree (if any), the excess is recognised immediately in profit or loss as a bargain purchase gain.

Goodwill

Goodwill arising on an acquisition of a business is carried at cost as established at the date of acquisition of the business (see the accounting policy above) less accumulated impairment losses, if any.

For the purposes of impairment testing, goodwill is allocated to each of the Group's cash-generating units ("CGUs") (or group of CGUs) that is expected to benefit from the synergies of the combinations, which represent the lowest level at which the goodwill is monitored for internal management purposes and not larger than an operating segment.

A CGU (or group of CGUs) to which goodwill has been allocated is tested for impairment annually or more frequently whenever there is indication that the unit may be impaired. For goodwill arising on an acquisition in a reporting period, the CGU (or group of CGUs) to which goodwill has been allocated is tested for impairment before the end of that reporting period. If the recoverable amount is less than its carrying amount, the impairment loss is allocated first to reduce the carrying amount of any goodwill and then to the other assets on a pro-rata basis based on the carrying amount of each asset in the unit (or group of CGUs).

On disposal of the relevant CGU or any of the CGU within the group of CGUs, the attributable amount of goodwill is included in the determination of the amount of profit or loss on disposal. When the Group disposes of an operation within the CGU (or a CGU within a group of CGUs), the amount of goodwill disposed of is measured on the basis of the relative values of the operation (or the CGU) disposed of and the portion of the CGU (or the group of CGUs) retained.

聯營公司為本集團可對其行使重大影響力的實體。所謂重大影響力，是指參與投資對象財政及營運決策的權力，但並非控制或聯手控制該等決策。

聯營公司的業績、資產及負債以權益會計法於該等綜合財務報表入賬處理。就權益會計法而言所用的聯營公司財務報表，乃使用本集團在類似情況就類似交易及事件採用的一致會計政策予以編製。根據權益法，於聯營公司之投資初步按成本(其後經調整以確認本集團應佔聯營公司損益及其他全面收益及除損益及其他全面收益以外的淨資產變動)於綜合財務狀況表確認。倘本集團應佔聯營公司的虧損超過本集團所持該聯營公司之權益(包括實際上屬於本集團於該聯營公司投資淨值一部份之任何長期權益)，則本集團停止確認其應佔之進一步虧損。額外虧損僅按本集團已承擔之法定或推定責任或已代表該聯營公司支付款項的數額確認。

於聯營公司之投資按權益會計法入賬，由該投資對象成為一間聯營公司開始。在收購一間聯營公司時，任何投資成本超出本集團應佔投資方可識別資產及負債之公平淨值之差額確認為商譽，並已包括在投資的賬面值中。本集團應佔可識別資產及負債淨公平值超出收購成本之任何差額，在重新評估後即時確認於該投資收購年度之損益。

本集團釐定是否有於聯營公司的投資減值之客觀證據。如有需要，投資之全部賬面值(包括商譽)會根據香港會計準則第36號作為單一資產進行減值測試，方法為將可收回金額(即使用價值與公平值減銷售成本之較高者)與賬面值作比較。任何已確認之減值虧損不會分配至構成投資賬面值一部份之任何資產(包括商譽)。倘其後投資之可收回金額增加，則根據香港會計準則第36號確認該減值虧損之撥回。

Investments in associates

An associate is an entity over which the Group has significant influence. Significant influence is the power to participate in the financial and operating policy decisions of the investee but is not control or joint control over those policies.

The results and assets and liabilities of associates are incorporated in these consolidated financial statements using the equity method of accounting. The financial statements of associates used for equity accounting purposes are prepared using uniform accounting policies as those of the Group for like transactions and events in similar circumstances. Under the equity method, an investment in an associate is initially recognised in the consolidated statement of financial position at cost and adjusted thereafter to recognise the Group's share of the profit or loss and OCI of the associate and changes in net assets of the associate other than profit or loss and OCI. When the Group's share of losses of an associate exceeds the Group's interest in that associate (which includes any long-term interests that, in substance, form part of the Group's net investment in the associate), the Group discontinues recognising its share of further losses. Additional losses are recognised only to the extent that the Group has incurred legal or constructive obligations or made payments on behalf of the associate.

An investment in an associate is accounted for using the equity method from the date on which the investee becomes an associate. On acquisition of the investment in an associate, any excess of the cost of the investment over the Group's share of the net fair value of the identifiable assets and liabilities of the investee is recognised as goodwill, which is included within the carrying amount of the investment. Any excess of the Group's share of the net fair value of the identifiable assets and liabilities over the cost of the investment, after reassessment, is recognised immediately in profit or loss in the period in which the investment is acquired.

The Group assesses whether there is an objective evidence that the interest in an associate may be impaired. When any objective evidence exists, the entire carrying amount of the investment (including goodwill) is tested for impairment in accordance with HKAS 36 as a single asset by comparing its recoverable amount (higher of value in use and fair value less costs of disposal) with its carrying amount. Any impairment loss recognised is not allocated to any asset, including goodwill, that forms part of the carrying amount of the investment. Any reversal of that impairment loss is recognised in accordance with HKAS 36 to the extent that the recoverable amount of the investment subsequently increases.

When the Group ceases to have significant influence over an associate, it is accounted for as a disposal of the entire interest in the investee with a resulting gain or loss being recognised in profit or loss. When the Group retains an interest in the former associate and the retained interest is a financial asset within the scope of HKFRS 9, the Group measures the retained interest at fair value at that date and the fair value is regarded as its fair value on initial recognition. The difference between the carrying amount of the associate and the fair value of any retained interest and any proceeds from disposing of the relevant interest in the associate is included in the determination of the gain or loss on disposal of the associate. In addition, the Group accounts for all amounts previously recognised in OCI in relation to that associate on the same basis as would be required if that associate had directly disposed of the related assets or liabilities. Therefore, if a gain or loss previously recognised in OCI by that associate would be reclassified to profit or loss on the disposal of the related assets or liabilities, the Group reclassifies the gain or loss from equity to profit or loss (as a reclassification adjustment) upon disposal/partial disposal of the relevant associate.

When the Group reduces its ownership interest in an associate or a joint venture but the Group continues to use the equity method, the Group reclassifies to profit or loss the proportion of the gain or loss that had previously been recognised in OCI relating to that reduction in ownership interest if that gain or loss would be reclassified to profit or loss on the disposal of the related assets or liabilities.

When a group entity transacts with an associate of the Group, profits and losses resulting from the transactions with the associate are recognised in the Group's consolidated financial statements only to the extent of interests in the associate that are not related to the Group.

In applying HKFRS 9 to long-term interests, the group does not take into account adjustments to their carrying amount required by HKAS 28 "Investments in Associates and Joint Ventures" ("HKAS 28") (i.e. adjustments to the carrying amount of long-term interests arising from the allocation of losses of the investee or assessment of impairment in accordance with HKAS 28).

當本集團於達成履約責任時(或就此)確認收入，即當與特定履約責任相關的商品或服務的「控制權」轉移予客戶時。

履約責任指一項明確貨品或服務(或一批貨品或服務)或一系列大致相同之明確貨品或服務。

倘符合以下其中一項條件，控制權隨時間轉移，收入則可參考完成相關履約責任的進度而按時間確認：

- 客戶同時收取及享用由本集團履約所帶來的利益；
- 本集團履約導致創建及提升於本集團履約時由客戶控制的資產；或
- 本集團履約並無產生對本集團有替代用途的資產，且本集團可享有強制執行權，以收回至今已履約部份的款項。

否則，收入於客戶獲得明確商品或服務的控制權時確認。

本集團自銷售音響、電子及揚聲器和電池產品所產生的營業額乃於某一時間點確認。根據香港財務報告準則第15號「來自客戶合約之收入」(「香港財務報告準則第15號」)的控制權轉移法，該等銷售營業額乃於獲得客戶接受時確認，即按協定運送條款及客戶指定位置交付貨品，以及當客戶有能力主導該等產品的使用及獲得該等產品絕大部份餘下利益的時間點。

合約負債指本集團向客戶轉移貨品或服務之責任，而本集團已就此向該客戶收取代價(或代價已到期收取)。

當本集團確定所發生的額外成本是為了支持或直接與從客戶處獲得的製造合約相關，並用於達成(或持續達成)其履約義務時，該合約成本即被資本化。

Revenue from contracts with customers

The Group recognises revenue when (or as) a performance obligation is satisfied, i.e. when “control” of the goods or services underlying the particular performance obligation is transferred to the customer.

A performance obligation represents a good or service (or a bundle of goods or services) that is distinct or a series of distinct goods or services that are substantially the same.

Control is transferred over time and revenue is recognised over time by reference to the progress towards complete satisfaction of the relevant performance obligation if one of the following criteria is met:

- the customer simultaneously receives and consumes the benefits provided by the Group’s performance as the Group performs;
- the Group’s performance creates or enhances an asset that the customer controls as the Group performs; or
- the Group’s performance does not create an asset with an alternative use to the Group and the Group has an enforceable right to payment for performance completed to date.

Otherwise, revenue is recognised at a point in time when the customer obtains control of the distinct good or service.

The revenue of the Group arising from sales of audio, electronics and acoustics, and batteries products is recognised at a point in time. Under the transfer-of-control approach in HKFRS 15 “Revenue from Contracts with Customers” (“HKFRS 15”), revenue from these sales is recognised when customer acceptance has been obtained, which is the point of time when the goods are delivered based on the agreed shipping terms and the location specified by the customers, and when the customer has the ability to direct the use of these products and obtain substantially all of the remaining benefits of these products.

A contract liability represents the Group’s obligation to transfer goods or services to a customer for which the Group has received consideration (or an amount of consideration is due) from the customer.

A contract cost is capitalised when the Group determines that the incremental costs incurred are in support of or directly related to the manufacturing contracts obtained from customers and to meet (or continuing to meet) its performance obligations.

租賃之定義

本集團於合約開始時根據香港財務報告準則第16號的定義評估合約是否租賃或包含租賃。除非合約條款及條件其後有變，否則不會重新評估該合約。

本集團作為承租人

代價分配至合約組成部份

就包含一項租賃組成部份及一項或多項額外的租賃或非租賃組成部份的合約而言，本集團根據租賃組成部份的相對單獨價格及非租賃組成部份的單獨價格總額將合約代價分配至各租賃組成部份。非租賃組成部份獨立於租賃組成部份，並應用其他適用標準入賬。

短期租賃及低價值資產租賃

本集團對於租賃年期為自開始日期起計12個月或以內且不包含購買選擇權之租賃房產、機械及設備和其他租賃應用短期租賃確認豁免，並就低價值資產租賃應用確認豁免。短期租賃及低價值資產租賃之租賃付款於租賃年期内以直線法或另一系統化基準確認為開支。

使用權資產

使用權資產之成本包括：

- 首次計量租賃負債之金額；
- 於開始日期或之前支付之任何租賃付款減任何已收租賃獎勵；
- 本集團產生之任何初始直接成本；及
- 本集團將於拆除及移除相關資產、復修相關資產位處之場址或將相關資產復修至租賃條款規定之狀況時產生之估計成本。

Leases

Definition of a lease

The Group assesses whether a contract is or contains a lease based on the definition under HKFRS 16 at inception of the contract. Such contract will not be reassessed unless the terms and conditions of the contract are subsequently changed.

The Group as a lessee

Allocation of consideration to components of a contract

For a contract that contains a lease component and one or more additional lease or non-lease components, the Group allocates the consideration in the contract to each lease component on the basis of the relative stand-alone price of the lease component and the aggregate stand-alone price of the non-lease components. Non-lease components are separated from lease component and are accounted for by applying other applicable standards.

Short-term leases and leases of low-value assets

The Group applies the short-term lease recognition exemption to leases of leasehold building, machinery and equipment and others that have a lease term of 12 months or less from the commencement date and do not contain a purchase option. It also applies the recognition exemption for lease of low-value assets. Lease payments on short-term leases and leases of low-value assets are recognised as expense on a straight-line basis or another systematic basis over the lease term.

Right-of-use assets

The cost of right-of-use assets includes:

- the amount of the initial measurement of the lease liability;
- any lease payments made at or before the commencement date, less any lease incentives received;
- any initial direct costs incurred by the Group; and
- an estimate of costs to be incurred by the Group in dismantling and removing the underlying assets, restoring the site on which it is located or restoring the underlying asset to the condition required by the terms and conditions of the lease.

可退回租賃按金

已付之可退回租賃按金根據香港財務報告準則第9號入賬，首次按公平值計量。對於首次確認時公平值之調整會被視為額外租賃付款，並計入使用權資產之成本。

租賃負債

於租賃開始日期，本集團按於該日未支付之租賃付款之現值確認及計量租賃負債。計算租賃付款之現值時，倘租賃內含之利率無法輕易地釐定，則本集團會使用於租賃開始日期之增量借款利率。

租賃付款包括：

Refundable rental deposits

Refundable rental deposits paid are accounted under HKFRS 9 and initially measured at fair value. Adjustments to fair value at initial recognition are considered as additional lease payments and included in the cost of right-of-use assets.

Lease liabilities

At the commencement date of a lease, the Group recognises and measures the lease liability at the present value of lease payments that are unpaid at that date. In calculating the present value of lease payments, the Group uses the incremental borrowing rate at the lease commencement date if the interest rate implicit in the lease is not readily determinable.

The lease payments include:

- fixed payments (including in-substance fixed payments) less any lease incentives receivable;
- variable lease payments that depend on an index or a rate, initially measured using the index or rate as at the commencement date; and

Classification and measurement of leases

Leases for which the Group is a lessor are classified as finance or operating leases. Whenever the terms of the lease transfer substantially all the risks and rewards incidental to ownership of an underlying asset to the lessee, the contract is classified as a finance lease. All other leases are classified as operating leases.

Rental income from operating leases is recognised in profit or loss on a straight-line basis over the term of the relevant lease. Initial direct costs incurred in negotiating and arranging an operating lease are added to the carrying amount of the leased asset, and such costs are recognised as an expense on a straight-line basis over the lease term except for investment properties measured under fair value model.

Allocation of consideration to components of a contract

When a contract includes both leases and non-lease components, the Group applies HKFRS 15 to allocate consideration in a contract to lease and non-lease components. Non-lease components are separated from lease component on the basis of their relative stand-alone selling prices.

Refundable rental deposits

Refundable rental deposits received are accounted for under HKFRS 9 and initially measured at fair value. Adjustments to fair value at initial recognition are considered as additional lease payments from lessees.

Lease modification

Changes in considerations of lease contracts that were not part of the original terms and conditions are accounted for as lease modifications, including lease incentives provided through forgiveness or reduction of rentals.

The Group accounts for a modification to an operating lease as a new lease from the effective date of the modification, considering any prepaid or accrued lease payments relating to the original lease as part of the lease payments for the new lease.

Right-of-use assets and lease liability with fixed payments are subsequently measured in accordance with the Group's accounting policies above.

If the fair value of the consideration for the sale does not equal the fair value of the asset, or if the payments for the lease are not at market rates, the Group makes the following adjustments to measure the sale proceeds at fair value:

Property, plant and equipment

Property, plant and equipment are tangible assets that are held for use in the production or supply of goods or services, or for administrative purposes (other than asset under construction and freehold land as described below) are stated in the consolidated statement of financial position at cost or fair value less subsequent accumulated depreciation and subsequent accumulated impairment losses, if any.

Advantage has been taken of the transitional relief provided by HKAS 16 "Property, Plant and Equipment" from the requirement to make regular revaluations of the Group's land and buildings which had been carried at revalued amounts prior to 30 September 1995, and accordingly no further revaluation of land and buildings is carried out. Prior to 30 September 1995, the revaluation increase arising on the revaluation of these assets was credited to the property revaluation reserve. Any future decreases in value of these assets will be dealt with as an expense to the extent that they exceed the balance, if any, on the property revaluation reserve relating to a previous revaluation of the same asset. On the subsequent sale or retirement of a revalued asset, the corresponding revaluation surplus is transferred to retained profits.

Freehold land is not depreciated and is measured at cost less subsequent accumulated impairment losses.

Asset in the course of construction for production, supply or administrative purposes are carried at cost, less any recognised impairment loss. Costs include any costs directly attributable to bringing the asset to the location and condition necessary for it to be capable of operating in the manner intended by management and, for qualifying assets, borrowing costs capitalised in accordance with the Group's accounting policy. Depreciation of these assets, on the same basis as other property assets, commences when the assets are ready for their intended use.

When the Group makes payments for ownership interests of properties which includes both leasehold land and building elements, the entire consideration is allocated between the leasehold land and the building elements in proportion to the relative fair values at initial recognition. To the extent the allocation of the relevant payments can be made reliably, interest in leasehold land that is accounted for as an operating lease is presented as "right-of-use assets" in the consolidated statement of financial position. When the consideration cannot be allocated reliably between non-lease building element and undivided interest in the underlying leasehold land, the entire properties are classified as property, plant and equipment.

物業、廠房及設備項目會在出售或預期繼續使用資產不會帶來未來經濟利益時剔除確認。就出售或註銷物業、廠房及設備之任何損益(按出售所得款項與該資產之賬面值之差額計算)於損益中確認。

投資物業

Depreciation is recognised so as to write off the cost or valuation of assets other than properties under construction and freehold land less their residual values over their estimated useful lives, using the straight-line method or reducing balance method. The estimated useful lives, residual values and depreciation method are reviewed at the end of each reporting period, with the effect of any changes in estimate accounted for on a prospective basis.

An item of property, plant and equipment is derecognised upon disposal or when no future economic benefits are expected to arise from the continued use of the asset. Any gain or loss arising on the disposal or retirement of an item of property, plant and equipment is determined as the difference between the sales proceeds and the carrying amount of the assets and is recognised in profit or loss.

Investment properties

Investment properties are properties held to earn rentals and/or for capital appreciation. Investment properties include land held for undetermined future use, which is regarded as held for capital appreciation purpose.

Investment properties are initially measured at cost, including any directly attributable expenditure. Subsequent to initial recognition, investment properties are measured at fair value, adjusted to exclude any prepaid or accrued operating lease income.

Gains or losses arising from changes in the fair value of investment properties are included in profit or loss for the period in which they arise.

An investment property is derecognised upon disposal or when the investment property is permanently withdrawn from use and no future economic benefits are expected from its disposal. Any gain or loss arising on derecognition of the property (calculated as the difference between the net disposal proceeds and the carrying amount of the asset) is included in profit or loss in the period in which the property is derecognised.

商標及專利最初以購入成本計量並分別以其估計有用年期約20年及2年以直線法攤銷。

購入製造新產品專業訣竅之既得權利之成本，由既得日期起計，以直線法分3年至5年或按專利許可年期(取較短者)攤銷。

估計可用年期及攤銷方法於報告期結算日進行審閱，而任何估計變動的影響則按前瞻基準入賬。

Intangible assets

(a) Intangible assets acquired separately – Trademarks, patent and technical know-how

Trademarks and patent are measured initially at purchase cost and are amortised on a straight-line basis over their estimated useful lives, which are estimated to be twenty years and two years respectively.

The cost of acquiring rights to technical know-how for the production of new products is amortised on a straight-line method, over a period of three to five years from the date of acquisition or over the licence period, whichever is shorter.

The estimated useful life and amortisation method are reviewed at the end of each reporting period, with the effect of any changes in estimate being accounted for on a prospective basis.

(b) Internally-generated intangible assets – Research and development expenditure

Expenditure on research activities is recognised as an expense in the period in which it is incurred.

An internally-generated intangible asset arising from development activities is recognised if, and only if, all of the following have been demonstrated:

- the technical feasibility of completing the intangible asset so that it will be available for use or sale;
- the intention to complete the intangible asset and use or sell it;
- the ability to use or sell the intangible asset;
- how the intangible asset will generate probable future economic benefits;
- the availability of adequate technical, financial and other resources to complete the development and to use or sell the intangible asset; and
- the ability to measure reliably the expenditure attributable to the intangible asset during its development.

首次被確認為內部產生無形資產的金額，為無形資產符合以上確認標準日起計支出的總和。如沒內部產生無形資產可被確認，開發支出於產生期間從損益中扣除。

The amount initially recognised for internally-generated intangible asset is the sum of the expenditure incurred from the date when the intangible asset first meets the recognition criteria above. Where no internally-generated intangible asset can be recognised, development expenditure is charged to profit or loss in the period in which it is incurred.

Subsequent to initial recognition, internally-generated intangible assets are reported at cost less accumulated amortisation and accumulated impairment losses, if any, on the same basis as intangible assets that are acquired separately. The resultant asset is amortised on a straight-line basis over its estimated useful life, not exceeding ten years, commencing in the year when the product is put into commercial use.

(c) Intangible assets acquired in a business combination – Customer relationship

Intangible assets acquired in a business combination are recognised separately from goodwill and are initially recognised at their fair value at the acquisition date, which is regarded as their cost.

The customer relationship is amortised using straight-line method, over a period of five years. Subsequent to initial recognition, the customer relationship is recorded at cost less accumulated amortisation and accumulated impairment losses.

An intangible asset is derecognised on disposal, or when no future economic benefits are expected from use or disposal. Gains and losses arising from derecognition of an intangible asset, measured as the difference between the net disposal proceeds and the carrying amount of the asset, are recognised in profit or loss when the asset is derecognised.

物業、廠房及設備、使用權資產及無形資產的可收回金額按個別進行估計。當未能個別估計資產之可收回金額，則由本集團估計該資產所屬現金產生單位之可收回金額。

在現金產生單位進行減值測試期間，當可以建立合理及一致的分配基礎時，公司資產將分配至各個現金產生單位，否則將其分配至可以建立合理及一致的分配基礎的最小現金產生單位。公司資產所屬的現金產生單位或一組現金產生單位釐定可收回金額，並與相關現金產生單位或一組現金產生單位的賬面值進行比較。

可收回金額乃公平值減出售成本與使用價值的較高者。在評估使用價值時，估計未來現金流量使用稅前貼現率貼現至其現值，該貼現率反映當前市場估計之貨幣時間價值及估計未來現金流量時並無調整之有關資產(或現金產生單位)之特定風險。

Impairment on property, plant and equipment, right-of-use assets and intangible assets other than goodwill

At the end of the reporting period, the Group reviews the carrying amounts of its property, plant and equipment, right-of-use assets and intangible assets with finite useful lives to determine whether there is any indication that these assets have suffered an impairment loss. If any such indication exists, the recoverable amount of the relevant asset is estimated in order to determine the extent of the impairment loss, if any.

The recoverable amount of property, plant and equipment, right-of-use assets and intangible assets are estimated individually. When it is not possible to estimate the recoverable amount individually, the Group estimates the recoverable amount of the CGU to which the asset belongs.

In testing a CGU for impairment, corporate assets are allocated to the relevant CGU when a reasonable and consistent basis of allocation can be established, or otherwise they are allocated to the smallest group of CGUs for which a reasonable and consistent allocation basis can be established. The recoverable amount is determined for the CGU or group of CGUs to which the corporate asset belongs, and is compared with the carrying amount of the relevant CGU or group of CGUs.

Recoverable amount is the higher of fair value less costs of disposal and value in use. Provisions

The amount recognised as a provision is the best estimate of the consideration required to settle the present obligation at the end of the reporting period, taking into account the risks and uncertainties surrounding the obligation. When a provision is measured using the cash flows estimated to settle the present obligation, its carrying amount is the present value of those cash flows (where the effect of the time value of money is material).

Restructurings

A restructuring provision is recognised when the Group has developed a detailed formal plan for the restructuring and has raised a valid expectation in those affected that it will carry out the restructuring by starting to implement the plan or announcing its main features to those affected by it. The measurement of a restructuring provision includes only the direct expenditures arising from the restructuring, which are those amounts that are both necessarily entailed by the restructuring and not associated with the ongoing activities of the entity.

Contingent liabilities

A contingent liability is a present obligation arising from past events but is not recognised because it is not probable that an outflow of resources embodying economic benefits will be required to settle the obligation or the amount of the obligation cannot be measured with sufficient reliability.

Where the Group is jointly and severally liable for an obligation, the part of the obligation that is expected to be met by other parties is treated as a contingent liability and it is not recognised in the consolidated financial statements.

The Group assesses continually to determine whether an outflow of resources embodying economic benefits has become probable. If it becomes probable that an outflow of future economic benefits will be required for an item previously dealt with as a contingent liability, a provision is recognised in the consolidated financial statements in the reporting period in which the change in probability occurs, except in the extremely rare circumstances where no reliable estimate can be made.

Investments in equity instruments at FVTOCI are initially measured at fair value plus transaction costs. Lifetime ECL represents the ECL that will result from all possible default events over the expected life of the relevant instrument. In contrast, 12-month ECL ("12m ECL") represents the portion of lifetime ECL that is expected to result from default events that are possible within 12 months after the reporting date. Assessment are done based on the Group's historical credit loss experience, adjusted for factors that are specific to the debtors, general economic conditions and an assessment of both the current conditions at the reporting date as well as the forecast of future conditions.

The Group always recognises lifetime ECL for trade and bills receivables. The ECL on these assets are assessed individually and/or collectively using a collective basis with appropriate groupings.

For all other instruments, the Group measures the loss allowance equal to 12m ECL, unless when there has been a significant increase in credit risk since initial recognition, the Group recognises lifetime ECL. The assessment of whether lifetime ECL should be recognised is based on significant increases in the likelihood or risk of a default occurring since initial recognition.

In assessing whether the credit risk has increased significantly since initial recognition, the Group compares the risk of a default occurring on the financial instrument as at the reporting date with the risk of a default occurring on the financial instrument as at the date of initial recognition. In making this assessment, the Group considers both quantitative and qualitative information that is reasonable and supportable, including historical experience and forward-looking information that is available without undue cost or effort.

In particular, the following information is taken into account when assessing whether credit risk has increased significantly:

- an actual or expected significant deterioration in the financial instrument's external (if available) or internal credit rating;
- significant deterioration in external market indicators of credit risk, e.g. a significant increase in the credit spread, the credit default swap prices for the debtor;
- existing or forecast adverse changes in business, financial or economic conditions that are expected to cause a significant decrease in the debtor's ability to meet its debt obligations;
- an actual or expected significant deterioration in the operating results of the debtor;
- an actual or expected significant adverse change in the regulatory, economic, or technological environment of the debtor that results in a significant decrease in the debtor's ability to meet its debt obligations.

Irrespective of the outcome of the above assessment, the Group presumes that the credit risk has increased significantly since initial recognition when contractual payments are more than 30 days past due, unless the Group has reasonable and supportable information that demonstrates otherwise.

For financial guarantee contracts, the date that the Group becomes a party to the irrevocable commitment is considered to be the date of initial recognition for the purposes of assessing impairment. In assessing whether there has been a significant increase in the credit risk since initial recognition, the Group considers the changes in the risk that the specified debtor will default on the contract.

The Group regularly monitors the effectiveness of the criteria used to identify whether there has been a significant increase in credit risk and revises them as appropriate to ensure that the criteria are capable of identifying significant increase in credit risk before the amount becomes past due.

就內部信貸風險管理而言，本集團認為，倘若內部生成或自外部來源獲得的資料顯示債務人不太可能向其債權人(包括本集團)悉數付款(不考慮本集團持有的任何抵押品)，則發生違約事件。

無論上述情形如何，本集團認為，倘若金融資產逾期超過90日，則發生違約事件，除非本集團有合理及支持資料能說明更寬鬆的違約標準更為合適，則作別論。

(ii) Definition of default

For internal credit risk management, the Group considers an event of default occurs when information developed internally or obtained from external sources indicates that the debtor is unlikely to pay its creditors, including the Group, in full (without taking into account any collaterals held by the Group).

Irrespective of the above, the Group considers that default has occurred when a financial asset is more than 90 days past due unless the Group has reasonable and supportable information to demonstrate that a more lagging default criterion is more appropriate.

(iii) Credit-impaired financial assets

A financial asset is credit-impaired when one or more events that have a detrimental impact on the estimated future cash flows of that financial asset have occurred. Evidence that a financial asset is credit-impaired includes observable data about the following events:

- (a) significant financial difficulty of the issuer or the borrower;
- (b) a breach of contract, such as a default or past due event;
- (c) the lender(s) of the borrower, for economic or contractual reasons relating to the borrower's financial difficulty, having granted to the borrower a concession(s) that the lender(s) would not otherwise consider; or
- (d) it is becoming probable that the borrower will enter bankruptcy or other financial reorganisation.

(iv) Write-off policy

The Group writes off a financial asset when there is information indicating that the counterparty is in severe financial difficulty and there is no realistic prospect of recovery, for example, when the counterparty has been placed under liquidation or has entered into bankruptcy proceedings. Financial assets written off may still be subject to enforcement activities under the Group's recovery procedures, taking into account legal advice where appropriate. A write-off constitutes a derecognition event. Any subsequent recoveries are recognised in profit or loss.

預期信貸損失的計量取決於違約概率、違約損失率(即如存在違約時的損失程度)及違約風險。對違約概率及違約損失率的評估基於歷史數據，並就前瞻性信息作出調整。預期信貸損失的估計反映以發生相關違約的風險為權重的無偏概率加權釐定之金額。

一般而言，預期信貸損失為本集團按初始確認時釐定的有效利率貼現，按照合約應收到的所有合約現金流量與本集團預計收到的所有現金流量之間的差額。

就財務擔保合約而言，由於根據擔保工具條款，本集團僅於債務人違約時作出付款。因此，預期虧損為就持有人產生信貸虧損作出補償之預期付款現值減本集團預期從持有人、債務人或任何其他人士收取之任何款項。

對於無法以有效利率確定的財務擔保合同之預期信貸損失，本集團將採用貼現率，該貼現率反映當前市場估計貨幣之時間價值及特定於現金流量之風險，但僅限於調整貼現率以反映考慮風險的程度，而非調整貼現的現金短缺。

倘預期信貸損失按集體基準計量，則金融工具按以下基準歸類：

- 逾期狀況；

管理層定期檢討歸類，以確保各組別成分繼續擁有類似信貸風險特性。

(v) Measurement and recognition of ECL

The measurement of ECL is a function of the probability of default, loss given default (i.e. the magnitude of the loss if there is a default) and the exposure at default. The assessment of the probability of default and loss given default is based on historical data adjusted by forward-looking information. Estimation of ECL reflects an unbiased and probability-weighted amount that is determined with the respective risks of default occurring as the weights.

Generally, the ECL is the difference between all contractual cash flows that are due to the Group in accordance with the contract and the cash flows that the Group expects to receive, discounted at the effective interest rate determined at initial recognition.

For a financial guarantee contract, the Group is required to make payments only in the event of a default by the debtor in accordance with the terms of the instrument that is guaranteed. Accordingly, the expected losses is the present value of the expected payments to reimburse the holder for a credit loss that it incurs less any amounts that the Group expects to receive from the holder, the debtor or any other party.

For ECL on financial guarantee contracts for which the effective interest rate cannot be determined, the Group will apply a discount rate that reflects the current market assessment of the time value of money and the risks that are specific to the cash flows but only if, and to the extent that, the risks are taken into account by adjusting the discount rate instead of adjusting the cash shortfalls being discounted.

Where ECL is measured on a collective basis, the financial instruments are grouped on the following basis:

- Past-due status;
- Nature, size and industry of debtors; and
- External credit ratings where available.

The grouping is regularly reviewed by management to ensure the constituents of each group continue to share similar credit risk characteristics.

Interest income is calculated based on the gross carrying amount of the financial asset unless the financial asset is credit-impaired, in which case interest income is calculated based on amortised cost of the financial assets.

Derecognition of financial assets

The Group derecognises a financial asset only when the contractual rights to the cash flows from the asset expire, or when it transfers the financial asset and substantially all the risks and rewards of ownership of the asset to another entity.

On derecognition of a financial asset measured at amortised cost, the difference between the asset's carrying amount and the sum of the consideration received and receivable is recognised in profit or loss.

On derecognition of an investment in equity instrument which the Group has elected on initial recognition to measure at FVTOCI, the cumulative gain or loss previously accumulated in the investment revaluation reserve is not reclassified to profit or loss, but is transferred to retained profits.

Financial liabilities and equity

Classification as debt or equity

Debt and equity instruments are classified as either financial liabilities or as equity in accordance with the substance of the contractual arrangements and the definitions of a financial liability and an equity instrument.

Equity instruments

An equity instrument is any contract that evidences a residual interest in the assets of an equity after deducting all of its liabilities. Equity instruments issued by the Company are recognised at the proceeds received, net of direct issue costs.

Perpetual instruments, which include no contractual obligation for the Group to deliver cash or other financial assets or the Group has the sole discretion to defer payment of distribution and redemption of principal amount indefinitely are classified as equity instruments.

Repurchase of the Company's own equity instruments is recognised and deducted directly in equity. No gain or loss is recognised in profit or loss on the purchase, sale, issue or cancellation of the Company's own equity instruments.

Financial liabilities at amortised cost

Financial liabilities including creditors, bank loans, import and other loans are subsequently measured at amortised cost, using the effective interest method.

剔除確認金融負債

當及只當金融負債獲解除、取消或已屆滿時，本集團將其剔除。剔除確認之金融負債賬面值與已付及應付代價之差額，將於損益中確認。

衍生金融工具

衍生工具在簽訂合約時會以公平值初次確認，之後在每個報告期末按公平值重新計量。由此產生的損益會計入當期損益。

Financial guarantee contracts

A financial guarantee contract is a contract that requires the issuer to make specified payments to reimburse the holder for a loss it incurs because a specified debtor fails to make payment when due in accordance with the terms of a debt instrument. Financial guarantee contracts are measured initially at their fair values. It is subsequently measured at the higher of:

- the amount of the loss allowance determined in accordance with HKFRS 9; and
- the amount initially recognised less, where appropriate, cumulative amortisation recognised over the guarantee period.

Derecognition of financial liabilities

The Group derecognises financial liabilities when, and only when, the Group's obligations are discharged, cancelled or have expired. The difference between the carrying amount of the financial liability derecognised and the consideration paid and payable is recognised in profit or loss.

Derivative financial instruments

Derivatives are initially recognised at fair value at the date when derivative contracts are entered into and are subsequently remeasured to their fair value at the end of the reporting period. The resulting gain or loss is recognised in profit or loss.

A derivative is presented as a non-current asset or a non-current liability if the remaining maturity of the instrument is more than 12 months and it is not due.

Bank balances, deposits and cash

Bank balances, deposits and cash presented on the consolidated statement of financial position include:

- (a) cash, which comprises of cash on hand and demand deposits, excluding bank balances that are subject to regulatory restrictions that result in such balances no longer meeting the definition of cash; and
- (b) cash equivalents, which comprises of short-term (generally with original maturity of three months or less), highly liquid investments that are readily convertible to a known amount of cash and which are subject to an insignificant risk of changes in value. Cash equivalents are held for the purpose of meeting short-term cash commitments rather than for investment or other purposes.

存貨

存貨乃根據成本和可變現淨值二者中之較低值入賬。存貨成本以先入先出法計算。可變現淨值乃按存貨之估計售價減所有估計完成成本及在市場上銷售所需成本計算。進行銷售所需的成本包括直接歸於銷售的增量成本和團體必須承擔才能進行銷售的非增量成本。

稅項

所得稅支出指即期應付稅項及遞延稅項總和。

即期應付稅項按年內應課稅溢利計算。由於應課稅溢利就其他年度的應課稅或可扣稅收入及開支項目及毋須課稅和不可扣稅之項目之處理上之分別，故與稅前溢利不同。本集團即期稅項負債按於報告期結算日已頒佈或實際上已頒佈稅率計算。

遞延稅項是根據綜合財務報表中資產和負債帳面金額與計算應納稅利潤時使用的相應稅基之間的暫時性差異確認的。遞延稅項負債一般針對所有應納稅暫時性差異確認。遞延稅項資產一般針對所有可抵扣的暫時性差異，只要有可能獲得應稅利潤來抵扣這些可抵扣的暫時性差異即可。如果暫時性差異是在交易中對資產和負債進行初始確認(企業合併除外)時產生，而該交易既不影響應納稅利潤，也不影響會計利潤，並且在交易時不產生同等的應納稅和可抵扣暫時性差異，則不確認此類遞延稅款資產和負債。此外，如果暫時性差異是由商譽的初始確認引起的，則不確認遞延稅項負債。

For the purposes of the consolidated statement of cash flows, cash and cash equivalents consist of bank balances, deposits and cash as defined above.

Inventories

Inventories are stated at the lower of cost and net realisable value. Costs of inventories are determined on a first-in, first-out method. Net realisable value represents the estimated selling price for inventories less all estimated costs of completion and costs necessary to make the sale. Costs necessary to make the sale include incremental costs directly attributable to the sale and non-incremental costs which the Group must incur to make the sale.

Taxation

Income tax expense represents the sum of the current and deferred income tax expense.

The tax currently payable is based on taxable profit for the year. Taxable profit differs from profit before taxation because of income or expense that are taxable or deductible in other years and items that are never taxable and deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the consolidated financial statements and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are generally recognised for all deductible temporary differences to the extent that it is probable that taxable profits will be available against which those deductible temporary differences can be utilised. Such deferred tax assets and liabilities are not recognised if the temporary difference arises from the initial recognition (other than in a business combination) of assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit and at the time of the transaction does not give rise to equal taxable and deductible temporary differences. In addition, deferred tax liabilities are not recognised if the temporary difference arises from the initial recognition of goodwill.

遞延稅項負債乃就附屬公司及聯營公司之投資有關之應課稅臨時差額而確認，惟若本集團可控制臨時差額之逆轉，以及暫時差額可能不會於可見將來逆轉者除外。與該等投資及權益相關的扣減暫時差額所產生的遞延稅項資產，僅在按可能出現可利用暫時差額扣稅之足夠應課稅溢利時，並預期於可見將來撥回時確認。

遞延稅項資產之賬面值於每個報告期結算日審閱，於不再有足夠應課稅溢利可供恢復全部或部分資產時減少。

遞延稅項資產及負債乃按預期於償還負債或變現資產期間適用之稅率及基於於報告期間結算日已頒佈或實際頒佈之稅率(及稅法)計算。

遞延稅項負債及資產之計量反映本集團預期於報告期間結算日收回其資產或償還其負債之賬面值後將出現的稅務後果。

就計量使用公平值模式計量的投資物業的遞延稅項而言，除非假定被駁回，否則該等物業的賬面值將假定完全透過出售收回。當投資物業可折舊，且在業務模式中持有，其目標是隨時間消耗投資物業所包含的絕大部分經濟利益，而不是通過出售，則該假定會被駁回，但永久業權土地除外，因為永久業權土地總是假定為完全通過出售收回。

就本集團確認使用權資產及相關租賃負債之租賃交易計量遞延稅項而言，本集團首先釐定稅項扣減是否源自使用權資產或租賃負債。

就稅項扣減乃源自租賃負債之租賃交易而言，本集團將香港會計準則第12號規定分別應用於使用權資產及租賃負債。由於應用初步確認豁免，故有關使用權資產及租賃負債之暫時差額並未於初步確認時確認。自重新計量租賃負債和租賃修改而形成的使用權資產和租賃負債賬面值之後續修訂所產生的暫時差額，並不適用初始確認豁免，及於重新計量日或修改日確認。

Deferred tax liabilities are recognised for taxable temporary differences associated with investments in subsidiaries and associates, except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future. Deferred tax assets arising from deductible temporary differences associated with such investments and interests are only recognised to the extent that it is probable that there will be sufficient taxable profits against which to utilise the benefits of the temporary differences and they are expected to reverse in the foreseeable future.

The carrying amount of deferred taxation assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply in the period in which the liability is settled or the asset is realised, based on tax rate (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

The measurement of deferred tax liabilities and assets reflects the tax consequences that would follow from the manner in which the Group expects, at the end of the reporting period, to recover or settle the carrying amount of its assets and liabilities.

For the purposes of measuring deferred tax for investment properties that are measured using the fair value model, the carrying amounts of such properties are presumed to be recovered entirely through sale, unless the presumption is rebutted. The presumption is rebutted when the investment property is depreciable and is held within a business model whose objective is to consume substantially all of the economic benefits embodied in the investment property over time, rather than through sale, except for freehold land, which is always presumed to be recovered entirely through sale.

For the purposes of measuring deferred tax for leasing transactions in which the Group recognises the right-of-use assets and the related liabilities, the Group first determines whether the tax deductions are attributable to the right-of-use assets or the lease liabilities.

For leasing transactions in which the tax deductions are attributable to the lease liabilities, the Group applies HKAS 12 requirements to right-of-use assets and lease liabilities separately. Temporary differences on initial recognition of the relevant right-of-use assets and lease liabilities are not recognised due to application of the initial recognition exemption. Temporary differences arising from subsequent revision to the carrying amounts of right-of-use assets and lease liabilities, resulting from remeasurement of lease liabilities and lease modifications, that are not subject to initial recognition exemption are recognised on the date of remeasurement or modification.

編製集團旗下個別公司之財務報表時，以該公司之功能貨幣以外貨幣(外幣)進行之交易，按交易日期之適用匯率確認。於報告期結算日，以外幣列值之貨幣項目按當日之適用匯率重新換算。按公平值以外幣列值之非貨幣項目乃按於公平值釐定當日之適用匯率重新換算。按歷史成本計量之以外幣列值非貨幣項目不予重新換算。

就綜合財務報表之呈列方式而言，本集團海外業務之資產與負債以於報告期結算日適用之匯率換算為本公司之呈列貨幣(即港元)。收入及開支則按該年度之平均匯率換算，惟匯率於該期間大幅波動則除外，於此情況下，則按各交易日期適用之匯率換算。產生之匯兌差額(如有)確認為其他全面收益及累計於權益中之換算儲備(如適用則歸屬於非控股權益)。

Taxation (continued)

Deferred tax assets and liabilities are offset when there is a legally enforceable right to set off current tax assets against current tax liabilities and when they relate to income taxes levied to the same taxable entity by the same taxation authority.

Current and deferred tax are recognised in profit or loss, except when they relate to items that are recognised in OCI or directly in equity, in which case, the current and deferred tax are also recognised in OCI or directly in equity respectively.

In assessing any uncertainty over income tax treatments, the Group considers whether it is probable that the relevant tax authority will accept the uncertain tax treatment used, or proposed to be use by individual group entities in their income tax filings. If it is probable, the current and deferred taxes are determined consistently with the tax treatment in the income tax filings. If it is not probable that the relevant taxation authority will accept an uncertain tax treatment, the effect of each uncertainty is reflected by using either the most likely amount or the expected value.

Foreign currencies

In preparing the financial statements of each individual group entity, transactions in currencies other than the functional currency of that entity (foreign currencies) are recognised at the rates of exchanges prevailing on the dates of the transactions. At the end of the reporting period, monetary items denominated in foreign currencies are retranslated at the rates prevailing at that date. Non-monetary items carried at fair value that are denominated in foreign currencies are retranslated at the rates prevailing at the date when the fair value was determined. Non-monetary items that are measured in terms of historical cost in a foreign currency are not retranslated.

Exchange differences arising on the settlement of monetary items, and on the retranslation of monetary items, are recognised in profit or loss in the period in which they arise.

For the purposes of presenting the consolidated financial statements, the assets and liabilities of the Group's operations are translated into the presentation currency of the Group (i.e. HK\$) using exchange rate prevailing at the end of the reporting period. Income and expenses items are translated at the average exchange rates for the period, unless exchange rates fluctuate significantly during the period, in which case, the exchange rates prevailing at the dates of transactions are used. Exchange differences arising, if any, are recognised in OCI and accumulated in equity under the heading of translation reserve (attributable to non-controlling interests as appropriate).

在出售海外業務(即出售本集團在海外業務的全部權益，或出售一間包括海外業務的附屬公司而失去控制權，或出售一間包括海外業務的聯營公司部份權益而保留之權益成為金融資產)，就該業務日常營運積累屬於本公司擁有人權益的所有匯兌差額重新分類至損益中。

借貸成本

On the disposal of a foreign operation (that is, a disposal of the Group's entire interest in a foreign operation, or a disposal involving loss of control over a subsidiary that includes a foreign operation, or a partial disposal of an interest in an associate that includes a foreign operation of which the retained interest becomes a financial asset), all of the exchange differences accumulated in equity in respect of that operation attributable to the owners of the Company are reclassified to profit or loss.

In addition, in relation to a partial disposal of a subsidiary that does not result in the Group losing control over the subsidiary, the proportionate share of accumulated exchange differences are re-attributed to non-controlling interests and are not recognised in profit or loss. For all other partial disposals (i.e. partial disposals of associates that do not result in the Group losing significant influence), the proportionate share of the accumulated exchange differences is reclassified to profit or loss.

Goodwill and fair value adjustments on identifiable assets acquired arising on an acquisition of a foreign operation on or after 1 April 2005 are treated as assets and liabilities of that foreign operation and translated at the rate of exchange prevailing at the end of each reporting period. Exchange differences arising are recognised in OCI.

Borrowing costs

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are added to the cost of those assets until such time as the assets are substantially ready for their intended use or sale.

Any specific borrowing that remain outstanding after the related asset is ready for its intended use or sale is included in the general borrowing pool for calculation of capitalisation rate on general borrowings. Investment income earned on the temporary investment of specific bank and other loans pending their expenditure on qualifying assets is deducted from the borrowing costs eligible for capitalisation.

All other borrowing costs are recognised in profit or loss in the period in which they are incurred.

政府補助

政府補助於有合理保證本集團將遵守補助所附條件及收取補助時方予確認。

與應收收入相關的政府補助作為已經發生的費用或虧損的補償，或者為直接向本集團提供財務支持而沒有任何未來相關成本的款項，於其應收期間的損益確認。與補償費用有關的政府補助自相關費用扣除，其他政府補助則在「其他收入及其他收益」中呈列。

低於市場利率的政府貸款之收益視為政府補助，按已收款項與基於現行市場利率貸款的公平值之差額計量。

退休福利成本及終止服務福利

向界定供款退休福利計劃(包括國家管理的退休福利計劃和強制性公積金計劃)所作之供款，於僱員提供服務後有權獲得供款時確認為支出。

終止服務福利之負債於本集團實體不再能夠撤回終止服務福利要約及於確認任何相關重組費用(以較早者為準)時確認。

短期僱員福利

短期僱員福利是在員工提供服務時預期支付的福利之未貼現金額。除非另有香港財務報告準則要求或允許在資產成本中納入福利，所有短期僱員福利確認為支出。

Government grants

Government grants are not recognised until there is reasonable assurance that the Group will comply with the conditions attaching to them and that the grants will be received.

Government grants related to income that are receivable as compensation for expenses or losses already incurred or for the purpose of giving immediate financial support to the Group with no future related costs are recognised in profit or loss in the period in which they become receivable. Government grants relating to compensation of expenses are deducted from the related expenses, other government grants are presented under “other income and other gains”.

The benefit of a government loan at a below-market rate of interest is treated as a government grant measured as the difference between proceeds received and the fair value of the loan based on prevailing market interest rates.

Retirement benefit costs and termination benefits

Payments to the defined contribution retirement plans, including state-managed retirement benefit scheme and the Mandatory Provident Fund Scheme, are recognised as expense when employees have rendered service entitling them to the contributions.

A liability for a termination benefit is recognised at the earlier of when the Group entity can no longer withdraw the offer of the termination benefit and when it recognises any related restructuring costs.

Short-term employee benefits

Short-term employee benefits are recognised at the undiscounted amount of the benefits expected to be paid as and when employees rendered the services. All short-term employee benefits are recognised as an expense unless another HKFRS requires or permits the inclusion of the benefit in the cost of an asset.

A liability is recognised for benefits accruing to employees (such as wages and salaries, annual leave and sick leave) after deducting any amount already paid.

應用附註3所述的本集團會計政策時，管理層須對未能從其他來源明顯得知的資產及負債賬面值作出判斷、估計及假設。估計及根本假設乃以過往經驗及其他被視為相關的因素為依據。實際結果可能有別於此等估計。

本集團持續檢討該等估計及相關假設。因應會計估計需作出的修訂將在該等估計之修訂期間(倘該等修訂僅影響該期間)或者修訂期間及未來期間(倘該等修訂影響現時及未來期間)予以確認。

應用會計政策時的關鍵判斷

以下為本公司董事在應用本集團會計政策過程中作出的關鍵判斷(除涉及估計外(見下文))，而該等判斷對綜合財務報表內確認的金額有最重要影響。

於俄羅斯從事電池相關產品貿易之一間聯營公司(「該聯營公司」)權益之減值評估

於該聯營公司權益之減值評估涉及關鍵判斷，主要由於持續地緣政治局勢，包括俄羅斯實施之資本控制措施及對俄羅斯施加之制裁。該等因素可能影響該聯營公司的未來財務表現及本集團變現經濟利益的能力。

經考慮外聘律師的意見、該聯營公司於年內的實際財務表現，以及現時地緣政治局勢、資本控制措施及對俄羅斯的制裁對本集團從投資變現經濟利益的能力的影響後，本集團管理層總結認為，於2026年3月31日，其於該聯營公司的權益並無減值跡象。

於2026年3月31日，本集團於該聯營公司權益之賬面值總額為129,140,000港元(2025年：100,703,000港元)。根據管理層的評估，本集團並無就該聯營公司權益確認減值虧損(2025年：無)。上述評估詳情於綜合財務報表附註16披露。

4. CRITICAL ACCOUNTING JUDGEMENTS AND KEY SOURCES OF ESTIMATION UNCERTAINTY

In the application of the Group's accounting policies, which are described in note 3, the management of the Company is required to make judgements, estimates and assumptions about the carrying amounts of assets and liabilities that are not readily apparent from other sources. The estimates and underlying assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an on-going basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

Critical judgements in applying accounting policies

The following are the critical judgements, apart from those involving estimations (see below), that the directors of the Company have made in the process of applying the Group's accounting policies and that have the most significant effect on the amounts recognised in the consolidated financial statements.

Impairment assessment on interest in an associate which is engaged in trading of battery related products in Russia (the "Associate")

The impairment assessment of the interest in the Associate involves critical judgements, primarily due to the ongoing geopolitical situation, including capital control measures implemented by Russia and the sanctions imposed on Russia. These factors may affect the Associate's future financial performance and the Group's ability to realise economic benefits.

After considering the opinion of external lawyers, the Associate's actual financial performance during the year, and the impact of the current geopolitical situation, capital control measures, and sanctions on Russia on the Group's ability to realise economic benefits from the investment, the Group's management concluded that no impairment indicators existed for its interest in the Associate as at 31 March 2026.

As at 31 March 2026, the gross carrying amount of the Group's interest in the Associate was HK\$129,140,000 (2025: HK\$100,703,000). Based on management's assessment, the Group recognised no impairment loss on the interest in the Associate (2025: Nil). Details of the above assessments are disclosed in note 16 to the consolidated financial statements.

估計不明朗因素的主要來源

於報告期結算日，存有重大風險可能須於下一財政年度對資產及負債賬面值作出重大調整的有關未來的主要假設及估計不明朗因素的其他主要來源如下。

應收該聯營公司貨款的信貸風險評估

於本年度，經考慮該聯營公司的實際財務表現及自該聯營公司收取貨款後，應收該聯營公司貨款的信貸風險下降。本集團管理層委任估值師個別評估該等應收貨款的信貸風險。

於2026年3月31日，應收該聯營公司貨款為55,645,000港元(2025年：63,930,000港元)。根據管理層之評估，本集團撥回應收該聯營公司貨款之預期信貸損失撥備1,237,000港元(2025年：1,248,000港元)。上述評估詳情於綜合財務報表附註36披露。

應收貨款的預期信貸減值損失

信用受損之應收貨款及應收該聯營公司貨款的預期信貸損失以個別評估進行。有關應收該聯營公司貨款之預期信貸損失詳情載於上文各段。對於並非個別評估的應收貨款，本集團採用集體基準釐定預期信貸損失。虧損率乃根據具有類似信貸風險特徵之各組債務人之內部信貸評級釐定。集體基準以歷史違約率為基礎，並考慮到合理和可支持的前瞻性資訊，且無需付出過多成本或努力獲得。於各報告日期，會重新評估過往觀察到的歷史違約率及考慮前瞻性資料的變動。

於2026年3月31日，應收貨款之賬面值為1,337,604,000港元(已扣除預期信貸損失撥備44,009,000港元)(2025年：1,024,291,000港元(已扣除預期信貸損失撥備40,313,000港元))。預期信貸損失撥備對估計變動敏感。有關預期信貸損失及本集團應收貨款的資料於附註36及22披露。

Key sources of estimation uncertainty

The following are the key assumptions concerning the future, and other key sources of estimation uncertainty at the end of the reporting period that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year.

ECL assessment on trade receivables from the Associate

During the year, taking into consideration the Associate's actual financial performance and the collection of receivables from the Associate, there was a decrease in credit risk in respect of the trade receivables due from the Associate. The management of the Group appointed the Valuer to assess the ECL on these trade receivables individually.

As at 31 March 2026, the trade receivables due from the Associate were HK\$55,645,000 (2025: HK\$63,930,000). Based on management's assessment, the Group recognised reversal of ECL provision on the trade receivables from the Associate of HK\$1,237,000 (2025: HK\$1,248,000). Details of the above assessments are disclosed in note 36 to the consolidated financial statements.

ECL of trade receivables

Trade receivables with credit-impaired balances and trade receivable from the Associate are assessed for ECL individually. Details on the ECL of trade receivables due from the Associate is set out in the above paragraphs. For trade receivables that are not individually assessed, the Group uses collective basis to determine ECL. The loss rates are determined based on internal credit ratings for each grouping of debtors that have similar credit risk characteristics. The collective basis is based on the Group's historical default rates taking into consideration forward-looking information that is reasonable and supportable, and available without undue costs or effort. At every reporting date, the historical observed default rates are reassessed and changes in the forward-looking information are considered.

As at 31 March 2026, the carrying amount of trade receivables was HK\$1,337,604,000 (net of provision of ECL of HK\$44,009,000) (2025: HK\$1,024,291,000 (net of provision of ECL of HK\$40,313,000)). The provision of ECL is sensitive to changes in estimates. The information about the ECL and the Group's trade receivables are disclosed in notes 36 and 22.

存貨撥備

存貨按成本與可變現淨值兩者中的較低者列賬。本集團管理層定期檢討本集團存貨撥備政策的合適性，並於各報告日期對存貨進行檢討。於各報告日期，管理層透過比較存貨賬面值與其可變現淨值來評估存貨撥備。可變現淨值主要參考估計售價減銷售所需的估計成本釐定。此外，本集團管理層參考存貨賬齡識別滯銷存貨，並根據當前市場需求及未來銷售計劃考慮存貨的可銷售性釐定存貨的可變現淨值。當預期可變現淨值低於成本時，可能會作出進一步撥備。

於2026財政年度，確認存貨撥備為12,909,000港元(2025年：撥回存貨撥備8,213,000港元)。於2026年3月31日，存貨賬面值為1,110,458,000港元(2025年：1,240,961,000港元)。

估計商譽減值

在釐定商譽是否作出減值時，須評估已分配商譽之現金產生單位(或一組現金產生單位)之使用價值。計算使用價值時，本集團須評估預期從現金產生單位(或一組現金產生單位)所得之未來現金流量，並需以合適之貼現率計算現值。倘實際現金流量少於預期之金額，則可能產生重大減值虧損。於2026年3月31日，商譽賬面值為109,054,000港元(2025年：70,399,000港元)。於2026財政年度，本集團並無確認商譽減值(2025年：無)。有關可收回金額之計算詳情載於附註20。

Allowances for inventories

Inventory is stated at lower of cost and net realisable value. The management of the Group reviews regularly the suitability of the Group's allowance policy for inventories and carries out review of the inventories at the end of each reporting period. At the end of each reporting period, management carries out the assessment of determining allowance for inventories by comparing the carrying amounts of inventories with their net realisable values. The net realisable values are primarily determined with reference to estimated selling prices, less the estimated cost necessary to make the sale. In addition, the management of the Group identifies slow-moving inventories with reference to aging analysis and determines the net realisable value for inventories by considering the saleability of inventories based on current market demand and future sales plan. When the expectation of the net realisable value is less than the cost, further allowance may arise.

Allowance for inventories of HK\$12,909,000 (2025: Reversal of allowance for inventories HK\$8,213,000) was recognised for the year ended 31 March 2026 ("FY2026"). As at 31 March 2026, the carrying amount of inventories was HK\$1,110,458,000 (2025: HK\$1,240,961,000).

Estimated impairment of goodwill

Determining whether goodwill is impaired requires an estimation of the value in use of the CGU (or group of CGUs) to which goodwill has been allocated. The value in use calculation requires the Group to estimate the future cash flows expected to arise from the CGU (or a group of CGUs) and a suitable discount rate in order to calculate the present value. Where the actual future cash flows are less than expected, a material impairment loss may arise. As at 31 March 2026, the carrying amount of goodwill was HK\$109,054,000 (2025: HK\$70,399,000). For FY2026, no impairment loss on goodwill was recognised (2025: Nil). Details of the recoverable amount calculation are disclosed in note 20.

投資物業公平值計量

投資物業根據獨立專業估值師進行的估值按公平值列賬。公平值的釐定涉及若干市況假設，詳情載於附註13。

在依賴估值報告時，本公司董事作出判斷，並信納估值方法能反映當前市況。該等假設之變動，包括因宏觀經濟環境轉變、國際貿易緊張局勢地緣政治之複雜性增加、政策方向及／或按揭規定變動或其他突發事件之潛在風險，將導致本集團投資物業之公平值變動，及對綜合損益表及其他全面收益表中列報的收益或虧損及重估盈餘作相應調整。

於2026年3月31日，本集團投資物業之賬面值為453,620,000港元(2025年：418,246,000港元)。

公平值計量

就財務申報而言，本集團若干資產按公平值計量。董事已委派特定工作小組釐定公平值計量的適當估值技術及輸入數據。

本集團採用的估值技術包括並非基於可觀察市場數據的輸入數據，以估算投資物業、以公平值計入其他全面收益之股本工具、以公平值計入損益之金融資產及若干類別金融工具的公平值(詳情分別載於附註13、17、24和36)。

Fair value measurement of investment properties

Investment properties are stated at fair value based on the valuation performed by independent professional valuers. The determination of the fair value involves certain assumptions of market conditions which are set out in note 13.

In relying on the valuation report, the directors of the Company have exercised their judgement and are satisfied that the method of valuation is reflective of the current market conditions. Changes to these assumptions, including the potential risk of any unexpected incidents as a result of change in macroeconomic environment, increased complexity in international trade tensions geopolitics, changes in policy direction and/or mortgage requirements, or other unexpected incidents would result in changes in the fair values of the Group's investment properties and the corresponding adjustments to the amount of gain or loss and revaluation surplus which reported in the consolidated statement of profit or loss and other comprehensive income.

As at 31 March 2026, the carrying amount of the Group's investment properties is HK\$453,620,000 (2025: HK\$418,246,000).

Fair value measurements

Some of the Group's assets are measured at fair value for financial reporting purposes. The directors have a designated team to determine the appropriate valuation techniques and inputs for fair value measurements.

The Group uses valuation techniques that include inputs that are not based on observable market data to estimate the fair values of investment properties, equity instruments at FVTOCI, financial assets at FVTPL and certain types of financial instruments of which details are set out in notes 13, 17, 24 and 36 respectively.

所得稅

本集團需要繳納多個司法管轄區的所得稅。釐定本集團全部所得稅撥備時涉及判斷。有若干交易及計算於日常業務過程中有關最終稅項之釐定是不能確定的。本集團根據額外稅項是否將會到期以確認預期稅項的負債。倘上述事項的最終稅務結果與初步確認的金額不同，此等差額於差額確定之期間內，將影響所得稅及遞延稅項的撥備。

5. 分類資料／營業額

就資源分配及業績評估而言，執行董事(即「本集團主要營運決策者」)衡量分部損益時，使用營運溢利的計量乃不包括利息收入、其他支出及其他虧損、財務成本及不能分類之費用。

本集團個就財務報告目的各自形成一個經營及報告分部的四個主要經營分部為：

電子及音響 – 研發、生產及分銷專業音響產品、KEF品牌音響系統、Celestion品牌揚聲器和相關電子及音響產品。

電池 – 研發、生產及分銷一次性電池、GP品牌電池及電池相關配件。

充電電池 – 研發、生產及分銷能源儲存電池解決方案及充電電池(不包括GP品牌充電電池)。

其他工業投資 – 包括投資控股公司、本集團的聯營公司，即美隆工業股份有限公司(「美隆」)及主要從事電子產品所用高精度零件製造的聯營公司，以及不活動公司。

Income taxes

The Group is subject to income taxes in various jurisdictions. Judgement is involved in determining the group-wide provision for income taxes. There are certain transactions and computations for which the ultimate tax determination is uncertain during the ordinary course of business. The Group recognises liabilities for expected tax issues based on estimates of whether additional taxes will be due. Where the final tax outcome of these matters is different from the amounts that were initially recognised, such differences will impact the income tax and deferred tax provisions in the period in which such determination is made.

5. SEGMENT INFORMATION/REVENUE

For the purposes of resources allocation and performance assessment, the executive directors, who are the chief operating decision makers (“CODM”), assess profit or loss of these operating divisions using a measure of operating profit which exclude: interest income, other expenses and other losses, finance costs and unallocated expenses.

The four main operating divisions of the Group, each of which constitutes an operating and reportable segment for financial reporting purpose, are:

Electronics and Acoustics – design, manufacture and selling of professional audio products, KEF branded audio systems, Celestion branded loudspeakers and related electronics and acoustics products.

Battery – development, manufacture and marketing of primary batteries, GP branded batteries and batteries related accessories.

Rechargeable battery – development, manufacture and marketing of energy storage battery solutions and rechargeable batteries, excluding GP branded rechargeable batteries.

Hong Kong Profits Tax is calculated at 16.5% on the estimated assessable profit for both years.

Income tax on profits assessable outside Hong Kong mainly arose from PRC Enterprise Income Tax (the “EIT Law”) calculated at a rate of 25%.

Certain of the Group's subsidiaries operating in the PRC are eligible as High and New Technology Enterprise and are entitled to preferential income tax rate of 15%. Enterprise Income Tax of the PRC of those subsidiaries has been provided for after taking these tax incentives into account.

33. SIMPLE AGREEMENTS FOR FUTURE EQUITY

In January 2023, KEF GP Group Limited ("KGG"), a wholly-owned subsidiary of the Company, issued simple agreements for future equity ("SAFE") for an aggregate amount of US\$13,700,000 (equivalent to approximately HK\$107,544,000). The SAFE will automatically convert into preferred shares of KGG at a conversion price of US\$1,000 per share if there is issuance of shares of KGG for raising capital. The SAFE will terminate following (i) the issuance of shares of KGG for raising capital; or (ii) repayment to SAFE investors pursuant to change of control of KGG or dissolution of KGG. The SAFE is not mandatorily redeemable and has no interest rate or maturity date. As SAFE do not contain any contractual obligation to pay cash or other financial assets, they are classified as equity and regarded as part of non-controlling interests in the Group's consolidated statement of financial position.

34. PERPETUAL BONDS

On 30 September 2024, GP Industries, a subsidiary of the Company, entered into subscription agreements with certain investors for the issue of fixed rate resetting perpetual subordinated bonds up to an aggregate principal amount of US\$11 million (equivalent to HK\$85,423,000) (the “perpetual bonds”). Incremental costs directly attributable to the issuance of perpetual bonds incurred amounting to HK\$464,000 were recognised in equity, deducted against the principal amount.

In accordance with the terms and conditions of the subscription agreements, inter alia, (i) the distribution rate on the perpetual bonds is at 9.5% per annum and 8.5% per annum for the first and second year respectively and will reset annually thereafter; (ii) the distribution will be payable semi-annually in arrear, unless deferred at the discretion of the Company and will be cumulative; and (iii) the perpetual bonds have no fixed redemption date and are redeemable in whole at GP Industries' option on the third anniversary of the issue date of the perpetual bonds or any anniversary of the issue date thereafter, at their principal amount, together with any accrued, unpaid or deferred distributions.

As a result, the Company is considered to have no contractual obligations to repay its principal or to pay any distributions and the perpetual bonds do not meet the definition for classification as a financial liability. The whole instrument is presented within equity, and distributions are treated as dividends.

The investors of the perpetual bonds include certain Directors, a member of Senior Management and a wholly owned subsidiary of Meiloon, in addition to third party investors. The Directors and the member of Senior Management have subscribed for an aggregate principal amount of US\$4.0 million (equivalent to HK\$31,062,000). The wholly owned subsidiary of Meiloon has subscribed for the principal amount of US\$1.0 million (equivalent to HK\$7,766,000).

During FY2026, distributions amounting to US\$997,000 (equivalent to HK\$7,752,000) (2025: US\$459,000 (equivalent to HK\$3,579,000)) were recognised and US\$1,045,000 (equivalent to HK\$8,283,000) (2025: nil) has been paid to perpetual bond holders. Distributions paid to the Directors, the member of Senior Management and the wholly owned subsidiary of Meiloon were US\$332,500 (equivalent to HK\$2,595,000) (2025: nil), US\$47,500 (equivalent to HK\$371,000) (2025: nil) and US\$95,000 (equivalent to HK\$741,000) (2025: nil) respectively.

35. CAPITAL RISK MANAGEMENT

The Company manages its capital to ensure that the entities in the Group will be able to continue as a going concern while maximising the return to owners through the optimisation of the debt and equity balance. The Group's overall strategy remains unchanged from prior years.

The capital structure of the Group consists of net debt, which includes bank loans, import and other loans and bank and other loans disclosed in notes 29 and 30 respectively, net of cash and cash equivalents and equity attributable to owners of the Company, comprising issued share capital, retained profits and other reserves as disclosed in the consolidated statement of changes in equity.

The directors of the Company review the capital structure on a regular basis. As part of this review, the directors consider the cost of capital and the risks associated with each class of capital. In the opinion of the directors of the Company, the Group will balance its overall capital structure through the payment of dividends, new share issues and share buy-backs as well as the issue of new debt or the redemption of existing debt.

The Group's cash flow interest rate risk is mainly concentrated on the fluctuation of Hong Kong Interbank Offered Rate or Prime Rate arising from the Group's bank borrowings. The management considers the Group's exposure of the short-term bank balances to interest rate risk is not significant as interest bearing bank balances are within short maturity period.

The sensitivity analysis below has been determined based on the exposure to interest rates for bank loans, import and other loans, and bank and other loans. The analysis is prepared assuming financial instruments outstanding at the end of the reporting period were outstanding for the whole year. A 50 basis points (2025: 50 basis points) increase or decrease is used when reporting interest rate risk internally to key management personnel and represents management's assessment of the reasonably possible change in interest rates.

Sensitivity analysis

If the interest rate on bank loans, import and other loans and bank and other loans had been 50 basis points (2025: 50 basis points) higher/lower and all other variables were held constant, the Group's profit before taxation would decrease/increase by approximately HK\$18,222,000 (2025: decrease/increase by HK\$16,613,000).

Other price risk

The Group is mainly exposed to equity price risk through its investments in listed equity securities and unlisted equity securities. The Group has a team to monitor the price risk and will consider hedging the risk exposure should the need arise.

The sensitivity analysis below has been determined based on the exposure to equity price risk at the end of the reporting period.

If the price of the listed equity investments and structured deposits at FVTPL had been 5% (2025: 5%) higher/lower, the Group's profit before taxation would increase/decrease by HK\$6,412,000 (2025: HK\$761,000).

As at 31 March 2026 and 31 March 2025, the Group does not hold any collateral or other credit enhancements to cover its credit risks associated with its financial assets.

Trade receivables arising from contracts with customer

In order to minimise the credit risk, the directors of the Company have delegated the management to be responsible for determination of credit limits, credit approvals and other monitoring procedures to ensure that follow-up action is taken to recover overdue debts. Before accepting any new customer, the Group uses an internal credit rating system to assess the potential customer's credit quality and defines credit limits by customer. Limits and rating attributed to customers are reviewed twice a year. Other monitoring procedures are in place to ensure that follow-up action is taken to recover overdue debts. In this regard, the directors of the Company consider that the Group's credit risk is significantly reduced. In addition, the Group performs impairment assessment under ECL model upon application of HKFRS 9 on trade balances individually or based on a collective basis.

The Group does not have any significant concentration of credit risk over trade receivables. Trade receivables consist of a large number of customers and spread across diverse industries.

As part of the Group's credit risk management, the Group applies internal credit rating for its customers. The following table provides information about the exposure to credit risk for trade receivables which are assessed based on a collective basis within lifetime ECL (not credit-impaired). Credit-impaired debtors with gross carrying amount of trade debt of HK\$29,700,000 (2025: HK\$28,073,000) and the trade receivables due from the Associate of HK\$55,645,000 (2025: HK\$63,930,000) as at 31 March 2026 were assessed individually. As the Group's historical credit loss experience does not show significantly different loss patterns for different customer segments, the provision for loss allowance based on past due status is not further distinguished between the Group's different customer base.

其他應收款項、按金及應收股息

在釐定賬面值總額為92,858,000港元(2025年：107,045,000港元)的其他應收款項、租賃按金及應收股息的預期信貸損失時，管理層已根據過往還款記錄、過往經驗及前瞻性資料(如適用)就該等結餘的可收回性作出定期個別評估。管理層經考慮相關交易對手的歷史違約率持續偏低，認為該等結餘的固有信貸風險不重大。

應收聯營公司款項

於2026年及2025年3月31日，就減值評估，應收聯營公司欠款被評為低信貸風險，因自最初確認後違約風險並無顯著增加。因此，就該資產之減值評估，損失撥備以12個月預期信貸風險計算。

Bills receivables

In determining the ECL for bills receivables amounting to HK\$34,394,000 (2025: HK\$29,320,000), the management has considered the bills received by the Group are with a maturity period of less than one year and have been individually assessed based on external rating of relevant banks, and concluded that for FY2026 and FY2025, the credit inherent in the Group's outstanding bills receivables is insignificant.

Loan to non-controlling interests

As at 31 March 2026 and 2025, the management has individually assessed the ECL of the loan to non-controlling interests of HK\$44,132,000 (2025: HK\$43,799,000). Management considered that due to the past due events of the loan to non-controlling interests, there is significant increase in credit risk in the loan to non-controlling interests. The management estimates the estimated loss rates of loan receivables based on historical credit loss experience of the debtors as well as the fair value of the collateral pledged by non-controlling interests to the loan receivables. Based on assessment by the management, a full ECL provision of HK\$44,132,000 (2025: HK\$43,799,000) was made on the loan to non-controlling interests.

Other receivables, rental deposits and dividend receivable

In determining the ECL for other receivables, rental deposits and dividend receivable with gross carrying amount of HK\$92,858,000 (2025: HK\$107,045,000), the management has made periodic individual assessment on the recoverability of these balances, based on historical settlement records, past experience, and also forward-looking information, as appropriate. The management has considered the consistently low historical default rate in connection with relevant counterparties, and concluded the credit risk inherent in these balances is insignificant.

Amounts due from associates

As at 31 March 2026 and 2025, for purpose of impairment assessment, the amounts due from associates are considered to have low credit risk as there has been no significant increase in the risk of default on the receivables since initial recognition. Accordingly, for the purpose of impairment assessment for the asset, the loss allowance is measured at an amount equal to 12m ECL.

流動資金風險

本集團透過結合銀行及其他貸款及股本作為日常營運之融資，並維持足夠備用信貸以確保在需要時提供必須之流動資金。管理層定期密切監察本集團之資金流動性以確保具足夠流動資金應付所有到期責任。參照公司於2026年3月31日現有的未使用貸款額約為2,922,000,000港元(2025年：2,390,000,000港元)和截至綜合財務報表獲准印發日期獲得的新貸款額，及經考慮未來可能發生之出售投資和再融資安排後，本公司董事認為流動資金及資本來源充足。

Bank deposits and bank balances

The credit risk for bank deposits and bank balances exposed is considered minimal as such amounts are placed with various banks with good credit ratings and there is no significant concentration of credit risk.

Financial guarantee contracts

For financial guarantee contracts, the gross carrying amount represents the maximum amount the Group has guaranteed under the respective contracts.

The Group is also exposed to the credit risk in respect of guarantees given to banks relating to banking facilities utilised by associates. The management periodically reviews financial position of the associates and considers that the associates have strong financial position and the Group has adequate monitoring procedures to reduce the credit risk.

Liquidity risk

The Group finances its operations by using a combination of bank and other loans and equity. Adequate lines of credit are maintained to ensure necessary liquidity is available when required. The management monitors the liquidity position of the Group on a periodical basis to ensure the availability of sufficient liquid funds to meet all obligations. With reference to the existing unutilised facilities of approximately HK\$2,922 million as at 31 March 2026 (2025: HK\$2,390 million) and newly obtained facilities up to the date when the consolidated financial statements are authorised for issue and after taking into account of any possible disposal of investments and re-financing arrangements, the directors of the Company consider the source of liquidity and capital for the daily operation are sufficient.

37. 退休福利計劃

本集團根據香港強制性公積金法例設立了一項強積金計劃。根據強積金計劃，僱主和僱員均須作出供款，強制性供款為有關僱員入息之5%，計算強積金計劃供款之有關僱員每月入息上限為30,000港元，由2014年6月開始生效。此外，僱主及僱員可自行決定自願供款。

就強積金計劃而言，僱主作出的所有強制性供款均全數歸屬於僱員，而自願供款產生的任何未歸屬於僱員的福利將被沒收並歸還給僱主。

本集團同時參與本集團於中國各地營運之有關市政府之僱員養老保險計劃。本集團每月就每月員工薪酬之若干百分比作出供款，而有關市政府承擔本集團現時及將來退休員工之退休福利責任。除上述供款外，本集團並無就員工之養老金供款及退休後福利存在任何責任。

此外，本公司部份於香港及中國以外之海外附屬公司參與由當地有關機構成立之中央公積金計劃，該等計劃為介定供款計劃。

於2026財政年度，本集團支付約64,019,000港元(2025年：59,245,000港元)之退休福利供款。

37. RETIREMENT BENEFIT SCHEMES

The Group participated in a MPF scheme registered under the Hong Kong Mandatory Provident Fund Schemes Ordinance. Under the MPF scheme, both the employer and its employees are required to make contributions to the scheme at 5% of the employees' relevant income, subject to a cap of monthly relevant income of HK\$30,000 effective from June 2014 for the MPF scheme. In addition, the employer and its employees may make voluntary contributions at their discretions.

For the MPF scheme, all mandatory contributions made by the employers are fully vested with the employees, while any unvested benefits of employees arising from voluntary contributions would be forfeited and reverted to the employers.

The Group also participates in the employees' pension schemes of the respective municipal government in various places in the PRC where the Group operates. The Group makes monthly contributions calculated as a percentage of the monthly payroll costs and the respective municipal government undertakes to assume the retirement benefit obligations of all existing and future retirees of the Group. The Group has no other obligations for the payment of pension and other post-retirement benefits of employees other than the above contribution payments.
